## Effort to end slavery

By Nelson A. King

A top United Nations official on Mar. 26 called for a "comprehensive approach" through laws, education and international cooperation to end modern-day slavery.

"The terrible impacts of slavery and the slave trade are still felt to this day," said Abdulaziz Al-Nasser, president of the U.N. General Assembly, in remarks commemorating the International Day of Remembrance of the Victims of Slavery and the Transatlantic Slave Trade.

"They have devastated continents and countries. They have led to profound social and economic inequalities and have given rise to hatred, racism and prejudice." he added.

In 2007, the General Assembly designated Mar. 25 as the International Day of Remembrance of the Victims of Slavery and the Transatlantic Slave Trade to honor an estimated 28 million Africans who were violently removed and cast into slavery, mainly in colonies in North America, South America and the Continued on page 4

## Strongman faces justice

A major row has erupted in Dutchspeaking Suriname over a proposal by a small group of parliamentarians to grant an amnesty for war crimes committed during the turbulent 12-year period from the 1980 military coup which, if approved, will wipe away the December 1982 executions of 15 government critics and the near decimation of a southeastern village near French Guiana, among other atrocities.

But while the Mega Combination

coalition group of former military strongman, now the elected president of the republic, Desi Bouterse has an easy working two-thirds majority in the 51-seat assembly, it has made it clear it wants some kind of consensus before any vote on amnesty for the period is approved.

The 'offending' period will cover the February 1980 coup when then Sgt. Desi Delano Bouterse and a group of military officers and subordinates overthrew the elected Henck

### **Barbados**

Barbados is moving to boost its tourism industry with new additions to the list of tax exempt items provided under the Barbados Tourism Development Act.

This is according to Minister of Tourism Richard Sealy who disclosed recently that these amendments were all part of efforts to strengthen the sector.

"This act makes available a wide range of concessions to tourism investors. Tourism is very vibrant and dynamic industry, the act has to be flexible in order to keep up with demands of the industry. Some of items required by the sector that were deemed as luxury items, five or 10 years ago are no longer deemed as such.

"Recognizing fact, and acknowledging the strident lobby from the Barbados Hotel and Tourism Association, my ministry is currently fine tuning a proposal for consideration by Cabinet, which recommends the expansion of the range of items that investors and operators in the sector can access free of duty under the Act," he said.

### Belize

The main opposition People's United Party (PUP) is threatening legal action over the recent general election in Belize that resulted in a narrow victory for Prime Minister Dean Barrow and his ruling United Democratic Party (UDP).

## Raúl Castro receives pope in Cuba

Shortly before Pope Benedict XVI met with Cuban President Raúl Castro for a courtesy visit at the Palace of the Revolution in Havana, Miami's Archbishop Thomas Wenski, who led about 800 pilgrims from Florida, assailed the communist island's Marxist ideologies.

During a mass in Havana at the capital city's oldest cathedral, Wenski invoked Pope John Paul II, who visited Cuba in 1998, calling for more freedoms in the Spanish-speaking Caribbean island.

In reiterating Pope Benedict's earlier criticism of Marxism as being "a spent ideology," Wenski urged Cubans to be the "protagonist of their own future."

### Antigua PM to help recover fraud funds

Antigua and Barbuda's Prime Minister Baldwin Spencer has pledged to work with other agencies to try and help recover money that victims across the globe lost to convicted Texas tycoon Allen Stanford through his bank based on the Caribbean island.

Spencer did not give details of the cooperation when he spoke with reporters after a U.S. Federal Court jury in Texas convicted Stanford of 13 of the 14 charges, including conspiracy, wire and mail fraud.

Prosecutors say the financier used his Stanford International Bank to swindle investors out of more than US\$7 billion, using the money to fund a string of failed businesses.

Spencer said he feels justice was served with the U.S. verdict, but said it doesn't bring real joy because he fears the verdict could provide more fuel to a U.S. victims' coalition that has promoted a boycott of Antigua.

The group has sometimes set up booths at travel shows to urge holidaymakers to avoid the tourism dependent island.

'This is a very unfair campaign," he said.

This country was made out as a country that encouraged and gave sustenance, if you like, to such types of developments, and that clearly was not the case," Spencer said.

Stanford was once the largest private employer in Antigua with 800 workers. He owned a cricket stadium, a restaurant, an airline, a newspaper and a development company.

U.S. prosecutors say they hope to seize about US\$300 million from more than 30 Stanford-controlled companies including Switzerland, Britain and Canada through civil trial, which is being heard by the same jury that convicted the 61-year-old Stanford.

# Taking a stand on trickle-down economics

The Adjusting for Income Disparity Act of 2012, (AID Act) tabled in the U.S. House of Representatives on March 26 by Rep. Yvette D. Clarke (D-Brooklyn) seeks to end the income disparity between the haves and the have-nots.

The so-called AID Act addresses "the scourge of income disparity currently afflicting our nation," Clarke said.

If enacted, the law would provide a tax credit for the middle class, aspiring middle class and working poor as well as ensure that the top 1 percent of income earners pay their fair share in taxes by bringing an end to the Bush era tax cuts.

The Bush-era system of trickle-down economics, does not work, Clarke said, adding: "It's time we give the financial power to the Americans who are the real drivers of our economy. It is simply the right thing to do."

If enacted the AID Act of 2012 would:

- ~ Create a refundable tax credit loosely based on the AMT the average disparity in income between the top 5 percent and bottom 5 percent of income earners;
- ~ Repeal the Bush tax cuts which, according to Citizens for Tax Justice, would cost \$5.4 trillion if extended another decade; bringing their 20 year cost to a staggering \$7.42 trillion;
- ~ Define "income" to include wages, income derived from capital gains, interest on municipal bonds, and benefits derived from federal assistance;
- ~ Create a threshold for tax credit eligibility that encourages Americans to continue to seek employment, and;
- ~ Direct the IRS to adjust the tax credit yearly for inflation.

Income inequality has grown to its greatest point since estimated income inequality in 1929, at the start

of the Great Depression. According to the non-partisan Congressional Budget Office, income for the top 1 percent of households grew by 275 percent between 1979 and 2007. During that same period, income for the middle-class only grew by approximately 40 percent while the bottom 20 percent of income earners only saw their wages increase by 18.3 percent.

According to Moody's Analytics, Clarke said, the top 5 percent of income earners account for 37 percent of consumer outlays, nearly equaling the 39.5 percent of the bottom 80 percent.

"As we slowly progress from the current economic downturn, we must empower those who are having the hardest time getting back on their feet. For too long our economic policies have favored the top 1 percent of income earners.

"When we focus on ensuring that the poor and working poor have the ability to become economicallyviable middle class citizens, then we will know that our economy is headed in the right direction.

"This bill directs this economy to help the majority of Americans, not just a select few," Clarke added.

## Press conference marks milestone for Wall St. protest

Last week, just days after the sixmonth anniversary of its historic protests, and as the Occupy Wall Street (OWS) movement (and the NYPD) gear up for a milestone demonstration on May 1, 74 people were arrested as hundreds converged on Zuccotti Park on Saturday, March 17. Several protestors sustained injuries, as did some police officers.

The March 19 press conference at Zuccotti Park, at which aggressive police tactics was the subject, was not the first showing of solidarity between members of the New York City Council and Occupy Wall Street

City Council members Ydandis Rodriguez and Jumaane Williams, long-time supporters who were arrested during various OWS actions, denounced the police abuse of power at the press conference.

In the democratic tradi-tion, people meet in the public square, Williams said. (This) "is suppression of dissent."

Rodriguez called for a "Protestors Bill of Rights" and for people to

come out to protest on March 24.

Brooklyn councilman Stephen Levine called for Speaker Quinn to hold a hearing on the conduct of law enforcement.

Several OWS supporters, present Saturday night spoke. Bill Livsey showed a large black and blue mark sustained from a police baton. In tears, Liesbeth Rapp, a 27-year-old activ-ist, described one female protestor who had a seizure and was not able to obtain timely treatment, barred by the police. The park was closed Saturday night, following the arrests.

## Senegalese strongman loses a vote

Expatriot Senegalese nationals in Harlem, Brooklyn, the Bronx and cities across the U.S. last weekend participated in the election of a new president in their homeland.

Opposition candidate Macky Sall won a runoff in second round voting after a long emotional campaign, particularly significant because incumbent Abdoulaye Wade changed the constitution to allow himself to run again.

In West Harlem, the halls of Frederick Douglass Academy were abuzz. Voters entered one of the six precincts, showed IDs, picked up a card for each candidate and an envelope, and disappeared behind canvas drop-cloths where they made their choice then deposited the ballots in plexiglass voting boxes.

After dipping a finger in ink and finishing the process, many stayed behind to greet friends and follow election news from back home on the radio, exuding unity as an immigrant community, overshadowing political differences.

Amadou T. Ba, of the Bronx, a construction worker who has lived in New York 20 years explained: "We argue about politics but we share everything else," describing the

camaraderie of the moment.

On the constitutional change that allowed Wade to run again, Ba remarked that Wade supporters argued that "even in America they do it. Why not in Senegal."

When people are talking they mention Mayor Bloomberg's changing of election laws to remain in office, but adding: "I don't like what he did, but I think he is a good

mayor otherwise.'

Supporters of both candidates compared the constitutional change allowing Wade to run again, to changes to the City Charter that allowed him to run a third time.

"For all the setbacks to democracy, the vote seems to be taking care of the issue," said Souleymane Diagne, a philosophy professor at Columbia

Aaron government at the wrong end of a series of disputes between the military and authorities.

The issues had included a quarrel over demands by the military to be represented by a labor union, unheard of in neighboring Caribbean Community member states of which Suriname has since become a member.

Any parliamentary amnesty will also cater for the unprecedented December 1982 executions of 15 government critics at an old Dutch fort on the Surinamese river that is less than 200 yards from the Assembly Building where a vote could be held in the coming weeks if the Mega Combination goes ahead with plans.

But while various civil society groups, individual critics and opposition figures have railed against the possibility of the coup-makers and 1982 protagonists escaping possible jail time under cover of an amnesty, others like former Army Officer Edgar Ritfeld who, like President Bouterse is on trial for the executions, wants "to be freed by the court rather than be let go by an amnesty" because he said he

is innocent of murder charges.

The move to get parliamentary pardons for nearly 25 mostly exsoldiers, has come as the four-year mass murder trial of Bouterse and the rest appears to be nearing an end and as some witnesses have directly fingered Bouterse for being at the scene and even giving orders to execute some of the journalists, clergymen, labor leaders and academics who died on Dec. 7-8, 1982.

Bouterse has always denied giving any such orders but has said that as the then boss, he has to accept "collective responsibility" for those events. If February 1980 and December 1982 are not important enough dates in local history, the country's main advocate lobby, the Moiwana Human Rights Organization of Suriname says that it is "surprised and disappointed" that any assembly forgiveness will include the 1986 slaughter of Moiwana Maroon Village by soldiers chasing anti-government rebels operating from across the river in neighboring French Guiana.

More than 50 elderly men, women and children were killed because of the perception that they were assisting rebels, then led ironically, by now Bouterse ally and Mega Combination legislator Ronnie Brunswijk.

The main opposition New Front Coalition of former President Ronald Venetiaan also says it plans to oppose the amnesty proposal.

"Let it be clear that I am absolutely against the granting of amnesties for serious human rights violations," says New Front spokeswoman and veteran parliamentarian Ruth Wijdenbosch," noting that for "laws are the same between politicians and the man/woman of the streets."

Both the party and Moiwana argue that now that a trial verdict nears an end and after the last set of witnesses definitively fingered Bouterse and other key players now in government for 1982, a play is being made to wipe away all sins that they totally disagree with.

The result is that everyone now awaits the ruling of the court. Tensions were heightened in Paramaribo last week when the court visited the fort to get a better sense of what went on during that morbid period of 24 hours more than 30 years ago.

West Indies.

In his remarks, Al-Nasser emphasized that member states must work tirelessly to eradicate modern slavelike practices that have emerged in the forms of racism, human trafficking, sexual exploitation, child labor, forced marriage, and the forced recruitment of children for use in armed conflict.

The General Assembly president also underlined that existing international instruments on slavery "should be fully utilized to bring about necessary change in attitudes and customs, to punish the offenders, and to support innocent victims in re-gaining their lives and dignity.

"Let us learn from the horrors and sacrifices of the past, and ensure through concrete actions and results that slavery in all its forms is forever eliminated," he said.

Since March 23, the U.N.

has been hosting a series of events to pay tribute to the men and women who bravely fought against the transatlantic trade, as well as those who continue to stand up against modern forms of slavery.

This year's commemoration at U.N. headquarters in New York included an exhibition of images of heroes and activists, original documents, historical illustrated newspapers and artefacts, as well as an evening of cultural and culinary specialties of Africa and a global student videoconference.

In addition, plans are underway to erect a permanent memorial in the U.N. headquarters complex "to remind the world that millions of Africans were violently removed from their homelands, abused and robbed of their dignity over the course of four centuries during the transatlantic slave trade."



University, as early word out of Senegal indicated that Sall was leading.

Diagne was on hand as president of DE CENA, the organization responsible for monitoring the 27 polling places overseas, compiling the votes and sending them to Dakar.

"The election is all the more significant because of what is happening in Mali," [Senegal's neighbor to the east] Dakar said, where there is an ongoing Touareg rebellion crisis that led to a presidential military coup.

Yacine Wade, a dancer and former member of the Senegalese National Ballet spoke of her father's life as an example of the change that was needed in Senegal.

"He worked all his life for the government as security for the president, but after he had a stroke and was sick he received no support."

Ironically Wade, who dances here with the Sankofa Drum and Dance

Ensemble, the Rhythm Monsters and others, supports herself as a home health care nurse.

The crowd swelled by mid-afternoon. Groups of men conversed in the entrance courtyard, a group of women in the colorful traditional dress that the vounger generation refer to as "granman" sat on the steps inside.

Polls in Senegal closed at 2:00 p.m. New York time and before polls closed here at 6:00 p.m. President Wade had conceded defeat.

Final results were not known at press time, but early estimates had Sall winning 82.5 percent of the vote, compared to Wade's 17.5 percent in the Diaspora according to Prof. Diagne.

Amadou Ndiaye, Harlem resident for 20 vears who represents the Socialist Party of Senegal in the U.S.summed up the feeling this way: "If there are two cars, one driver is 90 and the other in his mid-50s, whose car are you going to use?

"The burden of running a country is much heavier than driving a car."

## Fundamental issues for the Belize Football League

For many years now the people who are involved in the sport of football in Belize have been saying that my relative Bertie Chimillio, has been using the football leagues funds for his own personal activities. Now, that he has been removed from the presidency the government of Belize, along with FIFA, are going to investigate all the financial transactions made under his reign as president of the league.

I just hope and pray that they find no evidence of misappropriation of funds; for if they happen to find any evidence, the consequences against him will be very severe.

Many people have been speaking to me about Bertie Chimillio in Belize and the United States not knowing that we are related and the things they have been saying about him are not nice. I would caution that we make no assumptions until all the evidence is presented to the government of Belize and FIFA, because he should be considered innocent until proven guilty.

Many other Belizeans have been dying for years now to get Bertie Chimillio's position; not because they possess the necessary skills, experience and education to improve the quality of football in Belize, but because they want to have access and control over the money that he was controlling.

In the Belize National Interdistrict Football Champions of 1975 and 1976 which was controlled by Belize Amateur Football Association (B.A.F.A.), I was a member of the All Orange Walk selection team that ended up in the finals against Dangriga's Queens Park Rangers that was defeated twice.

In 1975 we were given a gold plated medal, and in 1976 we received a gold-p lated trophy.

This was despite the fact that thousands of dollars were made at M.C.C. Grounds during those years, yet there was no football stadium in the city of Belize. After living in the United States for a few years, I felt that I was used and abused by the people who were controlling football in Belize and I decided to throw both of those trophies in the garbage.

Football is Belize's No.1 sport, yet over the years the quality of football I see Belizeans playing today is worse than when I was growing up watching and playing the sport.

There is no building that I know of, where our young children can go and gather information on our Belizean football heroes, because there is no Belize Football Hall Of Fame that is active in our country.

There was an attempt by my friends Nick Dujon and Ray Davis years ago, but without any cooperation they got frustrated and gave it up.

I am now 57 years old and if I was to be selected, I might not be around to witness it, like many other great players who are dying yearly.

Belize has not qualified yet to reach the World Cup. Getting rid of Bertie Chimillio is one thing, but there are other fundamental football issues that FIFA, the Belize government and the Belize Football League need to address.

## Women's History Month: A Time for Cautious Celebration

March marks Women's History Month, a celebration of women's achievements and a reminder of the work that still must be done to ensure basic security and rights for women. Nowhere is this contrast more significant than in Afghanistan, where a successful transition to a sustainable peace hinges on the inclusion and equality of women.

Afghan women have made gains these past 10 years. There are now 3.2 million Afghan girls enrolled in school since the overthrow of the Taliban in 2001. Afghan women's organizations lobbied diligently for a provision of gender equality in the Constitution and have won the right to vote in elections. Afghanistan has adopted a 25 percent parliamentary quota in the lower house of parliament, one of the highest in the world and, unlike the United States, Afghanistan has signed the United Nations Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW).

But while providing opportunities for women to vote, work and attend schools in Afghanistan is paramount to equality, women can't pursue these opportunities if they aren't safe. Combat activities like night raids and drone strikes are not furthering Afghan women's security. Instead, these activities are fueling military conflict that hinders the development of political solutions.

According to a Washington Post-ABC News poll conducted in March 2011, 63 percent of Americans are opposed to continuing the war in Afghanistan. Washington also has joined the chorus calling for our troops to come home. On Feb. 1, Secretary of Defense Leon Panetta announced that the United States will end its combat missions in Afghanistan by "mid- to the latter part of 2013." In late February, 87 members of Congress sent a letter to President Obama praising this accelerated timetable. There is no question that we are leaving Afghanistan, but what will we leave behind?

As U.S. troops leave Afghanistan and we begin to think beyond war, our engagement with the country must not end. In a recent National Public Radio (NPR) interview, Fawzia Koofi -- who has been a deputy speaker of Afghanistan's parliament and is now being talked about as a potential first woman president in Afghanistan -- said of the United States, "I know in your capitals, in your country and among your public, issues like women's rights, human rights are not the main rea-

son you are in Afghanistan, but this is one of the achievements you have invested blood and treasure for." We should honor this sacrifice and we should invest wisely in economic and social programs that enhance security through demilitarization and promote women's rights through inclusive peace processes. These investments will be far less costly than the decade of war that came before.

In December 2011, President Barack Obama released the first-ever U.S. National Action Plan on Women, Peace and Security, and signed an Executive Order directing the plan to be implemented. Together, the Executive Order and National Action Plan (NAP) chart a roadmap for how the United States will accelerate and institutionalize efforts across the government to advance women's participation in preventing conflict and keeping peace. These documents represent a fundamental change in how the United States will approach its diplomatic, military and development-based support to women in areas of conflict like Afghanistan. It is a step in the right direction, but there is far more work to be done.

The meaningful representation of women in all peace negotiations and post-conflict recovery planning is critical. As a state legislator, I know how important it is for women to be at the table to build coalitions, speak up for unheard voices and decide how resources should be allocated. This is true of peace-building around the world, too. At the 10th anniversary of U.N. Security Council Resolution 1325 on Women, Peace and Security in October of 2010, Secretary of State Hillary Clinton said, "It's not as though we are doing a favor for ourselves and them by including women in the work of peace. This is a necessary global security imperative. Including women in the work of peace advances our national security interests, promotes political stability, economic growth and respect for human rights and fundamental freedoms. ... No peace that sacrifices women's rights is a peace we can afford to support.

Women's History Month gives us reason for cautious celebration. Can we preserve the gains that Afghan women have made? We must support a peacebuilding transition strategy that emphasizes the roles and rights of women.

## The frantic search for an issue

Those gatherings in Washington aimed at influencing the deliberations of the Supreme Court when the justices rule on the challenge to the health care reform law include folks who hope not only for the health care legislation, or perhaps major parts of it, to be ruled unconstitutional, but that it serves as the big 2012 rally point Republicans are desperately in search of. The agitators for repeal of the law know very well that, as things now stand, the GOP/Tea Party alignment is back on its heels, as far as being battle-ready for the November stakes.

What that element dares to dream about is a re-run of all hell breaking loose, as it did in 2009, when the anti-Obama crowd made health care reform a wedge issue that had the kind of galvanizing effect that facilitated the big Congressional turnover in 2010. Election to the House of a slew of right-siders, a number of them proponents of extremist views on the role of government, gave Republicans a taste of blood for the next time around when the spoils of battle would include the presidency.

Fortunately, a scenario in which all of Washington would fall in and dance to that far-right tune is not how it has played out. Rather, what we've had is a graphic illustration of governmental dysfunction, where intransigence on the part of conservative hardliners has seen Congress plummet to public approval numbers so low as to practically defy measurement. Republicans are uniformly seen as the main culprits whenever public attitudes toward this Washington paralysis are sampled. Net effect for the GOP has been that the hoped-for drive to bring government to an embrace of those well-known right wing talking points has run into some bumps in the road. And the signal received most clearly by Americans is of recklessness by an out-of-control bunch who, under the guise of advocating for "the people"

in fact push an agenda that leaves most of "the people" hung out to dry.

Republicans being seen as generally favoring those in the society of higher socio-economic profile is hardly new, but it has become much more stark in the heady expectations following the success of those 2010 House elections. It was a classic case of going for too much of a good thing and believing, to boot, that the rap about having the public's back was a saleable defense even against excessively irresponsible conduct. Legislative decisions or votes constantly going to the down-to-the-wire stage, threats to shut down the government, open defiance of public sentiment (as in popular support for the well-to-do being asked to pay a higher tax rate) all cast a hot-to-trot House majority as being totally out of step with the public they claimed to protect.

Such behavior has only given rise to a highlighting of the now famous 99 percent versus one percent phenomenon – something for which Republicans have hubristically laid the blame on Democrats for what they have labeled "class warfare." That sense of almost permanent Washington gridlock has also led to a souring, among those of even slightly moderate bent in the GOP fold, of attitude about what the party brand has become. Maine's Sen. Olympia Snowe is only the latest of that ilk to give up in disgust, announcing in February that she would not seek reelection in November.

The antics of presumptive GOP nominee Mitt Romney during the current campaign have been a perfect caption for what now frames the party's identity. Romney absolutely could not have won himself the governorship of Massachusetts had he merchandised himself then as the

avid conservative he now purports to be. But his past profile is the Achilles heel that has the right-side party faithful obviously unconvinced about his go-to line of rhetoric. Romney's attempts at pulling off this role have often been so clumsy, it clearly has messed with the GOP's sense of confidence regarding the man who will apparently lead their charge this fall. The combination of an electorate fed up with Capitol Hill tomfoolery and a presidential candidate considered well shy of the genuine article is surely baggage the party would rather not have.

Hence the frantic search for whatever could prompt a revisiting of 2009's anti-Obama uproar. Had there not lately been positive economic recovery news, that frenzy from three years ago would have been an easier reach today. But encouraging economic developments makes less palatable the bellowing of folks who've shown themselves capable of holding the country hostage in pursuit of an agenda that doesn't necessarily sit well with most Americans. Looking to the legal challenge to healthcare reform to provide the "Aha!" moment might not be the sure bet the challengers think it is. For one thing, some provisions of the law which have so far been rolled out could already be making a difference that is more likely to garner public support than engender opposition. Changes in Medicare, for instance, where an emphasis on preventive services includes elimination of fees for services for most beneficiaries is pretty certain to register positively. Ditto, the change which allows young people to be covered in parents' insurance plans through age 26.

Even if the government mandate that everyone have insurance becomes the central issue for the court and is struck down, heathcare reform seemingly has enough going for it to deny the opposition the political wallop they're figuring it will be.

## How the Affordable Care Act helps small business

According to national news reports, Mary Brown, the lead plaintiff in the lawsuit challenging the health reform law and owner of a small auto shop in Florida, has had to close her business and file for bankruptcy due to thousands of dollars in unpaid medical bills.

My husband and I own a small auto shop too, at the other end of the country in Renton, Washington. Our business is alive and kicking – thanks to the Affordable Care Act.

For as long as I can remember, fixing cars in my own small business has been my dream. My dad served 40 years in the military and knew a little about everything. I grew up fixing cars with him, starting when I was little holding a flashlight while he worked. His lessons stuck with me: you always do what you can to help.

My husband and I met while studying to be auto mechanics. For the last 15 years, we've lived our dream – owning our own shop not far from where I grew up.

We're your typical Mom-and-Pop operation – the two of us and one auto technician we employ. I know our customers by name. They all know my dog. We've raised two beautiful children while doing what we love.

When we started our business, buying expensive health insurance seemed completely out of reach. With so many start-up costs, there were many things we did without.

But, getting older I've started worrying more about my health. A few years ago, we decided we needed to get insurance. Obtaining policies for Jay and my employee went smoothly, but I was rejected for a pre-existing condition I've had since birth – a genetic condition called psoriasis.

When I got that rejection letter, the thought that kept going through my head was that we'd have to close our business and find jobs with health insurance. It was a devastating thought. We're living our dream. It's everything I'd ever hoped for.

Then I found out about the Pre-existing Condition Insurance Plan. It's part of health care reform — a plan where people who've been rejected by insurance companies can get coverage until the ban on pre-existing condition denials takes effect.

I signed up. I've since learned that my psoriasis has led to other conditions that need treatment. I'm getting the care I need, and Jay and I are still doing what we love

That's why I'm outraged that Republican attorneys general, including my state's AG, Rob McKenna, are taking a partisan lawsuit that threatens to take my dreams away to the U.S. Supreme Court.

They're joined in this lawsuit by the NFIB, which purports to be the "Voice of Small Business." Not small businesses like mine.

I actually used to be an NFIB member, until I read their literature and realized they're more interested in playing politics than giving real small businesses a voice.

I've never considered myself a very political person. Growing up in a big family (11 kids), you learn to consider all sides. I have siblings who are Republicans, Democrats, even Independents. I love them all. My sister, a Republican, has been skeptical of health reform, but even she admits that it's working for people like me.

I'm sure some people might say I'm at fault for my own

situation. Even though I would have been rejected whenever I applied due to my pre-existing condition, I still feel some responsibility for not applying for health coverage when I was younger.

But isn't personal responsibility part of the point of health care reform? The new law is built on the idea of sharing responsibility to fix a broken system.

It's the insurance companies' responsibility to stop denying coverage for pre-existing conditions.

It's the government's responsibility to ensure that coverage is affordable with premium assistance on a sliding scale and tax credits for small businesses.

And, if we get access to coverage that's affordable, isn't it all of our responsibility to be a part of the solution by purchasing insurance?

If any one of us – insurance companies, the government, or individuals – fails on our end of the bargain, reform breaks down.

So, for the NFIB, McKenna, and the other AGs on this lawsuit, I have a message. I believe that I – and millions of other Americans who are benefiting from health care reform – deserve for you to look us in the eye and explain why you want to take our health care away.

Maybe, just maybe, when you hear our stories, you might consider changing your mind.



## Diabetes and oral health

According to the American Diabetic Association more than 25.8 million children and adults in the United States—8.3 percent of the population—have diabetes. Diabetes develops in people of all ages. However, there is higher frequency of development in African Americans and Hispanics. Diabetes is a disease that can affect the whole body, including your mouth.

Research shows that there is an increased prevalence of gum disease among those with diabetes, adding to the list of other complications associated with diabetes, such as heart disease, stroke and kidney disease. Emerging research also suggests that not only are people with diabetes more susceptible to serious gum disease, but serious gum disease may have the potential to affect blood glucose control and contribute to the progression of diabetes.

Because diabetes can lower your resistance to infection and can slow the healing process. The most common oral health problems associated with diabetes are: Tooth decay

- Periodontal (gum) disease
- •Salivary gland dysfuncion
- •Fungal infections/Oral Candidiasis
- •Lichen planus and lichenoid reactions (inflammatory skin disease)
- •Infection and delayed healing
  - •Taste impairment Tooth Decay

Your teeth are covered with plaque, a sticky film of bacteria. After meals, snacks, or beverages that contain sugars, the bacteria release acids that attack tooth enamel creating cavities.

When diabetes is not controlled properly, high glucose levels in saliva may help bacteria to increase. Plaque that is not removed can eventually (calcify) into calculus, or tartar. This can create conditions that lead to chronic inflammation and infection in the mouth.

#### Periodontal Disease

Periodontal disease is an infection of the gum and bone that hold your teeth in place. Periodontal diseases often appear to be more frequent and more severe among persons with dia-

betes. Signs of Periodontal Disease are gingivitis/bleeding gums, bone loss, periodontal abscess, bad breath and tooth mobility.

Salivary Gland Dysfunction

Saliva helps wash away food particles and keeps the mouth moist. Without enough saliva, bacteria will increase. Dry mouth, or Xerostomia, is a common complaint among diabetic dental patients. Dryness irritates the soft tissue in the mouth, often making them inflamed and painful. This condition greatly increases the risk of tooth decay and periodontal disease. Some recommendations for dry mouth are using a saliva substitute for relief from discomfort, taking frequent sips of water, using melting ice chips and restricting intake of caffeine and alcohol.

### Infections and Delayed Healing

Infection is a risk for the diabetic patient and can make it more difficult to control blood glucose levels. If you are having extensive oral surgery or even a simple extraction, the dentist may prescribe antibiotics to minimize the risk of infection.



To help the healing process, blood glucose levels should be under control before, during and after surgery extractions.

Other oral conditions that can be associated with diabetes are Oral Candidiasis. a fungal infection in the mouth that appears to occur more frequently among persons with diabetes including those who wear dentures. Dentist may prescribe antifungal medications to treat this condition. Good oral hygiene is critical. Another is Lichen Planus, a skin disorder that presents oral manifestations. Lichen Planus involves painful lesions in the oral mucosa. There is no permanent cure, dentist may prescribe a topical anesthetic or other medication to reduce and relieve the condition.

## HIV community treatment as prevention

A new study finds that treating HIV infected community members reduces the spread of the virus to others within that community. The study found that as more and more community members are put on treatment, fewer and fewer people become infected with the virus.

The community "treatment as prevention" study results were presented in Seattle at the Conference of Retrovirus and Opportunistic Infections.

Researchers from the Africa Centre for Health and Population Studies used HIV surveillance data collected in KwaZulu-Natal, a poor rural area of South Africa where almost one out of three have HIV. Over time, about 20,000 individuals among 228,000

area residents were put on HIV treatment.

The study found that for each percentage point increase for those in the area who were put on HIV treatment there was a significant decrease in HIV transmission.

When HIV treatment coverage reached 20 percent of the infected population, there was a 22 percent decline in HIV infections community-wide, said study researcher Frank Tanser, PhD, of the Africa Centre for Health and Population Studies in South Africa. "In communities where HIV treatment achieved 30 percent, the individuals' HIV acquisition was 38 percent less likely."

The results have implications for HIV at-risk communities well beyond AIDS



ravaged Africa. Here in the United States greater HIV treatment access should achieve the same "Treatment as Prevention" reductions in new transmissions for affected communities.

"These findings are extremely important," said Paul De Lay, deputy executive director, Programme, Joint United Nations Programme on HIV/AIDS.

"The results give clear evidence that HIV incidence is

reduced as a result of high coverage of antiretroviral therapy," added Dr. Tanser.

The research also confirms last year's breakthrough study that proved the concept of Treatment as Prevention. It found that effectively treating HIV infection provides an HIV prevention bonus of reducing the spread of the virus for couples where one partner in HIV infected and the other is not. The groundbreaking study, known as HPTN 052, found that if an HIV-positive person stays on antirviral therapy, the risk of transmitting the virus to their uninfected sexual partner can be reduced by 96 percent. That study was conducted among African heterosexual couples, not on a community-wide scale like the new study.

## What a little bit of urine can tell

Perhaps it was 40 years ago that a friend of mine came to my home late in the evening, very upset and concerned about his father. He had brought with him only a sample of his father's darkly stained brown urine, which foamed with the slightest agitation. He was concerned that his father might be bleeding in the urine from some tumor of the bladder, prostate or kidney.

A few pertinent questions established that his father's eyes and skin were deeply stained yellow but his bowel movements were almost colorless. It was my sad task to inform my friend that his father required hospitalization without delay. If he was lucky, his problem might be traced to a gallstone obstructing the flow of bile but unfortunately, cancer of the pancreas would have to be considered a more ominous cause.

Sorry to say, that was the diagnosis and the father succumbed to this illness soon thereafter. Foaming of the urine was the kev: bile makes the urine foam. So a diagnosis was reached or at least strongly suspected just by examining the urine. Patients often ask why they're asked to give a urine specimen before they are examined. So much information can be obtained from the proper examination of a patient's urine specimen; it would be unthinkable for the urologist to reach a conclusion about a patient without first having done a complete urinalysis.


Even in ancient, Babylon, Egypt, India and particularly during the Roman and Byzantine Eras, doctors were skilled in making diagnoses simply by looking at the patient's still warm urine specimen in a clear glass. This skill was known as "Uroscopy," often included actually tasting the urine for sweetness or sugar and it has become the forerunner of modern urinalysis.

Today, a complete urinalysis requires not only the visual appreciation of the appearance of the urine specimen but a complete chemical and microscopic evaluation as well. Usually, the chemical testing is done by use of a "dipstick," which rapidly and accurately gives the results to up to 10 different tests including sugar, protein, blood, ketones, bilirubin (bile), urobilinogen, nitrates, specific gravity, pH (acidity), and white blood cells (pus). That's only part of the story however; microscopic examination of the centrifuged urinary sediment completes the urinalysis because white blood cells, red blood cells, bacteria, fungi, yeast, crystals, and casts, which are solidifications of certain proteins within the kidney tubules are easily seen.

Many different types of crystals, each one distinguishable under the microscope give valuable clues as to the cause of a patient's kidney stone formation. Complete urinalysis remains an indispensable tool for the modern urologist to properly diagnose and treat every patient. The next time you are asked to give a urine specimen, be happy that so much information can be obtained "from just a little bit of urine.

## Peninsula Hospital closure 'devastating'

Assemblywoman Michele Titus (D-Queens), chair of the Assembly Social Services Committee, blasted the mismanagement that resulted in the closing of Peninsula Hospital on Tuesday.

assemblywom-The an called on the State Department of Health to reevaluate the closure and ensure that Peninsula will reonen.

As a result of the shutdown, more than 1,000 jobs will be lost and countless families on the Rockaway Peninsula will be affected.

"The news that Peninsula Hospital is closing is devastating to Far Rockaway families and hospital employees," Assemblywoman Titus said. "It leaves many dedicated workers without a job and hardworking families with even fewer options for vital medical attention it's simply unacceptable."

### Countless families on the Rockaway Peninsula will be affected.

Last month, the hospital failed a state inspection of its lab, suspending most of its patient care and forcing ambulances to divert to other local hospitals. With the influx of additional patients, wait times in emergency rooms will soar and doctors and nurses will be stretched even thinner, Assemblywoman

Titus noted.


"Flooding nearby hospitals with more and more patients could cost lives,' Assemblywoman Titus said. "We can't allow that to happen – we need a more viable option. And to that end, I hope the State Department of Health steps in, reevaluates and Peninsula can be up and running again.'

Peninsula Hospital has been in operation for 104 vears with more than 170 hospital beds at its facility. Because of the closure, more than 100,000 residents of the Rockaways will be left with only St. John's Episcopal Hospital to serve them in case of emergen-

"Careless mismanagement at Peninsula Hospital now means that Rockaway families will be without an important healthcare option," Assemblywoman Titus said. "Our community is reeling and I hope we can address this situation quickly," she added.

The UDP won 17 of the 31 seats with the PUP improving significantly on the six seats it held in the last parliament to take 14 seats.

Opposition Leader Francis Fonseca said the polls which were monitored by an observer team from the Organization of American States (OAS), were neither free nor fair and that the electoral process was tainted with irregularities.

He said across the country there have been credible, reliable, documented reports of abuse and illegality in the conduct of the election process

"Our party has assembled legal advisers, who are examining the documented evidence and reviewing the legal options available,' he said.

The opposition leader said it is the intention of the PUP to file several election petitions in respect of the March 7 general elections.

The OAS praised Belize for the peaceful conduct of the poll, but urged the authorities to regulate campaign finance and curb the level of electioneering around polling stations.

### Grenada

The Grenada government is taking legal action against Lawrence Duprey, the former executive chairman of the financially-troubled CL Financial and its Colonial Life Insurance Company (Clico) subsidiary.

Grenada and other Caribbean countries have been severely affected by the financial problems plaguing the Trinidad-based conglomerate, CL Financial, the parent company of British American Company (Baico) and Clico resulting in the loss of millions of dollars to policy holders.

Finance Minister Nazim Burke told legislators that the Eastern Caribbean Currency Union (ECCU) member countries are continuing to pursue support from the Trinidad and Tobago government that has pumped billions of dol-

lars as part of a rescue plan for Clico policyholders in that country.

Burke said the support is being sought from Port of Spain for non-traditional policyholders including policyholders with Flexible Premium Annuities.

### Guyana

The Guyana government has denied that it entered into a secret agreement with the Trinidad-based conglomerate ANSA McAL to build an ethanol plant in the South American country.

Agriculture Minister Dr. Leslie Ramsammy reiterated the government's position, less than 48 hours after an official government statement indicated that the ANSA McAl Group would build the ethanol project on 110,000 hectares.

The government said ANSA McAl's selection was done by the U.S.-based company Numark Associates Inc. which won a publicly tendered service consultancy to

expand bio-energy opportunities in Guyana

The agreement was signed last September to process up to 2,000,000 tons of sugarcane per year and produce 40 million gallons of ethanol annually.

Ramsammy said from his knowledge, no past or present government officials have ever engaged in any secret deal for the production of bio-fuel locally.

#### Haiti

President Michel Martelly displayed his Haitian passport on national television recently to try and quell rumors that he gave up his citizenship and is not eligible to hold office.

The Haitian constitution does not recognize dual nationality for senior government officials.

Critics of Martelly charged that he had renounced his Haitian citizenship prior to taking office last May. He had already denied that he held the citizenship of another country. But recently he showed reporters eight stamped passports that he has held over the years.

### Jamaica

Reggae singer Adidja Palmer, better know as Vybz Kartel, was remanded to prison recently after he appeared in court charged with the murder of a businessman.

He will return to court later this month when the prosecution is expected to hand over documents to his defense attorneys.

Palmer, 35, is accused of conspiring with other men to murder businessman and promoter Barrington Burton.

It is alleged that on Monday July 11, 2011, Palmer, along with other men conspired to murder Burton, a 27-year-old businessman/promoter, who was killed while standing with friends along Walkers Avenue in Gregory Park.

The dancehall entertainer is also facing charges of conspiracy to murder and illegal

possession of a firearm.

#### St. Kitts

The opposition in St. Kitts says it has drafted a Freedom of Information Act and has submitted it for debate in the National Assembly.

Opposition Leader Mark Brantely said as with the Integrity in Public Life, which the opposition had unsuccessfully submitted for debate among legislators last year, the Freedom of Information legislation was essential for the development of the country.

He said even as the opposition submitted new bills, it was not giving up on its efforts to have the Integrity in Public Life legislation brought to the House for debate, even if it meant making amendments.

Brantley said the Freedom of Information Act is vital for the democracy and the draft legislation had the input of all members of the opposition.

## Southeast Queens residents clean up

The litter-strewn lawns that demarcate vacant foreclosed homes are a rarely considered side-effect of the impact the foreclosure crisis has had on Southeast Queens, But residents who are tired of the unsanitary and often dangerous conditions presented by the neglected properties are fighting back.

On Saturday, March 17, members of the New York Queens Chapter cleaned up the trash from the lawn of 109-31 157th St. in Jamaica. Queens and delivered it to a local branch of CitiBank (168-48 Hillside Ave) who foreclosed on the property.

"Since the economy collapsed and I was laid off I have struggled to pay my mortgage. There are already two vacant homes

to think that if I lose my home, that it will become a blight on the community," said New York Communities for Change Member Tikhia Williams who lives around the corner from 109-31 157th St.

"Before the financial crisis, Southeast Queens was a community full of proud homeowners. We took care of our homes and lawns and watched out for our neighbors. Now the foreclosure crisis has driven countless families out of their homes and our new neighbors the big banks — only care about their profits, not about what's good community. This is no way to live," said New York Communities for Change Member William Seaberry of St. Albans.

The excess garbage in the community attracts rodents and other vermin, and the abandoned homes create an environment that is conducive to criminal activity. The homeowners who remain in the neighborhood are facing decreasing property values and worsening conditions

Communities for Change on this block. It pains me because the banks that foreclosed on these properties are not doing their part to care for them.

> "For a while now, many people have been able to make their mortgage payments. Seeing the value of our homes decline because of the vacant properties is salt in the wound," said New York Communities for Change Jean Sassine of Queens Village. "The banks who caused the financial crisis should be taking responsibility for these properties. If they can't, then they should leave them in the hands of families who would be happy to."

> More than 11 million Americans owe more on their mortgages than their homes are worth and declining property values from unkempt vacant lots continue to drive up the underwater rate. Underwater home owners are more likely to be foreclosed on. Currently Southeast Queens has a foreclosure rate three times higher than the state aver-





He said the pope and the Catholic Church in Cuba desire a political system that grants dignity to all people.

During his near hour-long meeting with Castro, Benedict asked the president to declare a holiday for Good Friday, when Catholics commemorate the death of Jesus Christ.

The request was a follow-up of sorts to Cuba's decision to declare Christmas a national holiday in honor of John Paul's 1998 visit. Cubans hadn't had Christmas off for nearly 30 years.

"It's not that it changes reality in a revolutionary way, but it can be a sign of a positive step, as was the case of Christmas after John Paul's visit," said the Vatican spokes-

man, the Rev. Federico Lombardi.

Pope Benedict also raised "humanitarian" issues with Raul Castro, an apparent reference to political prisoners.

But Marino Alberto Murillo Jorge, Cuba's minister of economy and planning, has ruled out political change following Benedict's call for Cubans to "strive to build a renewed and open society, a better society, one more worthy of humanity, and which better reflects the goodness of God."

Murillo addressed foreign journalists on Mar. 27 about the island's economic changes, but added, "In Cuba there will not be political reform."

Nonetheless, Cuban dissidents have seized on the pope's visit to shine light on the Communist government's treatment of

those with opposing political views.

The government has been closely following the activities of dissidents, particularly the Ladies in White, a small movement of women who wear white and gather at Masses at Catholic churches in Cuba to protest the treatment of the island's prisoners of conscience.

On Mar. 28, Pope Benedict XVI wrapped up his visit with an open-air Mass in the shrine of the Cuban revolution. He also met with former President Fidel Castro, Raúl's elder brother.

"I will happily greet His Excellency Pope Benedict XVI as I did John Paul II, a man for whom contact with children and the humble raised feelings of affection," Castro had written the day before.


On Broadway, she joined Jennifer Holiday and Loretta Devine to mimic a trio of singers often described akin to Motown Records triumvirate Supremes.



Hannah (Rachel Hendrix) has suffered from a host of afflictions over the course of her childhood, including asthma, seizures and multiple hip surgeries. Besides her physical ailments, the poor girl has unfortunately been haunted mentally by a nagging sense of feeling unwanted, despite being raised by a couple of very loving parents (John Schneider and Jennifer Price).

Everything comes to a head during her freshman year in college, after she collapses on stage while performing in a school play. Her parents rush to campus where they inform her doctor (Lance E. Nichols) in the infirmary that their daughter has considered committing suicide.

Hannah's dismay upon learning that her folks had invaded her privacy by reading her diary is forgotten as soon as they proceed to make an even more shocking revelation. For not only do they subsequently announce that she had been adopted, but that she had miraculously survived an attempted abortion when her mother was only 24 weeks

That bombshell triggers an explosion of emotions inside Hannah ranging from bewilderment to desperation to rage. But at least she finally has an idea why she's been so sickly and saddled with emotional trauma all her life.




team and his parents to decide on the strategic next step that would be most effective to bring George Zimmerman to justice.

The day following the New York demonstration, Sanford Police Chief Bill Lee temporarily stepped down from head of the Sanford Police Department. A public letter from the NAACP calls on the Florida State prosecutor to swiftly pursue justice.

Similar demonstrations in London and Australia are broadening the focus to fight racial discrimination.

A vigil held at Union Square on March 26 read 20 names. paving tribute to victims of hate crimes. Remarley Graham, an unarmed Bronx teen, killed by police in his own home this year on Feb. 8, was one who was memorialized. On March 27, Trayvon's parents testified in Washington on Capital Hill about racial profiling.


### Players Assn. claims victory

The present Collective Bargaining Agreement (CBA) and Memorandum of Understanding (MoU) between the West Indies Players Association (WIPA) and the West Indies Cricket Board (WICB) will remain in force until the dispute between the two parties is decided in the High Court of Trinidad and Tobago at a future date.

According to a WIPA media release, Justice Ricky Rahim granted a final mandatory injunction recently forcing the WICB to treat the agreements as in full force and effect, despite the board's pleas to the contrary and has made it clear that the WICB would be held in contempt of court if it breaches the court's order.

It's nothing new for Boys & Girls High School to come into Madison Square Garden and compete for a New York City Public Schools Athletic League basketball championship. And it is big for the team, including the players, coaches, and staff at the school, to win three titles during the same number of years, as no school has ever done it before.

"We are honored and felt great for our championship," added Lovelace. "It was difficult (at the start of the season) to bring new players in (and they jelled together very well). The guys stepped up and made plays (in the win over Jefferson). And I did the job successfully."

The agreements and other documents safeguarding the rights of the players, came into effect on Sept. 1, 2005, with the provision that they could only be changed or replaced with the agreement of both parties. If not, they would continue in force.

In 2008, the agreements rolled over. However, in 2011, the WICB signaled its intention to unilaterally terminate the agreements.

The WICB's position was that a termination provision can be implied in the agreements even though none is specifically stated.

WIPA objected to this and in reply stated that not only did the parties intentionally omit a unilateral termination clause, but that the agreements mandated that the parties negotiate and come to a new agreement themselves.

Commenting on the judgment, WIPA President and CEO Dinanath Ramnarine said, "This is a big victory for WIPA and the

players.

"Justice Rahim's decision in the matter ensures that the WICB cannot continue to trample upon



soiled Meara's scoring sheet when Jamaican international Omar Cummings benefitted from Mexican International Rafael Marquez's mistake in front of the home team's goal and scored from 20 yards in the 77th minute for his first goal of the season.

### Trinidad & Tobago Lose

allowing Australia to take first strike. Team Australia piled up 281 runs with their openers having a swashbuckling partnership of 118. Captain Shane Watson and his opening partner David Warner took full advantage and used their experience, mixing aggression with caution and expedited their batting powers with excellence.

The most important thing for the Aussies in the final One-Day was that they did not lose an early wicket, while David Warner was more of the aggressor of the two openers, playing aggressively against every bowler that he faced. The tourists' innings of 281 was boosted by three half-centuries by Captain Shane Watson 66, David Warner 69 and Peter Forrest 53. It was unnecessary to give the Aussies first strike. The West Indies were bowled out for 251, losing the game by 30 runs.

West Indies captain and head coach will have to modify their decision-making going into the test series, which starts Saturday, April 7. The ODI series ended 2-2 -- a tame draw, with one game ending in a tie.

### Andre Russell Has **Great Potential**

Andre Russell has tremendous abilities but his batting must be closely monitored by Head Coach Ottis Gibson. Russell should be batting at Number Four, because he has the ability to perform against pace and spin. He is a powerful and confident player who has the courage to bat in that position and produce for the West Indies. Darren Bravo must bat lower in the batting order.

Darren Bravo Must go Down in the Order

It is fitting to allow Dwayne Bravo to bat ahead of his brother Darren Bravo. Inspite of Darren being out of form, he will serve the team much better in One-Day cricket batting at number six. Doing this will create stability for the middle order and give the West Indies batting much more depth.

A vital partnership is important in the top order of the batting and another two at minimum is needed in the middle to reach winning targets. In the top order, aggression must be mixed with excellent consolidation to avoid too many wickets being taken. Dwayne Bravo has been around for a good while and as a senior player he needs to come up with some good scores for the team.

Wicket keeper Carlton Baugh seems to have a crucial battle with the higher level of cricket. He is not



# **Improving** listening skills

Last week, we discussed how to take notes. This week we'll focus on ন্ধ listening.

No matter what method of note-충taking is used, adequate listening skills e are necessary to take effective notes.  $\overline{\mathbb{R}}$  This helps students transfer what the professor is saying into ideas that can be put down on paper. Staring off into space or having your mind drift can cause a student to miss out on key parts of a lecture. To improve note-taking skills. a student must first improve listening skills.

- ·Sit up closer to the teacher or professor: This enables eve-toeye contact that may help a student focus. It may also trigger visual clues to a professor to gauge whether the class is catching on or missing what's being taught. It's also advantageous from a practical standpoint. It enables students to better hear what's going on. If the professor is garbled or inaudible when sitting far away, moving closer is essential, especially in a large lecture hall.
- •Remove distractions: When a student enters the classroom, he or she should be ready to learn. That means silencing mobile devices and gearing the mind toward the lessons. Not every lecture will be exhilarating, so students should make a conscious effort to pay attention. Limiting distractions can
- Use an assistance device: Students who are prone to "zoning out" may want to ask permission to use a voice recorder. This way if key elements of the lesson are missed, they can be played back. This method also helps students fill in gaps when taking or studying notes. Keys To Note-taking Once listening skills have improved, students can go onto to other note-taking pointers.






