Cuba changes travel policy

The Consulate General of Jamaica in New York inaugurates a film series to celebrate the country's 50th anniversary of Independence and commemorate the spirit of sacrifice and leadership of the nation's heroes. "Time of Fury – The 1865 Morant Bay Rebellion" chronicles arguably the bloodiest repression of dissent by the British colonial

authorities in Jamaica during the post-emancipation era. The feature film, from the archives of the now defunct Jamaica Broadcasting Corporation, and directed by veteran broadcaster, Cary Robinson, producer of the 'Hill & Gully' TV Series, will be screened at the Bronx Bethany Church of the Nazarene, 971 East 227th St., on Tuesday, Oct. 23, 2012, starting at 6:30 p.m.

The dramatic epic "Time of Fury – The 1865 Morant Bay Rebellion" uses the medium of film to place in context the lives, struggles, and, personal sacrifices, of Paul Bogle, George William Gordon and their contemporaries, and response by the government of the day. As reported on Nov. 11, 1865, in less than a month of the

STING FOR TAX CHEATS

U.S. aiming at Carib money launderers

GEORGETOWN, Guyana --Caribbean bankers and representatives of the regional trade bloc (CARICOM) are to meet Thursday, Oct. 25 to discuss a common approach to a new American law compelling foreign banks to turn over, from next year, information about Americans with accounts overseas, officials said Wednesday.

Gobin Ganga, deputy governor of the Guyana Central Bank said a recently established regional task force, the umbrella Caribbean Association of Bankers (CAB) is now ready to work with regional officials on crafting a unified strategy as to how they will respond to

the Foreign Accounts Tax Compliance law aimed at tacking tax evasion through hidden accounts overseas.

The teleconference meeting will be the first in a series planned by regional finance officials to respond to the new law that Congress passed on 2010 but which becomes effective next January.

Ganga said local banks are already readying to "comply with the new law but are also anxious for Caricom to have a unified position through the work of the taskforce."

US citizens and legal permanent residents will be affected by

Antigua

Former Antigua and Barbuda Prime Minister Lester Bird says he will continue to lead the opposition Antigua Labor Party (ALP) despite the "anxieties" among supporters regarding his health and age.

"I am still very much able to perform the tasks of the leader and would step aside any moment my doctors felt that such tasks were likely to exceed my limitations,"

said Bird, 74, the island's second prime minister.



In a statement, Bird said there

would soon be a retreat of party leaders "in an effort to iron out many of the difficult issues that have causes some anxiety among supporters."

"We are in the process of preparing the constituencies for a convention in the latter part of November, 2012, and placing the right men and women on the appropriate slots as candidates very shortly afterwards," the statement said.

Bird, who was re-elected ALP leader in 2008, said that his vigor for the job could be seen in the various legal and other actions he has undertaken in challenging the authorities on a number of issues.

He reminded supporters that when he first became ALP leader, he bought with him more than two decades as a parliamentarian and an equal number of years as deputy premier and deputy prime minister.

He said with the next general election constitution due in March 2014, "I have readied myself to lead this heritage party to victory".

Bahamas

Tax reforms, a mortgage relief program, and incentives to drive more foreign direct investment are among the new measures that the

Bahamas government hopes will jump-start the slowing economy.

These meas-



ures among others were outlined in a statement issued Sept. 25 by the Ministry of Finance following the announcement by Standard & Poor's (S&P) the same day that it was revising downward its outlook on Bahamas long-term rating from "stable" to "negative." However, the U.S. ratings agency maintained its sovereign credit rating for The Bahamas at 'BBA/A-2'.

The Ministry of Finance stated" "As S&P clearly articulates in their statement, this administration inherited a deteriorating fiscal situation where the deficit target was overshot by a wide margin. This was in addition to the absence of a credible plan for deficit and debt reduction or taxation reform by the former administration".

Cayman Islands

The Cayman Islands has enacted new traffic laws and regulations, which introduce a ban on the use of mobile telephones while driving. Effective last month, it will be against the law to talk, text, instant message, etc.

Juliana O'ConnorConnolly said,

"Too many people have become too accustomed to checking e-mail or sending text while behind the wheel, even though it's as dangerous as drinking and driving."

She noted that most countries throughout the world such as the UK and other European countries, New Zealand, Canada and the United States have banned cellphones while driving.

Drivers who have found to be in breach of the ban on cellphones while driving will face a \$150 fine.

Haiti

Haiti's Prime Minister has sued a Haitian-American weekly newspaper for defamation over its reporting on the sale of a telecommunications company acquired by the Haitian government.

In the recent lawsuit filed in Miami federal court, Prime Min-



ister Laurent Lamothe and South Florida businessman Patrice Baker said Haiti-Observateur's reporting on the sale of Haitel was "outrageous, scandalous and reminiscent of a tabloid publication."

The Haitian telecom shut down earlier this year because it couldn't pay its debts. It was then acquire by the Haitian government.

In an article written in French for Haiti-Observateur's Sept. 12, 2012 edition, Joseph said Lamothe has not answered questions about the sale, though the prime minister has "cried, 'defamation' accusing Leo Joseph and the weekly of spreading of lies against him.

The newspaper has been publish-

ing since 1971 and serves Haiti's large diaspora communities in New York, Florida, Montreal and the Caribbean.

"The newspaper spread false information about the prime minister and we are taking legal measures to request that they be retracted or appropriate remedy is given,' said Salim Succar, special adviser to Lamothe.

Jamaica

Hundreds of Jamaicans dressed in black, took to the streets across the island recently to protest the upsurge in violent crimes, particularly those against women and children.

The protest organized by the group, Woman Inc. had been prompted by the rape of four

women and an eight-year-old girl recently by armed gunmen in the western parish of



St. James. They were also protesting the alleged rape of an 11-year-old girl who had been pregnant by her uncle.

National Security Minister Peter Bunting led protestors in the western city of Montego Bay and some of the protestors have called on the authorities to re-implement the death penalty.

"Government needs to re-implement the death penalty," said Betty-Ann Blaine, New National Coalition founder, who joined more than 200 protestors in Half Way Tree on the outskirts of the capital, armed with placards denouncing the violent acts against women.

Police say investigations are continuing in connection with the rape of the eight-year-old child and four other women.

Jamaica

Jamaica Finance and Planning

Minister Dr. Peter Phillips has disclosed that the government will be removing more posts from



the public sector before the end of the year.

These positions are in addition to just over three positions that will be axed to reduce public sector wage bill.

While unable to say how many additional posts would be involved, Phillips said the process would be done without impairing the functions of the public bodies. He also said the posts to be removed would be those that are currently not filled.

Phillips said the removal of the positions would contribute to an overall reduction in the expenses because these positions are all funded posts.

Suriname

An attorney representing Presi-

dent Desi Bouterse said the allegations that he is involved in drugs are just a fabrica-



tion to hinder his attempts to quash a damning drug conviction.

Criminal lawyer Inez Weski said a motion to overturn Bouterse's 1999 drug conviction would be filed soon with the Court of Appeals in the Netherlands.

Dutch police recently reported that the word "Bouta," the soubriquet by which Bouterse is known, was heard in a taped conversation of cocaine smuggler Piet Wortel.

Wortel was arrested a few months ago in Barcelona, Spain for involvement in large cocaine shipments. He reportedly said that "Bouta"

island wide conflagration, the New York Times wrote, "It is calculated that about 1,800 of the insurrectionists have been killed in the different engagements that took place with the troops and volunteers, and up to the above-named date, 125 had suffered the extreme penalty of the law."

Jamaica, this week, remembers its national heroes and the indelible mark they made in fashioning the nation's history, strength of character and unique identity by challenging the injustices of colonialism, racism, and poverty.

Established in 1969, as the highest award to be conferred on any citizen who has "rendered the most distinguished service to the country", the Order of National Hero has been conferred on one woman and six men: Nanny, outstanding military leader during the First Maroon War; Sam Sharpe, for leadership in the resistance against slavery during the rebellion of 1831; Paul Bogle and George Gordon, for their roles against social injustices in post-emancipation, colonial Jamaica during the rebellion of 1865; Marcus Garvey for his commitment to social and political betterment on the country's racial majority; Alexander Bustamante and Norman Manley, as architects of political independence.

George William Gordon was born in 1820 to an enslaved black mother and a white plantation owner father. He was a shopkeeper, produce dealer, Baptist preacher and landowner. Gordon entered politics as an advocate for the poverty-stricken peasants in the largely rural parish of St. Thomasin-the-East which he represented in House of Assembly. Additionally, his bitter criticism of Lt. Gov. Edward Eyre alienated him form much of the plantocracy.

There are conflicting reports if Paul Bogle was born free in 1820, 16 years before the end of slavery in the British Empire. However, by 1865 he was a Baptist deacon of significant reputation and one of handful of black landowners on the island with significant holdings. His 500 acres qualified him to vote in local elections and was a political adherent of Assembly member, George William Gordon.

Responding to the worsening social and economic situations in the decades following emancipation Paul Bogle led a delegation to take their complaints to the governor. The audience was denied. On Oct. 11, 1865, Bogle and about 300 men marched into Morant Bay and raided the police station. They then marched to the Court House where the local authorities were meeting. The resulting confrontation resulted in the governor's representative and fifteen vestrymen being killed, 51 prisoners freed, and

the courthouse razed. After the imposition of martial law, George William Gordon was seized from his home in southern parish of St. Andrew, convicted of treason and hanged on Oct. 23. Bogle was eventually captured by the Portland Maroons, was court marshaled and executed, along with his brother Moses, on Oct. 24.

The Morant Bay Rebellion and the resultant deaths of Bogle and Gordon precipitated the beginning of a new era in Jamaica's development. The British colonial authorities were compelled to make reforms in the administration of education, health, local government, the courts, banking and infrastructure.

The screening of "Time of Fury – The 1865 Morant Bay Rebellion," on the 147 anniversary of the revolt, will be held under the patronage of Consul General of Jamaica in New York, Hon. Herman LaMont and hosted by Rev. Sam Vassal of the Bronx Bethany Church of the Nazarene. The public is invited to this celebration of another aspect of Jamaica at 50, as we reflect on the past and reimagine the future.

in November," Bischotte told Caribbean Life.

"The September election was disastrous, Bischotte added. "As a result of the recent redistricting, many voters didn't vote because they were turned away from their normal polling sites; were misinformed on the use of affidavit-paper ballots and some on voter-ID laws.

"This is why we

thought it was the right thing to do to prepare people on the process of voting, their rights and alternative ways of voting. "We will also have a poll-site look-up table to assist people on where to find their polling sites," Bischotte added.

Bichotte is the current district leader for the 42nd Assembly District, covering Flatbush, East Flatbush, Midwood and Ditmas Park.

FACTA as it mandates banks to report all accounts with more than \$50,000 to the Inland Revenue Service (IRS). The bankers association said that it is concerned with some clauses that mandate registered banks to also report account of non residents and non citizens once

they spend more than two months a year in the US.

CAB spokesman Carlton Barclay has said that regional banks have to be careful as local confidentiality laws will be broken if full compliance is adhered to.

Caribbean leaders had raised the issue with President Obama in Colombia earlier this year but no formal follow up has been held.

Trinbagonian-American trailblazer passes

The first foreign born Caribbean American to serve in the U.S. Congress has died. Trinidad-born Mervyn Dymally passed on Oct. 7 in California after a long ailment. He was 86.

The trailblazer who has helped paved the way to improved conditions for all Americans was acclaimed as an advocate for civil rights.

He was a champion for equal rights and blazed a path for west coast residents as well as the underserved across the nation.


Dymally entered national politics simultaneous to his birthplace Trinidad& Tobago attaining independence in 1962.

A self-described civil rights champion, he was first elected as a California assemblyman that year.

He later became the state's first Black state senator in 1966 and its first and only Black lieutenant governor eight years later.

In 1980, he won a congressional seat in Los Angeles representing Compton and its surrounding area.

After that, there was no stopping the

ambitious and dedicated politician.

While serving his state in Washington D.C., through legislative circles he became California's highest-ranking Black politician.

"He fought for justice and equality for all people and served as a great role model for the next generation," Dr. Claire Nelson, president of Institute for Caribbean Studies said. "His success is a testament to the integration of Caribbean Americans into the American landscape and their contributions to the political and social fabric of the U.S."

"He was a stalwart for disenfranchised people and struggling communities at home and abroad," she added.

In Congress, he served as chairman of the Congressional Black Caucus.

While there, he championed economic and humanitarian aid for Africa and the Caribbean as chairman of the House Foreign Affairs Committee.

Dymally retired from Congress in 1992. However, he re-entered state politics at age 76. He won the same Assembly seat he held at the start of his political career.

"Merv knew how to build a political network better than nearly anyone," his former colleague Nancy Pelosi said. "He opened doors for the next generation of minority leaders."

He remained committed to public service for his entire life, serving not just as an elder statesman but a public official until a few years ago when he took ill.



Deportation reprieve

The United States says 179,794 applications have been received, and 4,591 have been approved two months after it started giving reprieves from deportation and work permits to young illegal Caribbean and immigrants.

The U.S. Department of Homeland Security said the number of approvals have increased significantly since it reported on Sept. 14 that 29 immigrants had been the first ones granted the two-year deportation deferrals.

Peter Boogaard, a department spokesman, said immigrants should now expect that the average time to process an application to be four to six months, stating that as many as 1.2 million immigrants could be eligible.

intense activity around the program in immigrant communities, especially among Latinos, has already yielded some political benefits to Obama, with Democrats repeatedly highlighting the initiative during their recent convention.

Initiated by an executive action, the program grants deportation deferrals that must be renewed after two years, but it does not provide any legal immigration

To be eligible for the deportation reprieve, illegal immigrants must be under 31 years old and have come to the United States before they were 16.

They must show that they have lived in the U.S. continuously since June 15, 2007, and be currently

in school or have earned a high school diploma or have been honorably discharged from the U.S. Armed Forces.

According to the Migration Policy Institute, a Washington-based nonpartisan research group, as many as 1.2 million illegal immigrants could be immediately eligible for the program.

"If somebody submits documents that show by the preponderance of the evidence that they meet the guidelines, we are poised to move the cases as quickly as possible," said Alejandro Mayorkas, director of the U.S. Citizenship and Immigration Services, the immigration agency that falls under the purview of the U.S. Department of Homeland

CARICOM commits to fighting cholera outbreak

The Caribbean Community (CARICOM) grouping says it will provide support to Haiti and the Dominican Republic to help deal with the cholera outbreak in the two countries.

CARICOM Deputy Secretary General, Ambassador Lolita Applewaithe, recently signed a declaration committing the 15-member regional grouping to join the international effort in the new "Regional Coalition on Water and Sanitation for the Elimination of Cholera" on two countries that make up Hispaniola.

CARICOM says it will support efforts by the governments of the two countries to harmonize and streamline international assistance and investments in water sanitation infrastructure aimed at eliminating cholera and to "work... in solidarity, towards the

steady improvement of universal access to safe drink-

ing water and sanitization in Haiti and the Dominica Republic."

The coalition launched in Salvador, Bahia, in June and is aimed at harnessing the necessary technical expertise, raising new funds and mobilizes previously committed pledges to fight cholera in the two Caribbean countries.

The World Bank and the

International Red Cross Federation have also signed the accord.

Ambassador Applewaithe said that the initiative would further consolidate the region's efforts to address the public health challenge posed by the cholera epidemic in Haiti, following the devastating January 2010 earthquake.

More than 7,000 people have died and 500,000 others have become ill in Haiti ever since the first case of cholera was detected in Haiti last October.

The Dominican Republic has reported more than 21,000 cases and more than 400 deaths.

PAHO said before the January 2010 earthquake that killed an estimated 300,000 people and destroyed many buildings in Haiti, only 69 percent of the population had access to safe drinking

Plane crash probe gets help from England

A team of investigators, which includes two members of the United Kingdom's Air Accidents Investigation Branch are assisting the Eastern Caribbean Civil Aviation (ECCA) with its probe into the fatal plane crash in Antigua, which claimed the lives of the pilot and two other passengers recently.

The tragedy claimed the lives of Captain Jason Forbes of Antigua and Annya Duncan, 29, of Jamaica, on impact. The other passenger, 57-yearold Sandrama Poligadu of Guyana also died shortly after at hospital.

The sole survivor, 23-year-old British citizen Michael Hudson is recovering at the St. Johan Medical Hospital following surgery. He was visiting Antigua en route to Montserrat for a business trip, regarding a poultry project.

The ill-fated Britten Normal Islander, Fly Montserrat, a nine-seater aircraft plunged to the ground

shortly after takeoff on Sunday, Oct. 7, 2012.

Duncan, a teacher in Montserrat had gone to Antigua for a dental appointment and was returning to the island when she met her death.

Investigators are listening to the audio recording of the conversation between the pilot and control tower operators prior to the crash.

Aviation officials say that a thunderstorm and lighting on the day may have been an aggravating factor.

Prepared for Coming Out Day?

Some parents have ideas early on, even at the age of three, that their child seems different from others of his or her gender. Little Adrian at age five, or maybe earlier, prefers to play with dolls and dress up in Mama's best dress. The little girl, Shenika, may insist on wearing pants even on Sunday when Mom wants the pretty pink dress. Of course, these are stereotypical statements, but the point that I want to make is that many parents and close family members begin to sense at an early age that their child is "different." As the years go by, they either push the feelings back in their minds and wait cautiously to notice if a Adrian is acting like a boy and Shenika is acting more ladylike.

If this is so, then why when the child becomes 16 or older, his /her announcement that he/ she is "gay" comes upon the family like a death sound that forces parents into defensive and hostile behavior. The cries of agony and shame are heard and the "coming out" result in creating the family secret. It can be even worse if the parents react in anger, disbelief or fall upon their religious teaching and totally reject and disown the child.

Today, young people are proclaiming their "gayness" at earlier ages, some as young as 10 and 11. We may want to push the genie back into the bottle, but today's more accepting attitudes towards sexual orientations and gender expressions give youth and young adults the self confidence to declare who they are at younger and younger ages. Too frequently the result can be disastrous in terms of their peers and yet as the society enforces more and more public policies against bullying and hate crimes, more open and welcoming attitudes will exist.

What happens in our Black communities where strong religious values against homosexuality and gender dissonance permeate much of our life styles and culture? What happens to the "coming out" process for our children, youth and young people? How can we evaluate ourselves and assess our movement towards a more open approach to lesbians, gays, bisexual, transgender and samegender loving people?

Statistically, we know that the Black community as a whole is moving closer to same sex marriage, although differences in attitudes may vary with age and education. In spite of these advances, we still are constrained in our acceptance of "out" and open manifestations of homosexuality... Our kids move to the Piers where they can be themselves, socialize, dress and behave free of social control and pressures. However, as their numbers increase and the area become more and more gentrified, they will eventually lose the safe place that has been a haven. What happens then when the reality is before our eyes?

The glaring contradiction in anti-Iran policy

President Barack Obama, Republican presidential candidate Mitt Romney, and Israeli Prime Minister Benjamin Netanyahu have at least one thing in common when it comes to Iran. All are guilty of flagrant self-contradiction.

Each says that a nuclear-armed Iran could not be effectively contained the way the U.S. government contained the nuclear-armed Soviet Union and Communist China. Yet each also says that Iran can be prevented from acquiring a nuclear capability or weapon if the United States and Israel draw a "red line" and threaten Iran militarily if it crosses the line.

Both assertions cannot be true. In his speech before the United Nations, Netanyahu, holding a poster of a cartoon bomb, said,

There are those who believe that a nuclear-armed Iran can be deterred like the Soviet Union. That's a very dangerous assumption... Militant Jihadists behave very differently from secular Marxists... Deterrence worked with the Soviets, because every time the Soviets faced a choice between their ideology and their survival, they chose their survival. But deterrence may not work with the Iranians once they get nuclear weapons.

There's a great scholar of the Middle East, Professor Bernard Lewis, who put it best. He said that for the Ayatollahs of Iran, mutually assured destruction is not a deterrent, it's an inducement.

In Obama's UN speech, he said, Make no mistake, a nuclear-armed Iran is not a challenge that can be contained.... And that's why the United States will do what we must to prevent Iran from obtaining a nuclear weapon.

Romney has said similar things. In his speech in Jerusalem last August he said that Iran "gives us no reason to trust them with Make no mistake, a nuclear-armed Iran is not a challenge that can be contained.... nuclear material" and that "preventing [their developing a nuclear capability] must be our highest national security priority."

All three men portray the Iranian regime as consisting of suicidal fanatics who, once having acquired even one nuclear weapon, would use it against Israel. Obama, Romney, and Netanyahu seem to believe the Iranians would use the bomb regardless of Israel's powerful military and its nuclear arsenal of at least 200 warheads, some of which are mounted on submarines, permitting a devastating second-strike capability.

In other words, if the Iranian regime were to acquire a nuclear bomb (a very big "if"), there would be no reasoning with it. Threats of massive retaliation — the essence of containment and deterrence — would likely have no effect whatsoever.

But if that is true, why would Obama, Romney, and Netanyahu expect that setting red lines backed by military threats would have the desired effect of deterring Iran from developing a nuclear capability or a weapon itself? How can Obama and Romney hope that harsh sanctions will dissuade Iran's "apocalyptic leaders" from developing a nuclear capability?

Why is deterrence expected to fail in one case but succeed in the other? The same allegedly suicidal fanatics would be making the decision.

I have yet to hear the mainstream media ask any of them these questions. Instead, the national "reporters" — stenographers, really — supinely pack Obama, Romney, and Netanyahu's fallacious premises into softball questions designed simply to let these men enunciate their talking points. You'd never know from their "coverage" that top military and intelligence figures in the United States and Israel say that Iran's leaders are "rational actors," that is, open to reason and not suicidal. The mainstream media have shamefully ill-served the American public, whose interests would be gravely harmed by a war with

The media accept another of these men's premises rather than putting it to the test. This is the assertion, as Netanyahu would have it, that Iran is racing toward acquisition of a nuclear weapon.

Both the Israeli and the U.S. intelligence communities say that Iran has not decided to acquire a weapon. Contrary to Netanyahu's hysterical warnings of a pending existential threat (warnings that go back decades), Iran has been turning its enriched uranium into a form that, while suitable for producing medical isotopes, is unsuitable for making weapons. Twice America's intelligence agencies have concluded that Iran scrapped its suspected nuclear program in 2003, after the U.S. military ousted Iraqi president Saddam Hussein, Moreover, Iran, unlike Israel. has signed the nuclear Non-Proliferation Treaty and is subject to inspections by permanently stationed International Atomic Energy Agency personnel.

The Iranian "threat" is another manufactured crisis.

Pulling us back from an undesirable place

In 2010, anti-Obama rage manifesting itself in the mid-term elections, with beleaguered health care reform set up as bete noire, delivered a message which eerily suggested that an overall American appetite for extremism was very much alive in the country. Tea Party successes in Congressional races, spectacularly so in the House, gave heart to those of the view that "our way or the highway" was okay, that political minds meeting somewhere in the middle was at all costs something to avoid. It is encouraging, even as we await the people's verdict come November, that signs point to perhaps a bit of a pullback from that undesirable place.

The calculus of right-side elements was that 2010 perfectly positioned this year's election as an unmistakable affirmation of a Tea Partyfriendly shift in public sentiment. Even through some primary contests earlier this year on the Republican side, there was evidence of the Tea Party force coming on strong (the Tea Party element's hijacking of the GOP being almost, if not already, a fait accompli). The opened floodgates on campaign financing, courtesy the high court, only seemed to make the playing field more advan-

tageous for this renegade action. A banner example of this was in Indiana, where six-term Republican incumbent in the Senate, Richard Lugar, dared to signal a willingness to compromise with the other side or to vote for Supreme Court nominees put up by the president, or to support other administration measures. For this, Lugar was deemed Tea Party prey and was bested in the primary by the Tea Party's guy. Polls are indicating Republicans may very well lose this seat held by Lugar for decades. If they do, it would be as classic a tale of poetic justice as one could conjure.

Then there's the infamous Todd Akin, another Tea Party stalwart, trying to unseat Democratic Senator Claire McCaskill in Missouri. Supposedly this was going to be a near-impossible seat for McCaskill to retain. That equation was substantially changed with Akin's celebrated hoof-in-mouth episode about "legitimate" rape and the female body's ability to naturally prevent pregnancy – a pathetic, incredulous attempt at rationalization for his uncompromising stand against abortion under any circumstances. Akin, having stubbornly refused to guit the race after such an outrage drew fire from

fellow Republicans, has seen the party machinery eventually resume its support for the most part after, with time, he began to make the race more competitive. But this Missouri Senate seat is one Republicans figured to be winning — a forecast that, again, may wind up upended.

That as an elected representative of the people one gets marked for political extinction for doing the right thing - trying wherever possible to find consensus among legislative decision makers - is searing commentary on what plagues the political landscape. Sadly, the movers and shakers responsible for shaping public service by elected officials into a no-holds-barred blood sport seem not the least bothered that people are the ultimate victims. It becomes obvious that it's a step in the right direction whenever those wedded to ideological rigidity or any other harbinger of governmental paralysis are kept at bay.

In the northeast, there are Senate

seats up for grabs that don't necessarily underscore the hard-right ideological fervor but could possibly be scrambling those Republican prognostication numbers. Republican Scott Brown in Massachusetts is viewed as something of a moderate, but in that contest the heart of the matter is hardly Brown's philosophical bent. There's something almost sacrilegious about the late Ted Kennedy's seat having been originally contested by a Democrat who was evidently a choice that didn't quite measure up. In Elizabeth Warren, Democrats seem to have the kind of challenger to Brown who would likely gain an immediate assent from that Senate Seat's legendary occu-

In Maine, Olympia Snowe, one of that shrinking circle of Republican moderates in the Senate, apparently decided she had had enough of the hard-line mentality that had become Capitol Hill ritual. Her decision to retire has opened the way for her seat to be filled, as is widely expected, by an Independent who would caucus with Democrats. It's left to be seen whether in Connecticut, retiring former Democrat-turned-Independent Senator Joe Lieberman's Senate seat will be taken over by an obvious-

ly determined, one might even say obsessed, Republican. Linda McMahon, who reportedly made bushels of money in wrestling promotion, is making yet another attempt to spend her way into the Senate – a perfect poster girl for what's wrong with the electioneering process. Some of McMahon's campaign advertising seems straight out of the Romney Ryan playbook, which gives pause as to whether her election would be a boost for gridlock, rather than a voice against it. But Connecticut has rejected her moneybags campaign before and could do so again.

Some of us are firmly of the persuasion that when called upon to make a declarative statement for the good of the Republic, the electorate invariably does the responsible thing. In the midst of some folks in high places unabashedly advocating regressive practices and policies of yesteryear; in the midst of the Supreme Court's awful Citizens United decision that looked to derail any chance of a level playing field; in the midst of strident voices for whom a government gripped by stasis is nothing to squawk about; in the midst of all that come the people in 2012, hopefully aspiring to a loftier place.

New York, Oct. 7, 2012 (AP) -- Rosalia Silva came to New York from Mexico with the promise of a good job, her small child in tow. Instead, she was forced into prostitution, trapped in a life of abuse and misery, and she saw no way out. Deeply depressed, she tried to hurt herself and her little boy.

Silva was arrested on assault charges and jailed, and later institutionalized while her son, Francisco, lived with foster parents for nearly five years. But then Silva was accepted into Drew House, a program for mothers that allows them to live with their children in a private apartment instead of prison while they serve out court mandates.

"Here we have our own place, said Silva, 36. "It's a place we can call home, a place we feel safe. It's a place where we can get to know

each other again."

It's apparently the only program like it in the country and has been lauded as a successful, more supportive and cheaper alternative to prison. But space is running out at the house, and prosecutors and program leaders say the effort needs funding in order to grow.

Silva and four other mothers live in the unmarked apartment building in Brooklvn, all sent there for felony offenses. Some involve drugs, others weapons, and still others more violent crime. Eligible women are flagged by Brooklyn prosecutors and defense attorneys. In order to live there, women must be homeless, have minor children, and have pleaded guilty to a felony. The charges are dropped if they complete the

court-ordered requirements, but if they break the law or don't follow through, they get the maximum sentence.

"They want us to succeed," Silva said of the program leaders. "They help us to stay on the path."

The women are largely independent except for a curfew and sign-in requirements. Mothers attend parenting classes, job training and therapy. Their children go to school and receive medical care and tutoring — and are given a sense of stability and

The four-story maroon building was bustling on a recent school day. A handful of small children in yellow and blue uniforms tumbled into the ground floor office, plopped down backpacks and said hello to the house man-

The kids raced to the backvard to play on the swing set near a garden of herbs and vegetables, tossing a basketball, and trying to be gentle with a small tabby cat that's taken up residence. Some of the moms joked nearby.

Rita Zimmer, the founder of Housing Plus Solutions, the nonprofit that runs the program, said it costs \$34,000 annually to house a woman and her children at Drew House. It costs nearly four times as much to incarcerate a woman and put her children in foster care.

Some prisons allow women to keep their infants with them, and some drug treatment programs allow children, but no other program allows women arrested on other felonies to live with their children instead of prison.

The idea came from prosecutors working with Brooklyn District Attorney Charles

Hynes and took nearly a decade to get off the ground, until Zimmer came on board. The house opened in 2008, and was named for Hynes' mother, a victim of domestic violence.

"There's just a lot more to public safety than locking people up," Hynes said.

A study completed by Columbia University in 2011 after a year of observation found residents were thriving. All but one of the seven initial residents completed court mandates, have not been re-arrested, and found stable homes. Their children remained in school. But women who are incarcerated are more often homeless and have higher rates of mental illness and substance abuse than women who get alternative punishment outside prison, according to the study. Their children are more likely to fail academically, suffer mental health problems and wind up in the criminal justice system themselves.

Researchers impressed, said Mary Byrne, who led the study. Their first recommendation was to replicate the model nationwide. and find more buildings in New York City to serve more families, but that's been impossible so far.

Part of the problem is that with an average stay of about a year, space rarely opens up. And women can't be forced to leave their apartments when their mandate ends under the terms of the grant from the U.S. Department of Housing and Urban Development, though most do leave for other housing.

But now, of the five women there, two are done and a third, Olgita Blackwood, is about to finish, and they haven't left. One has staved more than a year late because of immigration issues. Blackwood said she can't afford her own place.



Role of Vincy expats more critical than ever

Vincentian Vaughan Toney, chief executive officer of the Brooklyn-based Friends of Crown Heights Educational Center, told his compatriots at a recent Diaspora conference in New York that the role of the Diaspora in recovery and development at home, has become "ever more critical."

Toney, a former New York City Council candidate, noted that his homeland is not alone in seeking to engage the Diaspora more actively in creating opportunities for development and pointed to countries with large populations abroad such as China, India, Mexico, Nigeria, Egypt and the Philippines that are devising specific financial instruments, like Diaspora Bonds, "as a way of

"Increasingly, expatriates have become an indispensable source of economic support for their countries of origin – most commonly through the financial remittances they send to family, friends and philanthropic organizations back home," Toney explained in a paper submitted to the conference held at Kingdom Life Ministries International in Crown Heights, Brooklyn and read by Sherrill-Ann Mason, a member of the St. Vincent and the Grenadines Diaspora Committee of New York.

Toney says remittances from abroad represent a "critical lifeline for the poor," and the steady stream of foreign currency also helps improve St. Vincent and the Grenadines' credit worthiness for external borrowing."

would see to it that a drug plane which had crashed recently in Suriname's hinterland, carrying 400 kilograms of cocaine, would be safe and that all "bouta" wanted in return was 200 kilograms of the drug.

But police said there were no reports of an aircraft crashing in the interior.

"The Netherlands is again trying to blacken Mr. Bouterse's and Suriname's reputation with a smear campaign, because they just cannot accept that Suriname is making economic advancement without their help," said Foreign Minister Winston Lackin.

Bouterse, who led a military coup in February 1980, was convicted in absentia in 1999 and given an 11-year sentence. He appealed the conviction but the Appellate Court confirmed the sentence in October 2001.

Bouterse has always maintained he is innocent, though saying the sentence was politically motivated by the Netherlands.

Following is electoral victory in 2010, the Netherlands immediately stopped development aid to Suriname, adding that Bouterse would only be welcomed to the European country if he is prepared to begin his jail term.

Suriname

Suriname's Justice Minister Edward Belfort has questioned a recent report out of Jamaica that pointed to an increase in drug trafficking out of Suriname.

Recently Jamaica's Commissioner of Customs, Major Richard Reece said there has

been an increase in the number of persons from Suriname, Guyana and Trinidad and Tobago who "ingest drugs, or have drugs in their luggage."

"I don't know if that information is true. Which drug mule would travel from Suriname to Jamaica," said the minister, noting

that there is no direct Suriname-Jamaica flight, which makes it quite a hassle to travel to that island.

"An unlikely destination for drug couriers," said Belfort.

He also said authorities at Johan Adolf Pengel (JAP) Airport have stepped up security.

Belfort said that drug mules often use JAP Airport, but these are usually bound for Europe as there are several direct flights weekly to the Netherlands and Suriname.

Trinidad

Fired Justice Minister Herbert Volney said he will operate in Parliament as a United National Congress (UNC) MP, independent of

instructions from the People's Partnership Government whip.

He said his constituents wanted him to function as an independent.

Volney said his constituents are very hurt of his recent dismissal and they want him to speak freely in the House as a UNC MP but independent of the PP whip.

Volney was fired by Prime Minister Kamla Persad-Bissessar for allegedly misleading Parliament over the proclamation of Section 34 of the Administration of Justice (Indictable Proceedings) Act, which could have caused two financiers of the UNC and other persons accused in fraud and bid-rigging in the TT\$1.6 billion Piarco International to apply to the High Court to have their cases dismissed because more than 10 years had passed. Since then, the section of the Act has been repealed

Volney a former High Court judge resigned from the bench and joined the UNC to fight the May 24, 2010 general election. He won the St Joseph seat and was one of the PP's 29 MPs.

Film launches salute to Jamaican heroes

The Consulate General of Jamaica in New York inaugurates a film series to celebrate the country's 50th anniversary of Independence and commemorate the spirit of sacrifice and leadership of the nation's heroes. "Time of Fury – The 1865 Morant Bay Rebellion' chronicles arguably the bloodiest repression of dissent by the British colonial authorities in Jamaica during the post-emancipation era. The feature film, from the archives of the now defunct Jamaica Broadcasting Corporation, and directed by veteran broadcaster, Cary Robinson, producer of the 'Hill & Gully' TV Series, will be screened at the Bronx Bethany Church of the Nazarene, 971 East 227th St., on Tuesday, Oct. 23, 2012, starting at 6:30

The dramatic epic "Time of Fury – The 1865 Morant Bay Rebellion" uses the medium of film to place in context the lives, struggles, and, personal sacrifices, of

Paul Bogle, George William Gordon and their contemporaries, and response by the government of the day. As reported on Nov. 11, 1865, in less than a month of the island wide conflagration, the New York Times wrote, "It is calculated that about 1,800 of the insurrectionists have been killed in the different engagements that took place with the troops and volunteers, and up to the above-named date, 125 had suffered the extreme penalty of the law.'

Jamaica, this week, remembers its national heroes and the indelible mark they made in fashioning the nation's history, strength of character and unique identity by challenging the injustices of colonialism, racism, and poverty.

Established in 1969, as the highest award to be conferred on any citizen who has "rendered the most distinguished service to the country", the Order of National Hero has been conferred on one woman and six men: Nanny, outstanding military leader during the First Maroon War; Sam Sharpe, for leadership in the resistance against slavery during the rebellion of 1831: Paul Bogle and George Gordon, for their roles against social injustices in post-emancipation, colonial Jamaica during the rebellion of 1865; Marcus Garvey for his commitment to social and political betterment on the country's racial majority; Alexander Bustamante and Norman Manley, as architects of political independence.

George William Gordon was born in 1820 to an enslaved black mother and a white plantation owner father. He was a shopkeeper, produce dealer, Baptist preacher and landowner. Gordon entered politics as an advocate for the poverty-stricken peasants in the largely rural parish of St. Thomas-in-the-East which he represented in House of Assembly. Additionally, his bitter criticism of Lt. Gov. Edward Evre alienated him form much of the plantocracy.


There are conflicting reports if Paul Bogle was born free in 1820, 16 years before the end of slavery in the British Empire. However, by 1865 he was a Baptist deacon of significant reputation and one of handful of black landowners on the island with significant holdings. His 500 acres qualified him to vote in local elections and was a political adherent of Assembly member, George William Gordon.

Responding to the worsening social and economic situations in the decades following emancipation Paul Bogle led a delegation to take their complaints to the governor. The audience was denied. On Oct. 11, 1865, Bogle and about 300 men marched into Morant Bay and raided the police station. They then marched to the Court House where the local authorities were meeting. The resulting confrontation resulted in the governor's representative and fifteen vestrymen being killed, 51 prisoners freed, and the courthouse razed. After the imposition of martial law, George William Gordon was seized from his home in southern parish of St. Andrew, convicted of treason and hanged on Oct. 23. Bogle was eventually captured by the Portland Maroons, was court marshaled and executed, along

with his brother Moses, on

Oct. 24.

Rebellion," on the 147 anniversary of the revolt, will be held under the patronage of Consul General of Jamaica in New York, Hon. Herman LaMont and hosted by Rev. Chronic cough or cold could be COPD

You may have heard the term COPD before -- either in a radio or television commercial. COPD, short for chronic obstructive pulmonary disease, is a serious lung disease that over time makes it hard to breathe. Also known as emphysema or chronic bronchitis, it is the third leading cause of death in the United States, but as many as 12 million Americans don't even know they have it.

Unfortunately, symptoms are often shrugged off as a normal part of getting older or a consequence of being out of shape. And during cold and flu season, COPD symptoms can also be mistaken for that cold or cough that just won't go away. But COPD can be a dangerous health hazard. If left untreated, it can have debilitating effects on everyday activities. Affecting one in five adults in the U.S. over the age of 45 and an estimated 24 million Americans, as many as half remain undiagnosed.

In people who have COPD, the airway tubes that carry air in and out of your lungs are partially blocked, making it hard to breathe. The disease develops slowly and usually worsens over time. So don't ignore the first signs of COPD, which include a chronic cough, hacking, wheezing and shortness of breath.

COPD occurs most often in people age 40 and over with a history of smoking, affecting both current and former smokers. However, as many as one out of six people with COPD have never smoked. Other risk factors include long-term exposure to second hand smoke, certain chemicals, and dust or fumes in the workplace. In some people, COPD can be caused by a genetic condition known as alpha-1 antitrypsin, or AAT, deficiency.

"While there is no cure for COPD -- early diagnosis and treatment can help people with the disease improve their symptoms and get back to the

things they love doing," said James P. Kiley, PhD. director, Division of Lung Diseases, at the National Heart, Lung, and Blood Institute, part of the National Institutes of Health. "As we head into the colder months, take the first step to breathing better. Learn more about COPD and schedule an appointment to talk with your doctor or health care provider about your lungs."

COPD can usually be diagnosed by a doctor or health care provider during a regular office visit with a simple, non-invasive breathing test called spirometry. If you or a loved one experiences any of the symptoms of COPD, take some time to learn more about it. Visit http://COPD.nhlbi.nih. gov for more information.

With proper diagnosis and treatment, people with COPD can live longer and improve their quality of life.

Best-seller 'Marley & Me' slated for reissue

first books to expose the private life of Robert "Bob" Marlev and the women he was associated will be re-released next year.

Penned by Donald Delroy Taylor, Marley's best-known manager, the controversial tell-all will be gussied up with brand new chapters and on the shelves in time for the king of reggae's 68th birthday on Feb. 6.

First published under the cover "So Much Things To Say" the title was changed to reflect Taylor's unique relationship with the reggae legend.

Often compared to boxing promoter Don King or Elvis Presley's manager Col. Tom Parker, the charismatic, sharp-dresser was a selfmade manager.

Allegedly Taylor made his way into the big-time when singer Lloyd Price visited Jamaica.

According to the book, Taylor maneuvered his way to see the star offering to assist him with his stage outfit.



Taylor revealed that Price impressed with his meticulous care of the clothing suggested that Taylor set up a valet service for other visiting performers which included Fats Domino, Ben E. King and Jackie Wilson.

As the biography reads, Wilson was very impressed by Taylor's work and before leaving the island bought him a plane ticket to Miami in 1960.

Taylor lived in the south for a time but after meeting Jerry Butler made his way to New York and quickly landed a gig with Little Anthony and the Imperials.

Taylor travelled with the hit-makers and eventually became their manager.

Marley allegedly returned to Jamaica soon after Eric Clapton's version of Marley's "I Shot the Sheriff" hit

the charts. Simultaneously. Marley his Wailers left their manager Danny Sims. Taylor reportedly travelled to Kingston and without introduction offered his services to the Rastafarian. The pair shook hands and formed a union to go on the road to promote the "Natty Dread" album.

After a successful tour of Canada and the United States, Taylor renegotiated Marley's deal with Island Records president Chris Blackwell. That 1975 deal gave Marley his biggest payday with a contract for \$1 million.

Taylor is also credited with setting up a company in the British Virgin Island of Tortola in order to avoid UK and U.S. taxes. The business-savvy manager also extricated Marley from his publishing deal with Danny Sims.

Taylor managed Marley for five years.

He was among four persons shot at 56 Hope Road, Marley's home in Kingston in 1976. Newspaper reports at the time stated that Taylor saved Marley's life by standing in front of the reggae legend.

Taylor was critically injured and was immediately airlifted to Miami for sur-

A bullet was removed from his spine.

Marley and his wife Rita were also shot and injured in the incident.

Throughout the years, Taylor worked with Burning Spear, Gregory Isaacs, Prince, Soul II Soul, Mickey Howard, and producers Kenneth "Baby Face" Edmonds and L.A. Reid.

In 1979, Taylor bought Jimmy Cliff's publishing rights for \$40,000. He is reputed to be the brain behind rebuilding Cliff's career, which reportedly, had been on a downward spiral

since the early seventies.

Marley and Taylor parted ways after a trip to Gabon, Africa and dispute about embezzlement implicated the manager.

In 1980, Marley wrote "Bad Card" as a thinly-veiled attack on Taylor for the album "Uprising."

One year later Marley died of cancer in Miami.

Taylor reportedly took care of the funeral arrangements in Jamaica.

However, it was widely reported that Marley's death left a deep impression on him and he began using cocaine.

Allegedly Taylor tried to sort out the singer's estate but, in the absence of a will, the dispute between various parties --Rita Marley, Danny Sims, Cedella Booker - Marley's mother - Wailers - numerous baby mothers and numerous individuals seemed interminable.

Taylor said Rita Marley was against her husband's 'outside' children benefiting from his legacy, which was reportedly valued at \$30 million.

A court decision in 1989 ended the public feuding when Chris Blackwell bought the publishing rights to Marley's songs for \$12 million.

In 1983, Taylor convinced EMI America to sign Marlev's off-springs to a recording contract. Ziggy Marley & the Melody Makers headlined Marley's eldest son David and featured Stephen, Cedella and Sharon Marley.

Taylor died in Miami, December 1999 following surgery for a heart condition.

According to Mike Henry, head of LMH Publishing, the second edition will be more extensive than the first with additional chapters focusing on developments surrounding the Marley estate in the last decade.

"When the book came out, we were threatened with a lot of lawsuits that never materialized," Henry said. "Just read the number of Marley books that followed and you will see Don has been exonerated."





Teacher moonlights to save school's music program

Scott Voss (Kevin James) is a bored biology teacher at mythical Wilkinson High in Massachusetts, a cash-strapped school suffering from low morale. The apathetic slacker is part of the problem, as he sets a horrible example for his students, between stealing candy from vending machines and always arriving late for class.

During recess, the bored, 42-year-old bachelor makes a habit of flirting with the beautiful school nurse, Bella (Salma Hayek). However, she just as routinely rebuffs

his advances with gentle reminders of how often she's rejected each of his requests for a date.

The plot thickens the day Principal Betcher (Gregg German) assembles the faculty in the auditorium to announce his latest budgetary cutbacks. Those money-saving measures not only include plans to eliminate afterschool activities like the debate club and field trips but even the entire music program.

That means Scott's colleague Marty Streb (Henry Winkler) will be callously laid-off right before earning tenure. And to add insult to injury, the dedicated music teacher's firing comes at a time when his wife (Nikki Tyler-Flynn) is pregnant.

This dire state of affairs inspires Scott to prevail upon the principal to preserve his pal's position. But Betcher says he simply doesn't have the \$48,000 to pay Marty.

Therefore, Scott, who hasn't wrestled competitively since col-

lege, decides to raise the cash by moonlighting in the ring as a Mixed Martial Arts fighter. With the help of Marty and a retired kickboxing champ (Bas Rutten), he proceeds to whip himself into the best shape a middle-aged couch potato might hope for.

So unfolds "Here Comes the Boom," a sweet-natured, overcoming-the-odds sports saga combining familiar elements of Rocky (1976) and Nacho Libre (2006). Directed by Frank Coraci (The Waterboy), the star vehicle showcases Kevin James' comic genius at his best, whether he's doing pratfalls in a mask and ill-fitting stretchy pants or futilely wooing the woman of his dreams.

The paint-by-numbers plot inexorably builds to a UFC-sanctioned showdown between Scott and an intimidating adversary (Krzysztof Soszynski) for a purse conveniently matching Marty's salary. Wouldn't it be nice if Wilkinson's student body and school band were on hand in the Vegas arena to cheer for their altruistic teach, and better yet if Bella had a change of heart and also arrived ringside for a kiss at the moment of truth?

"Here Comes the Boom?" How about, here comes a pat Hollywood tale of redemption where a perennial loser transforms himself into a beloved hero who wins the cage match, saves his best friend's job, and gets the gorgeous girl!

their future prospects.

"He tells me about my stride, and about mental focus," the student athlete said. "I could picture in my head that I could do it (run)."

Hogarth, who came to New York when he was about 14-15 years of age, attended high school in Brooklyn.

Last year as a Uniondale junior, he ran in about 17 minutes in this same race of the Manhattan College high school meet. He lowered his time by about two minutes.

"I improved myself by training and lifting weights," he said. "I strengthened every part of my body. I've trained as hard as I can, pushed through every time and didn't stop."

He felt that it was exciting to run with and against so many athletes and schools. He has to push through and focus every time on the course or on the track.

Jamaica, U.S.A. advance to CONCACAF finals

host Antigua/Barbuda, the Reggae Boyz hoped to win by at least three goals, but it meant a Guatemala loss by at least two goals. A draw between the USA and Guatemala in Kansas City, Kansas on the same night meant that Jamaica's World Cup hopes would be dashed.

After Demar Phillips and Nyron Nosworthy gave Jamaica a 2-0 halftime lead off corner kicks and put it even on goal difference with Guatemala, which was losing 2-1 in the USA at the moment; it now seemed that the Reggae Boyz were well on their way to that goal difference edge to advance; Jamaica was even in goal difference with Guatemala, but Quinton Griffith's 61st minute goal for the visitors made it only a 2-1 margin. Richards became the savior

when advancing looked bleak again for Jamaica as the goal difference was only a plusone.

Richards stepped up his game in the last 12 minutes of play, first by latching onto a Rodolph Austin cross to registered Jamaica's third goal in the 78th minute; 10 minutes later, Richards registered the insurance goal that had the Jamaica National Stadium in an uproar. The news of the USA-Guatemala result had been known iust before Jamaica's game ended, but Richards' goals gave Jamaica the needed plus-three goal difference. Jamaica is the only Caribbean team in the six-team final round of qualifying; it qualified for the World Cup in 1998.

In the USA-Guatemala contest in front of a sellout crowd of 16, 947, Clint Dempsey scored twice and

Captain Carlos Bocanegra once to eliminate Guatemala. The visitors forged ahead through Carlos Ruiz's fifthminute goal after a lapse in the U.S. defense, but the Americans roared back with goals from Bocanegra (10th), off a Dempsey assist, and Dempsey (18th), from an Eddie Johnson cross, to forge ahead. Dempsey's final tally, off a Michael Bradley pass, came in the 36th minute and ended Guatemala's campaign. Bocanegra's 14th international goal now makes him the all-time leading scorer among U.S. defenders.

In Group B, hosts Mexico (18 pts.) won its sixth straight game with a 2-0 win over El Salvador to win the group and advance to the final round; goals by Oribe Peralta and Javier Hernández paced Mexico. Hosts Costa Rica (10 pts.) registered a

7-0 victory over Guyana and finished second in the group to advance. Costa Rica got goal from Randall Brenes (2), Alvaro Saborio (2), Cristian Gamboa, Cristian Bolanos and Celso Borges. El Salvador (5 pts.) and Guyana (1 pt.) have been eliminated.

Honduras (11 pts.) pummeled Canada (10 pts.) into an 8-1 defeat to win Group C and end Canada's qualifying campaign. Panama and Cuba played to a 1-1 tie, which sent Panama (11 pts.) into the final round as the second place team. Hosts Honduras got goals from Jerry Bengtson (3), Carlo Costly (3), and Mario Martinez (2) to win the group by goal difference. Cuba (1 pt.) was also eliminated.

Guyana (6 pts.) qualified from Group Five in the 2012 Digicel Caribbean Championship qualifying in St. Kitts and Nevis. The host and Anguilla were eliminated. Trinidad and Tobago won it three games, beating French Guyana (4-1), St. Kits and Nevis (1-0) and Anguilla (10-0). French Guyana topped Anguilla (4-1) and knocked off St. Kitts and Nevis (3-0) after losing to Trinidad and Tobago. St. Kitts/Nevis' only win came against Anguilla (2-0).

Windies Test players need special preparation

Admist the big win against Sri Lanka in the ICC World Twenty20, the West Indies players will have to improve their game to the "A" level in order to gradually reach the top of the ICC rankings. Much more concentration and skills will have to be exhibited on the field and the selectors will have the first responsibility of choosing a balanced squad.

Head Coach Ottis Gibson has to identify areas of weaknesses and have those guickly modified to face the huge challenges ahead. Some improvements are needed regarding field placements, which are the responsibility of the captain and players have to hold on to catches. Settling down and building partnerships must be priorities among batsmen in the Test matches.



Any number starting with 900, 540, 595 or 871 charges a fee beyond a local call. In some instances, ads initially advertise calls to a local number, but then direct starting with one of the paid exchanges. "Consu-mers must also question legitimacy of vague classifieds because too could be a scam. Before responding to an ad, consumers should verify the source of all information & always be wary about sending money or signing a contract with an unknown party.




