Rising sea levels destroy Carib beaches

The World Bank says due to rising sea levels and recurring storms, the beaches in most Caribbean nations have started to disappear.

In a new report, the Wash-

ington-based financial institution said in some areas of St. Vincent and the Grenadines, for instance, an estimated 18-30 meters of beach have been lost over the last nine years. "The highly vulnerable coastal strand and adjacent towns are fighting against increased flood risk from rainfall and storm surge," said the bank, noting that the issue **Continued on Page 6**

The Organization of American States (OAS) says it has concluded a two-day event in Kingston with the government of Jamaica during which a draft of Jamaica's National Cyber Security Strategy was presented and discussed publicly for the first time.

The OAS said on Tuesday that its Cyber Security Program at the Inter-American Committee against Terrorism (CICTE), in collaboration with the Jamaican Ministry of Science, Technology, Energy and Mining (MSTEM), held on Monday a validation workshop for the development and adoption of the strategy.

This workshop was followed by a technical training conducted with the support of experts from Microsoft

under the framework of a cooperative agreement established with the OAS early this year, the OAS said.

It said the workshops here was part of a larger cyber security initiative that is financed by the governments of Canada, the United Kingdom and the United States.

On the first day of the event, the OAS and its counterparts in the Jamaican government presented for the first time the National Strategy, the statement said.

"Although it is still pending official approval and adoption by the government of Jamaica, stakeholders in attendance had the chance to ask questions and make recommendations to the strategy and its adoption

Adams honors NY's 'finest' who saved infant

Brooklyn Borough President Eric L. Adams has paid tribute to Sgt. Michael Dario and Officer Elias Khan of the New York City Police Department's 62nd Precinct by proclaiming them September's "Heroes of the Month" for saving the life of a choking infant in Bensonhurst on Aug. 24.

William Taylor, commanding officer of the 62nd Precinct, as well as the mother of the choking infant, Christine Maresca, praised the officers for quickly responding to the emergency and for performing CPR to revive the infant until EMS responders arrived to the scene.

"This event is a way to Adams, joined by Cpt. acknowledge Brooklyn

heroes and everyday Brooklynites who do something special that usually goes under the radar of the daily news cycle," said Adams at a ceremony at Brooklyn Borough Hall, describing the significance of the "Heroes of the Month" and the valiant acts of the officers receiving the award.

"As a former police officer, I can't tell you how many

times that calls of this magnitude do not result in such a fortunate outcome as the call answered by Sgt. Dario and Officer Khan," he added. "So we cannot thank them enough for saving the life of a choking infant."

Adams also used the event to highlight the importance of CPR certification and training by the

St. Lucians to hold town hall meeting

St. Lucian nationals in the tri-state area are expected to attend a town hall meeting organised by the Consulate General of St. Lucia in New York at 7:00 p.m on Thursday, Sept. 25, 2014 at the Saint Lucia House, located at 438 E 49th St., between Church and Snyder avenues

The town hall meeting will address Deferred Action on Childhood Arrivals (DACA), the impact of the Foreign Account Tax Compliance Act (FATCA), and the NYC Municipal ID Program to be launched later this year.

DACA is a policy directive that provides, among other benefits, temporary deportation relief and work authorization to qualifying immigrant youth and young adults. Sam Solomon, a policy analyst at the NYC Mayor's Office of Immigrant Affairs (MOIA) and also a

representative of the NYC Department of Youth and Community Development (DYCD) will be presenting information regarding DACA and its immediate and long-term benefits.

FATCA is a set of provisions designed to stop U.S. Continued on Page 33

Caribbean Sharon Clarke's a shoo-in for gavel

The New York democratic primary is usually a keenly-watched five-borough contest of political possibilities but this year, Brooklyn and Queens took the lion-share of attention with a former comptroller vying to become the first Asian-American state representative; several indicted politicians contesting seats and a Caribbean woman making a bid for a judgeship within New York City's Civil Court.

In central Brooklyn Guyana-born Sharon Clarke campaigned to become a member of the civil court judiciary.

She won handily despite the fact she was four times challenged in the courts; did not receive endorsements from the borough president, mayor, governor, congresswoman or any of the so-called power, party reps.

On Labor Day she looked a winner walking along Eastern Parkway alongside a diverse Caribbean support team of campaigners.

State Senator Kevin Parker and Assemblyman Nick Perry said she was the best candidate to represent District Six.

"I have no doubt that Sharon Clarke is the best Democrat in the race," Assemblyman Perry said.

wholeheartedly "I endorse her candidacy and urge everyone to vote for her for Civil Court judge," Parker said.

The two Caribbean politicians stepped up to support the Bourne-born daughter to Barbadian and Guvanese parents and wife of a Jamaican named Clarke. And after the ballots were calculated Clarke emerged victorious by a margin of nearly 54 percent over her rival.

The mother of two sons, lawyer and human rights advocate will not have to defend her position in November because she is

unchallenged to rap the gavel.

Despite his former citywide position as comptroller and a fourth place showing in the mayoral elections last year, 47-year-old John Liu did not win a seat in the state senate. He lost by a narrow margin of 52 to 47 percent to the 62-yearold incumbent Senator Tony Avella dashing hopes of becoming the first Asian-American to represent New York State.

Former Brooklyn City Councilman Charles Barron repeated a feat his wife Inez accomplished five years ago by beating Chris Banks for the East New York seat in the 60th Assembly District. The outspoken politician claimed 64 percent of the votes and will occupy the seat his wife did in Albany when she held the position before winning the same city councilmanic seat Charles occupied.

Barron feels assured that in November he will easily win back the position which seems to be emerging a Barron family seat.

Joining Barron in Albany, former City Councilman Leroy Comrie won a landslide victory in Queens' District 14 over Senator Malcolm A. Smith. Comrie who was supported by Mayor Bill deBlasio whipped the senator charged with trying to bribe his way onto the Republican ballot for the 2013 mayoral race.

In District 19, John Sampson easily avenged his reputation by beating the mayor's choice Dell Smitherman for a seat in Albany. Despite charges of embezzlement Sampson won by taking 56 percent of the votes

Sampson is under federal indictment on charges that he embezzled more than \$400,000 from the sale of foreclosed homes. He was among a four-way challenge that may have split votes in his favor.

Antigua

Antigua Police say they have recaptured a prisoner who had been serving a 40-year jail sentence for murder after four years on the run.

They said Steven Alphonse had escaped on Jan. 27, 2014 when prisoners were engaged from removing coal from a pit.

He had been sentenced to death in 1993 for the brutal murder of a young woman, but appealed the case in 2007 and the sentence was commuted to 40 years in jail.

Alphonse escaped lawful custody on two previous occasions, mak-

ing his way to the neighboring French island of Guadeloupe during one of these escapes.

Prior to his arrest, police described Alphonse as "dangerous." He will appear in court on charges related to his escape from prison.

Bahamas

Cable & Wireless plans to invest more than US\$170 million in the Bahamas Telecommunications Company (BTC) over the next three vears to deliver the fastest mobile network in the Caribbean.

Of the US\$170 million that will be invested in upgrade networks and new services, some US\$60 million will go towards additional cell sites and more powerful radio signals across the Bahamas.

On Aug. 29, Cable and Wireless Communication (CWC) and the Bahamas government launched the BTC Foundation — a government-

managed national social initiative of the BTC. The founda-

tion, a charitable

trust, which focuses on philanthropic causes, was established as part of a recent agreement between the Bahamas government and CWC to allocate two percent of the previously held CWC shares for Bahamas citizens.

CWC's investment in the Bahamas is part of Cable and Wireless' plan to invest US\$1 billion in multiple Caribbean territories to revolutionize ICT delivery in the region over the next three years.

Cayman Islands

The United States Department of Justice (DOJ) says a Caribbeanbased investment advisor has been jailed for 30 months for using off-

shore accounts in the Cayman Islands to launder funds.

The DOJ said Joshua Vandyk conspired to launder monetary instruments.

Vandyk, a U.S. citizen and Eric St-Cyr and Patrick Poulin, Canadian citizens were indicted by a grand jury in the U.S. District Court for the Eastern District of Virginia on March 6.

The indictment was unsealed on March 12 after the defendants were arrested in

Miami. According to the plea agreements and statements of facts,

Vandyk, St-Cyr and Poulin conspired to conceal and disguise the nature, location, source of ownership and control of property believed to be the proceeds of bank fraud, specifically US\$2 million.

Vandyk and St-Cyr lived in the Cayman Islands and worked for an investment firm based there.

St-Cvr was the founder and head of the investment firm, whose clientele included numerous U.S. citizens

Poulin, an attorney at law firm based in Turks and Caicos, worked and resided in Canada, as well as the Turks and Caicos, court documents say.

Vandyk and St-Cyr solicited U.S. citizens to use their services to hide assets from the U.S. government, including the IRS.

Guyana

Guvana President Donald Ramotar has expressed optimism about the country's economic growth based on the 3.2 percent growth rate at the half-year mark.

Speaking at a ceremony recently to mark Brazil's 192nd anniversary of Independence, he revealed that another large gold mine will be

established in the future and this is an indication that investments are on a sound foot-

According to the president, while several infrastructural works have slowed due to a lack of guarry material, he has issued instructions for the granting of more quarry licenses that will in turn lead to increased stone production and the construction of roads.

Concerning the sugar industry, he said there should be better results in the next quarter, but despite the challenge of a slight price decrease, the industry is on the road to recovery.

Haiti

The head of the police service in Haiti has appeared before an investigating judge to answer why law enforcement officials have not arrested former president Jean Bertrand Aristide, who is being investigated on corruption charges.

Police Chief Godson Orelus appeared before Judge Lamarre Belizaire who is conducting the inquiry into the allegations against

the judge wanted to know about," said Orelus, who confirmed the

police were in possession of several arrest warrants. Aristide and several of his former colleagues have been accused of embezzling hundreds of millions of

dollars from the state through his

organization, Aristide for Democracv Foundation and other organizations during the period 2001-04.

Aristide, a former Roman Catholic priest, and his colleagues, including Mirlande Liberus, Yvon Neptune, Jan Nesty Lucian and Gustave Faubert, have also been banned from leaving the country.

Jamaica

Jamaica signed three loans totaling US\$105 million with the World Bank to support several government projects.

Finance and Planning Minister Dr. Peter Phillips, who recently led a four-member delegation to the United States, signed the accord, while World Bank Country Director, Sophia Sirtane, signed for the bank.

The loans are in support of three government projects — the Foundation for Competitiveness and

Growth, which will receive US\$50 million; the Youth Employment in **Digital Animation** Industry, US\$20



million and the Strategic Public Sector Transformation Project, US\$35 million.

Dr. Phillips said the loans represent an important cooperation between the government and the World Bank and is aimed at advancing the prospects for growth as the country goes through a strenuous economic reform program that forms part of the agreement with the International Monetary Fund (IMF).

St. Lucia

The St. Lucia Tourist Board (SLTB) says there has been an increase in visitor arrivals for the island in the first seven months of the year.

Tourist officials announced that total stay over arrivals by air and ferry at the end of July 2014, have surpassed all numbers previously recorded in the

island's history. 208,117, At visitor arrivals are seven percent higher than the



same period last year — a difference of more than 13,000 arrivals.

The SLRB says to further emphasize the significance of this year's performance, increases were recorded every month so far, with July

and implementation processes," the OAS said.

In addition, it said experts from the Commonwealth Secretariat Cyber Crime Initiative, the UKTI Defense and Security Organization, Microsoft, and the Oxford University Cyber Security Centre provided guidance and support on the implementation phases of national cyber security strategies.

The draft Strategy outlines several areas of focus for the country, including technical capacity building, awareness raising, cyber incident response and legislative considerations, the OAS said.

It also speaks to the development of a detailed implementation plan by the National Cyber Security Task Force.

The OAS said this workshop continues work begun by OAS/ CICTE in March 2014 on Jamaica's Cyber Security Strategy.

In the previous event, which convened stakeholders from more than 20 public and private entities in Jamaica, the OAS presented on the importance of cyber strategies, showcased a selection of strategies from around the world, and helped Jamaica define the pillars that would form the basis of its strategy.

"The success for implementing any strategy has a direct link with the availability of human and financial resources."

The OAS said its methodology on developing national cyber security strategies has been recognized and supported by the Governments of Canada, the United States and the United Kingdom as "particularly effective in helping member states enact comprehensive cyber policy."

Following the September mission, the OAS said the strategy will undergo a final review process internal to the Government of Jamaica.

After all relevant ministries and departments have had a chance to comment and provide feedback, it will pass through a formal adoption process, ending with Cabinet approval, the OAS said.

"OAS is wholeheartedly supporting the development of the National Cyber Security Strategy in Jamaica, and we hope that this effort could be adopted at the highest levels of the State soon", said OAS Secretary General Jose Miguel Insulza.

Insulza said once the Strategy is adopted, "the real challenge will be the implementation process, where support from relevant national and international stakeholders will be required."

He said the OAS is committed to continue supporting Jamaica's efforts on cyber security issues, inviting donor countries and the international community to increase their support to the OAS Program and to the government of Jamaica for protecting its cyberspace.

"The success for implementing any strategy has a direct link with the availability of human and financial resources," said MSTEM Minister of State Julian Robinson.

"Jamaica would not have been able to get this far in the process without the assistance of our partners," he added. "The commitment of OAS-CICTE to this process has not just been for the drafting of the Strategy but also to the implementation.

"We recognize that skills to combat cyber crime are limited, but we are pleased to have accessibility to capacity building which is being offered by our partners," Robinson continued.

To date, the OAS said the program has worked closely with 19 member-states to adopt and improve their national Computer Security Incident Response Teams (CSIRTs).

In addition to its recent work with Jamaica, the OAS said it has helped Colombia, Panama, and Trinidad and Tobago to draft and adopt their national cyber security strategies.

It said almost 40 countries around the world have already adopted national cyber security strategies, five of which are in the OAS region.

Besides Jamaica and the other countries mentioned earlier, the OAS said it has initiated the national strategy development process with Dominica, the Bahamas and Peru.

challenges faced by small islands around the world was at the center of the just-concluded Third Small Island Developing States (SIDS) conference in Samona.

The bank said the theme of the conference was sustainable development in view of these states unique and particular vulnerabilities.


The World Bank said beaches are not the only concern, stating that Caribbean ports are also at risk from rising sea levels.

"In island states, ports are the economic heart of the country, typically the capital and the island center of commerce," said the bank, adding that airports are also affected.

To improve the Caribbean's ability to resist and adapt to the effects of climate change, the World Bank has made some recommendations.

Among the recommendations are the implementation of a preventive system to establish an economic recovery and diversification plan following a disaster, as well as increased investment in scientific data collection and flood controls, land planning and watershed management.

The poor and vulnerable are the most affected by a global seas level rise, the bank noted.

Resolution on Caribbean debt restructuring

King A new United Nations General Assembly resolution on debt restructuring that will set up a multilateral legal framework for Caribbean and other debtor countries to emerge from debt safely has been welcomed by the U.N. rights expert on the issue as a way forward to "fill the current legal voice and reduce uncertainty."

"A multilateral legal framework would help to fill the current legal void and reduce uncertainty related to debt restructuring processes," said Juan Pablo Bohoslavsky, an independent expert charged by the U.N. Human Rights Council to monitor the effects of foreign debt on the enjoyment of all human rights, particularly economic, social and cultural rights.

In a statement from the U.N. Human Rights Office

(OHCHR) on Wednesday, Bohoslavsky highlighted in particular the disruptive impact of so-called "vulture funds", which buy unserviceable debt at a huge discount.

According to the World Bank, vulture funds are buying commercial debts knowing that multilateral debt relief has put the governments of heavily indebted poor countries in a better position to pay, and hoping that they will, therefore, be persuaded to settle with them.

They frequently engage in litigation in the courts of rich nations to obtain judgments against the debtor and then attempt to attach the government's assets abroad, the U.N. said.

"Vulture fund litigation not only prevents indebted countries from using resources freed up by debt relief for social and economic rights, it also complicates

debt restructuring processes," Bohoslavsky said.

In a letter to the Group of 77 ("G-77") developing countries sent before the U.N. General Assembly discussion on the resolution, he stressed that "financial markets need more prudence, not less."

"Financial business enterprises, including hedge funds or so-called 'vulture funds' have to respect human rights and should exercise human rights due diligence to identify, prevent, mitigate and account for adverse human rights impacts as outlined by the Guiding Principles on Business and Human Rights," Bohoslavsky said.

Bohoslavsky was appointed as Independent Expert on the effects of foreign debt and human rights by the United Nations Human Rights Council on May 8, 2014.

Walk in their shoes

I'm a CEO with a GED, and I have walked in the shoes of a minimum wage worker. I know from experience that it's a tougher road today.

The minimum wage buys fewer necessities now than it did when I needed it to survive. And as a successful capitalist, it pains me to see that the American Dream, which so inspired me, is increasingly out of reach.

As a young boy, I knew all too well the despair of empty pockets. I learned to be resourceful, making money by selling my most precious possessions. The sound of change in my pocket gave me hope.

From ages 15 to 18, I was homeless. I did what I had to do to survive and put money in my pocket. I worked under the table as a day laborer, toiled in pool halls, bussed tables and worked a variety of minimum-wage jobs.

I saw the minimum wage as a temporary entry wage. I believed that if I worked hard and played by the rules, I'd eventually get ahead. The scales weren't as tipped against workers as they are today.

It was a time in America when a homeless kid with a GED could still find opportunities and a path to living the American Dream. It was a time in America, when millions were rising into the middle class, not falling out of it.

My path to living the American Dream has been through a 37-year career with American Income Life. I started as a life insurance agent and worked my way up to my current position as CEO.

Our company culture remains one of creating shared prosperity and providing opportunity unlimited. We are proof that businesses can profit and grow by paying a fair wage and providing a pathway to the American Dream for employees.

For me and so many others of my generation, the minimum wage was just the first of many rungs on a career ladder. But too many workers today find themselves running in place on a treadmill -- stuck in low-wage jobs without real opportunity.

Today's federal minimum wage has less buying power than it did when I was a homeless teen in the 1960s.

The minimum wage hit its high point in value around the time I most needed it. At its peak in 1968, the minimum wage was worth \$10.96, adjusted for inflation. That's way more than today's federal minimum wage -- stuck at \$7.25 since 2009.

The \$3.71 difference between the minimum wage in 1968 and today isn't pocket change. It adds up to \$7,717 over the course of a year for full-time workers.

For millions of Americans, the minimum wage is no longer a temporary entry-level wage, but a longtime wage that locks them and their families into poverty and undermines the consumer demand that drives our economy.

Raising the minimum wage makes good economic sense. Many business leaders want to see it increased.

As a successful CEO, I was not surprised to see a recent national poll released by the American Sustainable Business Council and Business for a Fair Minimum Wage. It found that 61 percent of small-business owners with Continued on Page 12

Obama's quick fix won't solve the regional refugee crisis

SAN FRANCISCO, (IPS) -In recent months, an unprecedented surge of refugee women and children has been traveling alone to the United States to seek protection at our southern border.

The vast majority are fleeing their homes in the Central American countries of Honduras, El Salvador and Guatemala, and risking their lives as they make long and incredibly dangerous journeys to seek refuge on our soil.

The Women's Refugee Commission has been closely monitoring this population since 2011. Through our research, we concluded over two years ago that without major changes in U.S. aid or foreign policy to the Central America region, the United States would continue to receive more vulnerable migrants due to the humanitarian crisis developing in the region.

Organised crime, forced gang recruitment, violence against women, and weak economic and social systems are all contributing to the pervasive insecurity in these countries.

The flow of refugees fleeing from Honduras, El Salvador and Guatemala has not only continued, but has increased dramatically and rapidly as violence in the region has escalated.

And refugees are not only coming to the United States. The United Nations has found that asylum requests in the the neighbouring countries of Mexico, Panama, Nicaragua, Costa Rica and Belize have skyrocketed by 712 percent since 2009.

While some children may be seeking to reunite with their parents or family in the United States, the motivating factor forcing them from their homes is violence and persecution. The Organised crime, forced gang recruitment, violence against women, and weak economic and social systems are all contributing to the pervasive insecurity in these countries.

children we spoke with told us they feared they would die if they stayed in their home country, and although they might die during the journey, at least they would have a chance.

Particularly concerning about the recent surge is that the children making the perilous migration journey are now younger than in years past. It has become common for children as young as four to 10 years old to be picked up and arrested by the U.S. Border Patrol.

Additionally, a higher percentage of the children are girls, many of whom arrive pregnant as a result of sexual violence. The United Nations High Commissioner for Refugees (UNHCR) recently conducted research with this population and found that 58 percent of the children interviewed raised international protection concerns.

Children also come to the United States with their parents. Since 2012, the number of families arriving at the southern border of the United States has increased significantly. The vast majority of these families are made up of women with very young children and are fleeing the same violence and insecurity driving the refugee children.

Our country has a long and dedicated commitment to human rights, due process and the assurance that individuals who arrive at our borders seeking safety are not turned away without addressing their claims.

Under international and domestic law, we have an obligation to properly screen and provide protection for unaccompanied minors, trafficking victims and asylum seekers who arrive at our borders.

In recent months, however, the government has been unprepared and overwhelmed by the numbers of children and families in need. Rather than addressing the issue in a manner that is in line with our American ideals and recognising it as a regional refugee situation, the Obama administration is looking for a quick fix and compromising our values and the lives of women and children in the process by responding as though it were an immigration issue.

We are deeply concerned by the government's recent announcement that it will drastically expand detention of families and will expedite the processing of asylum cases.

Harsh detention and deportation policies endanger the wellbeing of children and families, present a risk that individuals with legitimate claims to asylum and other forms of protection will be summarily returned to countries where their lives are seriously threatened, and do not work as a deterrent against future migration.

Additionally, the administration has proposed to roll back laws that are in place to protect children, in order to quickly and with no due process, deport kids back to the dangers they escaped.

This humanitarian refugee crisis is a complex human tragedy and needs both shortterm and long-term attention.

Still determined to force-feed us war

When FDR delivered his historic "day that will live in infamy" speech about the Japanese Pearl Harbor attack in 1941, there was no great cajoling effort needed to get the American public on board with the idea that the most muscular of responses was the only way to go. Likewise was the population galvanized into a resolve that whoever was responsible, 60 years later, for the 9/11 atrocities should have hell to pay, regardless of whatever it would demand of U.S. resources. The point being that whenever there's cause, unassailably, to roll out the heavy artillery in defense of what this country stands for, broad-based public support is never in doubt. It's altogether different when misfits in positions of power try to force-feed war to the people.

We're in the throes right now of some of the usual suspects trying to impress upon the masses that a state of war is where America needs to be. The unseemly brutishness we've seen from the ISIS crowd cannot but assault our senses to the point of wishing swift evisceration of those claiming to subscribe to the consummate evil that is evidently the ISIS way. Where the super-hawks part company with the rest of us in our measured anger is in their ready resort to committing thousands of young people to combat in the effort to eliminate ISIS. And hardly is it only the ISIS threat that gets these guys' bloodand-guts mojo going.

Senator Lindsey Graham, the South Carolina Republican who, with Arizona's John McCain, seems very protective of the "warhungry" label he wears, wondered earlier this year why was President Obama not mounting a military response to Russia's antagonizing maneuvers in Ukraine. Evidence, he said, of the president being "weak and indecisive." As for the ISIS problem, Graham believes the international-coalition approach that the president has opted for, with the U.S. emphasis on air strikes, is good for zip. If putting hefty numbers of American boots on the ground in the ISIS fight is the unspoken last resort of the Obama strategy, Graham predictably begs to differ. Put those thousands of men and women in harm's way now!

ample reason the president should be committing U.S. troops to fullblown combat in Iraq and Syria, seeing as how, in McCain's analysis, it was this administration's Iraq policy of scaling down troop levels that gave rise to ISIS. "We had it won," McCain asserts of the quagmire created in Iraq after the invasion.

For starters, as we've noted before, any claims McCain had of offering judgments worthy of serious consideration were shattered in 2008, when he declared himself proud to be heading a Republican presidential ticket on which Sarah Palin was running mate. The very idea that there could be any show of interest in what McCain has to say is of itself perplexing. But that being said, the McCain pronouncement about the Bush administration having "won" anything in Iraq, except a place in the record books as orchestrating one of the biggest foreign policy blunders ever, should be taken with the proverbial pinch of salt.

It's irritating when the likes of McCain and Graham insist on parroting this gung-ho, militaristic fix for any hint of a headache on the foreign policy front – a go-to solution that thankfully doesn't find resonance today with the great majority of the American people. One has difficulty understanding how McCain, Graham and others of hawkish bent continue to be tone-deaf about Americans being none too thrilled when talk surfaces of deploying troops someplace. Given the U.S. experience in armed conflict in the latter half of the 20th century and opening years of the 21st, why shouldn't Americans be wary of any move toward active combat situations unless satisfied that this was absolutely necessary?

In the 1950s America found itself in a communist-thwarting action in Korea that resulted in more than 36,000 U.S. deaths. As for Vietnam, the Memorial in Washington bears testimony to more than 58,000 U.S. deaths in that conflict, which was also all about stopping communist expansionism. The North Vietnamese marched into Saigon in 1975, anyway. And in the period of occupation of Iraq, starting in 2003, there were almost 4500 American deaths, in yet another war whose benefits elude all but the sickos who agitated for the ill-conceived madness in the first place. Why indeed wouldn't Americans think it's high time the war games fanatics be relegated to a place well removed from front and center?

The ISIS problem needs to be robustly confronted, no doubt about that. President Obama, in choosing to have a broad coalition join the U.S. to take aim on this particular incarnation of evil, is going for a sober, calibrated approach and correctly ignoring the mouths that roar who now clamor for the kind of hair-trigger response that has led to some of our celebrated past missteps. But Obama should by now be used to the cacophony of voices blowing hot air and stay the course. None of these rabble rousers, for sure, would have wagered that this president would have been the one calling the play that nabbed bin Laden.

employees favor raising the minimum wage to \$10.10 and then adjusting it annually to keep pace with the cost of living.

It requires a holistic approach that prioritises additional resources for addressing the root causes of this crisis, strengthening protection in the region, and reinforcing our protection and adjudication of claims, not blocking access to protection and sending women and children back to the dangerous situations they are fleeing without adequate due process.

The United States must not compromise its longstanding commitment to humanitarian principles in the hope of finding a quick solution.

In Jamaica, Rastas ready for pot decriminalization

KINGSTON, Jamaica (AP) - Taking a deep draw on a pipe that glows with burning marijuana, reggae luminary Bunny Wailer gives a satisfied grin through a haze of aromatic smoke in his concrete yard painted in the red, green, gold and black colors identified with his Rastafarian faith.

These days, the baritone singer from the legendary Wailers, the group he formed in 1963 with late superstars Bob Marley and Peter Tosh, has reason to feel good. There is unprecedented traction building in Jamaica to decriminalize pot, meaning the dreadlocked Wailer and other adherents of Rastafari - a homegrown spiritual movement that considers the drug divine - may soon be able to smoke without fear of arrest.

"Rastas have treated marijuana as something legal all along, even though we have been sent to prison for using the herb in our prayer. But this is the time for all these pressures to stop. The world is catching up now," the 67-year-old three-time Grammy winner said at his modest Kingston home.

Jamaica is known internationally for its marijuana. The hardy plant grows easily on the tropical Caribbean island, where its use is culturally entrenched despite being legally banned for 100 years. Cultivation is kept hidden, with small patches tucked into mountainsides, in swamps and between rows of other crops. Wailer, himself, was convicted of possession in 1967 and did more than a year of hard labor.

Previous moves to decriminalize the drug failed to advance mainly because officials feared they would violate international treaties and bring sanctions from Washington. But now, with a number of U.S. states relaxing their marijuana laws - Colorado and Washington even allow recreational use - Jamaica is rethinking its position.

Justice Minister Mark Golding says Jamaica's Cabinet has approved a plan to decriminalize marijuana, including for religious purposes, and legislators are expected to authorize it before the end of the year.

Freedom to use marijuana for religious worship is one of various amendments to Jamaica's Dangerous Drugs Act supported by Prime Minister Portia Simpson Miller's administration. Her ministers also have proposed unclogging courts by decriminalizing small amounts of weed for personal use, making possession of two ounces or less a ticketable offense. The main hope is that a regulated medical marijuana and scientific research sector could help draw investments to the cash-strapped island, which is laboring under its latest loan program with the International Monetary Fund.

"Ganja," as marijuana is known locally, has a long history on the island. It was introduced to Jamaica in the 19th century by Indian indentured servants and it gained popularity as a medicinal herb. Use spread among the poor in the 1930s with the founding of Rastafari, a spiritual movement that melds Old Testament teachings and Pan-Africanism and whose followers worship the late Ethiopian Emperor Haile Selassie.

Rasta adherents say use of the "holy herb" induces a meditative state that brings them closer to the divine. The faithful smoke it as a sacrament in chalice pipes or cigarettes called "spliffs," add it to vegetarian stews, and place it in fires as a burnt offering.

For years, Rastafarians were treated as second-class citizens and looked down upon by many Jamaicans as oddball, even dangerous drug-addled cultists. Police shooting ranges once had images of dreadlocked Rastas as targets. The spiritual movement attracts only a small percentage of the country's mostly Christian population of 2.7 million.

It wasn't until the 1970s, when the Wailers and other Rasta musicians popularized the Rastafarian culture among better-off Jamaicans, that marijuana's popularity began to filter through the island's rigid class structure and gain a wider acceptance. Marley's worldwide popularity has made him Jamaica's most famous and revered son.

recording both the highest percentage (13 percent) as well as actual growth (3762).

In addition, the figures recorded in the months of February, March, April and June, were the highest number of arrivals ever recorded in these respective months in the island's history.

The expansion of the sector is fueled by growth in particular markets, namely the U.S. and UK, the island's two largest markets, which increased by 14 percent and eight percent respectively, during the seven month period.

Growth was also experienced in the Canadian and European markets, both of which increased by double digit percentages over last year.

Trinidad

The Trinidad and Tobago government is spending TT\$633 million (US\$10million) to buy 52 armored vehicles -32 for the Defense Force and 20 for the Police Service to protect the troops from today's high-powered rifles, grenades and explosives in hostile and dangerous conditions.

This was disclosed by National Security Minister

Garry Griffith who said "we are taking our fight to the next level."

Griffith said the armored vehicles which are different from the armored personnel carriers, are bullet-proof vehicles which look like normal SUVs which will be used for specific elements of law enforcement agencies.

He said in changing times it is important that the law enforcement officials have the necessary tools to be protected when they go out there to protect the citizens.

Griffith noted that armored vehicles are used worldwide and the Ministry of National Security will supplement the Defense Force with these types of vehicles.

He said the vehicles would arrived in the country as soon as the acquisition is finalized

Jamaica

The Jamaica Defense Force (JDF) has confirmed the United States Coast Guard had pulled out of the search and rescue operation for the aircraft with two U.S. citizens that went down off the coast of the eastern parish of Portland recently.

The U.S. Coast Guard had been offering

support to the JDF since they sought to find the aircraft as well as bodies of the two American passengers. The reason for the pull out is not known.



The aircraft with billionaire real estate developer Larry Glazer, 68, and his wife, Jane were aboard the single-engine turbo aircraft that flew on its own for 1,700 miles before running out of fuel and slamming into the sea off Jamaica's north coast.





IMMIGRATION GUIDE REMOVING IMMIGRATION NIGHTMARES

There are solutions to problems immigrants frequently experience. Among the problems and solutions are the following:

1. GETTING MARRIED TO A US CITIZEN OR GREEN CARD HOLDER AND BEING ABUSED OR ABANDONED BY THE SPOUSE:

If you are married to a US Citizen or green card holder who is abusive or has abandoned you, you may be entitled to a work permit and green card even if you are divorced or have a criminal record. You do not need your spouse to fi le for you or sponsor you or attend the interview with you. church include: 90s hitmaker Shelly Thunder, Florida resident and rock-steady singer Dobby Dobson, singer Joan Myers, dancer Alphonso Castro, radio personalities Jeff Barnes and Lady Finesse, clergyman Bishop Cecil Riley, Consul General Herman G. Lamott and former consular Dr. Basil K. Bryan, Courtney Robb former bass player with Byron Lee & The Dragonaires, producer Lloyd "Franno" Francis, VP Records presidents Chris and Randy Chin, former politician Una Clarke, immigration specialist Irwine Clare and vet-

er Samuel Mitchell. It was Mitchell who allegedly steered a teenaged Lewis to record his first solo song.

Employed at Federal Records, Mitchell chaperoned the 16-year-old on his first recording session.

"It changed the tempo of Jamaican music to a slower pace," Mitchell said. That genre became rock steady a pivotal sound that was first recorded on Merritone Records.

The song "Take It easy" took the number one slot on the local charts there and for many years later the track held command at that position. Afterwards it was no stopping Lewis as he followed with four consecutive chart toppers - "Sound & Pressure," "Music Got Soul," and "Cool Cool Coolie."

He was the first to ever hold such distinction.

The Kingston-born Lewis had other hits including the 1970 national Festival Song, "Boom Shacka Laka," and "Grooving Out On Life."

But two decades ago, Lewis rejected secular music opting for inspirational songs.

At age 66, Lewis was a devoted Christian and a career promoter of gospel.


He championed the Caribbean Gospel Music Awards and owned Caribbean Gospel Jubilee (CGJ) an internet radio station.

He wholehearted embraced the teachings of the Bible and recorded a total of 24 albums, three compilation CDs, many of them devoted to gospel.

Lewis is survived by his wife Vera, children Karen and Hopeton Jr. along with grandchildren and scores of fans.

Reportedly a scholarship and memorial fund will be named in his honor. In addition, a lobby for the Jamaica government to bestow a national honor will petition global fans to sign.

His body was interred at St. Raymond's Cemetery in the Bronx.



Busting eye health myths: What's fact and what's fiction?

(StatePoint) Everyone has heard myths about what is and isn't good for your eye health -from eating more carrots to limiting screen time. Unfortunately, many so-called facts are anything but factual, according to Dr. Ryan Nakamura, a VSP Vision Care optometrist. Here, he sorts fact from fiction.

• Myth: Reading in dim lighting will damage my eyes.

• Busted: It may seem hard to believe, but there is no evidence that reading in dim light will cause long-term damage to your eyes. "Dim lighting can lead to eye strain, requiring your eyes to work harder and making them tire more quickly, but it's only temporary," says Dr. Nakamura. That said, if you have access to a well-lit room for reading, take advantage of it.

• Myth: The darker the lenses my sunglasses are, the better they will protect my eyes.

• Busted: Not exactly. "Dark sunglass lenses may reduce eye

discomfort for those who experience light sensitivity, but they do not provide additional protection from ultra-violet rays," says Nakamura.

More important than the darkness of your lenses is making sure the sunglasses have UVA and UVB protection — the only true defense against the sun's harmful rays. Over time, exposure to UV rays can lead to cataracts, macular degeneration and, in some cases, even blindness. So whether you prefer lighter or darker lenses in your frames, sunglasses are a must-have year-round. Don't forget to make sure the children in your life wear them too.

• Myth: Working many hours in front of a computer screen will change my glasses prescription.

• Busted: Working too long in front of the computer won't change your prescription, but there are some impacts to consider. The blue light emitted from electronic devices can be damaging — impacting your sleep and possibly causing macular degeneration, which is the leading cause of blindness in adults. Also, using electronics for extended periods of time can result in digital eye strain. Symptoms of digital eye strain include fatigue, headaches and neck pain.

To help protect against digital eye strain and blue light exposure, consider using eyeglass lenses with blue light protection. Also remember the 20-20-20 rule: for every 20 minutes spent looking at your computer, TV or digital device, spend 20 seconds looking at something at least 20 feet away.

• Myth: If you don't have obvious issues with your vision, you don't need an annual eye exam.

• Busted: A comprehensive annual eye exam can protect far more than just vision. It can detect signs of serious health

problems -- including diabetes, high blood pressure and high cholesterol -- many times before physical symptoms are present. Some serious eye conditions have no immediately obvious signs or symptoms, such as glaucoma or macular degeneration, and take a comprehensive eye exam to detect. Regardless of visible symptoms, a comprehensive eye exam is a must every year, Dr. Nakamura recommends.

A new home for the African Diaspora

If water and rain are a sign that the spirits are looking down kindly, then the spirits were very very happy-there was a deluge-on Tuesday, Sept. 16, at the formal groundbreaking for the Caribbean Cultural Center African Diaspora Institute (CCCADI). A former East Harlem firehouse built in 1889 is being transformed, becoming a major cultural hub for the community. Its 8,500 square feet will be a gallery, community performance spaces, and home to educational workshops

and programming. It takes a city and foresight to build a cultural center and the vision of two women is responsible for what will be a major contribution to the mecca of arts on Harlem's 125th St. and to the East Harlem community. By its locale, 120 E. 125th St., between Park and Lexington avenues, CCCADI will connect the African and African-American communities of Harlem with the Latino community, further east.

In 2008, City Council Speaker (then member) Melissa Mark-Viverito assured that five decommissioned firehouses would be taken off the auction block by the Bloomberg administration and turned into cultural facilities.

Marta Moreno Vega had founded CCCADI to connect the African Diaspora communities to their root communities. Its center had been for 25 years in a brownstone on West 58th St, which it sold last year. The tenure there saw exhibitions, public programs, research, and advocacy and arts education programs, all to be continued and expanded.

CCCADI was selected as the developer for the East

Harlem firehouse site.

The road to developing has been challenging with a plethora of city and state partners including the New York City Economic Development Corporation and the New York City Department of Cultural Affairs.

During the groundbreaking ceremony and moving closer to her dreams, an emotional Dr. Vega shared the continuity of the Center, "People who grew up coming to CCCADI are now on the board."

Acknowledging the public figures present she remarked, "We are so grateful for all the elected officials, government agencies, local non-profits and businesses that helped to bring this project to life." It was noted that the center will employ 130 full/part-time and contracted positions for artists, educators, administrative and managerial



Maritime panel to hold sessions on port congestion

ISLE OF PALMS, S.C. (AP) _ Maritime leaders were told Tuesday that a federal commission is planning a series of meetings on dealing with port congestion that has resulted from a rebounding economy and bigger ships calling at the nation's ports.

They also learned that completion of the expanded Panama Canal, originally anticipated this year, has been pushed back to 2016.

Maritime Commission Chairman Mario Cordero, Panama Canal Authority Administrator Jorge Quijano and Gov. Nikki Haley were among those who spoke before the South Carolina International Trade Conference.

Cordero told the gathering that the Federal Maritime Commission plans a series of meetings to discuss port congestion with the first of four regional meetings to be held in Los Angeles next week.

in the Southeast, perhaps in Charleston, and in New Orleans.

Cordero envisions the meetings will contribute to a study of ways to deal with congestion that includes the waits truckers have at ports before they pick up or unload shipping containers.

"Congestion is the topic of the day," he said. Such a study, he added, will allow

the commission to advocate in Congress for money to improve both port and other shipping infrastructure.

He said congestion is one of a number of issues facing the nation's ports along with others such as environmental concerns, consolidation among shipping lines and energy costs.

Jorge Quijano, the head

of the Panama Canal Authority, said the expansion of the canal to handle a new generation of larger container ships has been delayed because of problems with contractors.

"Progress has been significant but slower than we anticipated," he said, adding that construction of the new lock system is now about 75 percent complete.

He said he did not want to predict an exact date when the expanded canal will be open.

Quijano said the authority would probably have a drawing to see which shipping line will be the first to travel through the revamped canal.

Haley told those attending that South Carolina is aggressively trying to attract foreign companies to locate in the state.

"I lot of what I wanted was to see what we could do to bring companies back to America," she told reporters later. "We want good companies that understand that Made in America means something."





Housewife, kids abducted by killer in thriller

"No Good Deed" Very Good (3 stars) Rated PG-13 for violence and profanity Running time: 84 minutes Distributor: Screen Gems

It is usually a bad sign when a movie studio decides not to preview a picture for film critics. In the case of "No Good Deed," Screen Gems claimed that it was refraining from doing so in order to prevent the spoiling of a surprising plot twist. Well, the butler did it! (Just kidding.)

Skeptical, I had to wait until opening day to see it. And while the movie is by no means a masterpiece, I'm happy to report that it's nevertheless a tautly-wound nail-biter which keeps you on the edge of your seat from beginning to end. And yes, there is a humdinger of a revelation during the

denouement, not a totally preposterous development but rather a plausible one which was merely cleverly-concealed.

The movie marks the theatrical directorial debut of Sam Miller, who is best known for Luther, the brilliant BBC-TV series featuring Idris Elba in the title role for which he won a Golden Globe in 2012. The two collaborate again here, with Idris playing Colin Evans, a serial killer who, at the point of departure, slays a couple of prison guards during a daring escape from a Tennessee prison.

He makes his way to his girlfriend Alexis' (Kate del Castillo) house in Atlanta only to murder her, too, when he learns she's already involved with another man. Colin remains so blinded with rage as he drives away that he crashes his stolen car into a tree along a suburban country road.

He subsequently knocks on the door of Terri Granger (Taraji

P. Henson), an attorney-turnedstay at home mom whose husband (Henry Simmons) has conveniently just left town with his father away for a weekend golf getaway. Against the former prosecutor's better judgment, she lets the tall, dark and handsome stranger enter the house, and it isn't long before there's trouble in paradise.

After all as the proverb suggested by the title warns, "No good deed goes unpunished." Accordingly, Terri and her two young kids find themselves in the clutches of a desperate maniac until the protective mother's maternal and survival instincts kick into high gear.

No Good Deed was ostensibly inspired by "The Desperate Hours," a suspiciously-similar Broadway play starring Paul Newman which was first adapted to the big screen in 1955 starring Humphrey Bogart, and remade in 1990 with Sir Anthony Hopkins. Thanks to Mr. Elba's menacing intensity, a potentially mediocre variation on the theme ends up elevated into a tension-filled gutwrencher his loyal fans won't want to miss.

The urban-oriented audience at the screening I attended talked back at the screen a lot in the way that engaged black folks do, and they even applauded heartily as the closing credits rolled, surefire signs that the studio has a hit on its hands, conventional critics notwithstanding.



One of the standout friendships he nurtured there was with two female singers -Izora Armstead and Martha Wash. With his guidance, the two women became as indelible in the minds of music lovers as he had imprinted. Perhaps, better known in recording circles as Two Tons of Fun, they scored a winner with the hit song written by musician Paul Shaffer titled "It's Raining Men."

History reveals and Wayne's words echo that Sylvester, the meteoric performer, mentored the women to be recognized by a record label. Once signed, they needed umbrellas to ward off showers of success precipitated from Shaffer's composition.

Continued from Page 15 tend to disdain government initiatives, for many, Jamaica's decriminalization plans signal a crucial victory after decades of struggle.

The momentum building "presents a major step forward for the recognition of the religious rights and expression of Rastafari," said Anta Anthony Merritt, a Rastafarian priest who is a faculty member at San Diego State University.

Even if the current proposals fall short of the full legalization Rastas long have sought, they are welcomed by many, said Priest Dermot Fagan, leader of a small sect in an isolated commune in the Blue Mountains that tower over Kingston.

"We are thankful for the coming changes and, yes, some of the pressures will be eased. But we can't forget the destruction, the mayhem that has been caused by the persecution of this divine herb," said Fagan, waving his hands for emphasis on a balcony overlooking the School of Vision retreat, a place where Rasta mysticism brushes against the realities of modern life.

Researchers who study the movement are curious about how decriminalization for Rastafari will play out. For now, there are a lot of unanswered questions. Ennis Edmonds, an associate professor of religious studies at Ohio's Kenyon College whose publications focus on Rastafari, said determining what is religious use in Jamaica will not be easy. There's essentially no formal church, organized conversion process and few places of communal gathering. An individual Rasta's personal relationship with "Jah," or God, is considered central to the faith.

"Most ritual smoking does not take place in official places of worship, but in people's vards and on street corners. Can a single Rasta smoking a spliff in any location claim religious use privileges?" Edmonds asked.


But for Wailer, the time is clearly ripe for change in "Babylon," the unflattering Rasta term for the Western world.

"Rastas have gone through a lot of hassles for years, getting criminalized and locked up for using the herb. But things are changing because ganja is what the world needs now," Wailer said, before taking another appreciative toke from his pipe.

Southern tragedy changes race relations in the U.S.

"In Remembrance of Emmett Till" by Darryl Mace c.2014, University Press of Kentucky \$40.00 / \$50.00 Canada 214 pages

What can you say about tragedy?

When it's imminent, you brace yourself and hope to come out unscathed. In its aftermath, you mourn and, eventually, you move on, healed... but not quite ever the same.

Still, what, exactly, can you say about tragedy? Plenty, as you'll see in the book "In Remembrance of Emmett Till" by Darryl Mace, and the strongest words come from influential places.

Mamie Till-Mobley was born in Mississippi but, when **BOOK REVIEW**


she was just two years old, her family joined the Great Migration and settled in Chicago. They left a state where lynching was "an all-to-common experience for blacks" and segregation was a way of life. Things were different in Illinois; there was still racism, but it wouldn't likely kill anyone.

In this less-tumultuous place, Emmett Louis Till was born and raised and, due to his Chicago upbringing, "could not understand what it was like to be black in Mississippi." Still, as was the habit of many Midwestern African American families at that time, 14-year-old Emmett was sent to spend the summer with an uncle in the south.

It was a tragic mistake. In the days following Aug.

31, 1955, when Emmett Till's body was pulled from the Tallahatchie River, "print media outlets... sprang into action" to report "yet another senseless murder of a black male..." Publications – both mainstream and black leaped on the story in days to follow, reporting on "indifference" from Mississippi officials, lack of outrage from white Mississippians at the murder, and the ensuing trial at which the defendants were observed laughing.

Interestingly, Mace says that mainstream Midwestern newspapers covered the story differently than did papers in the West and Northeast. African American publications, particularly from the Midwest, also had understandably different angles. They were, he says, the ones to

keep the story alive long after the trial ended.

"At the time," Mace further adds, "whites in the Deep South could not see that with his death Emmett Till sowed the seeds of change that would sprout forth into the modern civil rights movement. Regardless of race, Americans... and these members of the Emmett Till generation would change the very nature of race relations in the United States."

I struggled some with "In Remembrance of Emmett Till."

Part of the problem is that this book is more academic than I expected; there were times when I was riveted by the information author Darryl Mace uncovered, while other pages made me want to just shelve it awhile.

There's a good sense of time and context here, though, and that helped. Mace gives readers ample opportunity to understand why Till's violent death wasn't just "another senseless murder;" why the U.S. was ripe for Civil Rights progress made in the decade after his slaying; and how the press, especially sixty years ago, served its public.

Scholars and historians may appreciate more from this book than most, but Mace's thoroughness will get you through if you casually want to tackle it anyhow. Try "In Remembrance of Emmett Till," and see what you have to say.




Historic Twenty 20 cricket deal


