### Immigration activist Jean Montrevil detained

With the piercing sounds of sirens and traffic, immigration activists, local politicians, and clergy braved bitter weather at the prayer vigil and rally protesting the detention of Jean Montrevil.

Montrevil was picked up during his lunch break van transport entrepreneur outside his home near Far Rockaway. He was on a deportation order.

# CALLS TO **PERMIT** WEED

### Free up marijuana use says Antigua's PM Gaston Browne

Just as the regional commission on marijuana is in the Bahamas for public consultations this week, an influential Caribbean head of government is calling on governments to take cognizance of the global push to allow for possession of small amounts for personal use rather than fill jail houses with innocent youths across the region.

Gaston Browne of Antigua, likely to call general elections within a matter of weeks, came out swinging this week, suggesting that the time has come for Caricom governments to legalize and decriminalize small amounts for personal

"We should continue to follow the developments in Canada, in particular, which will legalize the use of marijuana come July 2018, and I believe there will be scope for CARI-COM countries to follow Canada wholesale," he said, noting that the region does not have to copy wholesale the laws in North America but could "take the aspects of laws and regulations that could apply to us

here and help us to deal with what has been a very difficult issue."

Four years ago, regional leaders established a commission on the positives of decriminalizing marijuana for personal and medicinal use but they are yet to make a final or collective decision on the way forward.

In the interim, the multi agency commission that leaders had appointed to guide them on this issue is continuing to organize and hold public consultations in member states with the Bahamas being the latest. Similar forums were held in Guyana and Suriname late last year.

But countries such as Jamaica and Belize are certainly not waiting on any collective decision. Both have moved separately to decriminalize. Jamaica allows for up to two ounces without criminal charges while Belize allow for possession of not more than 10 grams.

Just this week, Guyanese Attorney General Basil Williams ruled out Guyana joining Jamaica and Belize in freeing up possession of small

## Boston Carnival killers jailed for life

Two men convicted in the shooting death of an innocent bystander at a 2014 Caribbean Carnival in Boston's Dorchester neighborhood have been sentenced to life in prison.

Keith Williams, 21, and Wesson Colas, 25, who were found guilty of first-degree murder on Dec. 28 in the death of Dawnn Jaffier, were sentenced Monday in Suffolk Superior Court, according to Necn news.

Prosecutors said Jaffier, 26, a city youth worker, was shot in the head in an August 2014 confrontation on Blue Hill Avenue in Dorchester.

Prosecutors said Williams fired the shot that killed Jaffier but was aiming for Colas, who they said drew his gun first.

At Monday's sentencing, members of Jaffier's family gave impact statements on her behalf, according to Necn.

Her brother, Ian Jaffier Jr., told the court the defendants changed his life forever when they killed his beloved sister.

He also thanked the court for serving justice and recognized the families whose cases aren't solved and who continue to live without closure.

"I hope that this verdict actually rings bells through the city. It was stated earlier, I feel like if one person is watching this story, if one person puts their gun down, that's really a win for the whole entire city," Ian Jaffier Jr. said.

According to Necn, Jaffier's father, Ian Jaffier, called Dawnn's shooting death senseless, adding that his daughter strived to be a positive influence on the community. He said he'll always mourn the milestones they will miss.

## Commuting while black

## New guidebook alerts black commuters about stations with anti-black policing

It's a handbook for commuting while black.

A social justice community organization recently released a book to help black New Yorkers navigate the city's subway system. The National Action Network's "Black Commuters' Guide: Brooklyn" is a comprehensive book that highlights the disparity in fare evasion arrests in Brooklyn, and the stations where they are most likely to happen. The creator behind it all says despite the multiple disciplinary options transit officers can consider before cuffing offenders, those options are not being enforced and it is "the reason I created the book is because the numbers of black people being arrested for fare evasion is unconscionable," said Brandon Hicks.

When police catch someone evading a fare they can issue them a warning, a citation, or arrest them. The latter is the stiffest penalty and the first option for black offenders, he added.

"Either this is implicit bias or they are deliberately preying on black people, because the numbers are not reasonable," said Hicks. "The harshest crime is arrest and that is always the case for black people."

The guide pinpoints stations at Atlantic, Livonia, and Sutter avenues along the L train line, and the Junius Street station on the 3 train line, as the central areas with the highest arrest rates. All are in East New York and Brownsville — two predominantly black and low-income neighborhoods, said Hicks.

The police department's Transit District 33, which accounts for booking the vast majority of the fare jumping offenders, and covers central and eastern Brooklyn and parts of Queens, also includes Bushwick and Bedford-Stuvvesant.

In 2016, out of all of fare evasion arrests, 90 percent of those were people of color and 60 percent of them were black, according to Hicks. And the overwhelming demographic group subject to being apprehended

are young black men between the ages of 16 and 36.

Hicks said that black commuters face an insurmountable challenge against this type of policing and feels even if the arrests are warranted, he strongly believes poverty but mostly anti-black policing plays a bigger role.

"I'm looking at the numbers, and if most people being arrested are black, then we need to stop and figure out the source of these disproportionate arrests," he said.

The guidebook is an homage to "The Negro Motorist Green Book," published during the Jim Crow era to alert black travelers on sundown towns, interstates, cities, and lodgings they could safely accommodate

during segregation. But also it will alert black riders of the issue and know where to keep a look out for arrest.

"We are hitting the pavements and already handing these out around these communities and organizations — Brooklyn needs to be aware of these places and where arrest rates are higher." he said.

The group has tried to meet with the captain of Transit District 33 but has been unsuccessful in setting anything up, said Hicks.

Hicks overall mission is to discuss the matter with the head cop of the district and determine a feasible solution that will decriminalize fare evasion, and help gradually decrease the number of arrests and reduce the crime itself.

## Funerals begin for Jamaican victims of Bronx fire

Funerals began Monday for many of the victims, including Jamaicans, who perished in a massive fire in the Bronx on Dec. 28.

Iholt Francis had been planning a trip from Jamaica to New York to visit his twin brother to celebrate their 28th birthday. Instead, he arrived last week to take his brother off life support, according to reports.

Francis's twin, Holt Francis, died a week after the Bronx fire ripped through his apartment building, killing four members of his Jamaican family and eight other people.

The fire was the deadliest in New York City in 27 years, the New York

Times said.

The paper said the fire was started

by a three-year-old boy who was playing with a stove, and was fueled by gusty winds.

Funeral services were expected to be held Monday, at the R.G. Ortiz Funeral Home in Manhattan, for Holt Francis; his wife, Karen Stewart-Francis, 37; their daughters, Kylie, 2, and Kelesha, 7; and their cousin, Shawntay

#### **Barbados**

A new governor of the Barbados Central Bank (BCB) took up office from Jan. 1, 2018.

Finance Minister Christopher Sinkler announced that Christopher Havnes has been appointed as governor of the Central Bank of Barbados effective

The new governor, who has acted in the position since Feb. 24 last year, has

more than 37 years experience in central banking, with emphasis on macroeconomic policy and bank regulations.



He was deputy governor from February 2009 until early last year.

He authored and co-authored several publications, principally on economic policy, debt and financial sector issues.

#### **Dominica**

The Dominica Business Forum (DBF) is calling for a public inquiry into the looting that followed the Sept. 18 devastation caused by Hurricane Maria.

DCF chairman, Severin Mc Kenzie, said the issue had been raised with Prime Minister Roosevelt Skerrit last month where the private sector group discussed "the building of confidence particularly as it relates to the looting that took place after Hurricane Maria."

McKenzie said questions have been asked about what mechanisms are being put in place to give local investors a certain level of confidence that they should re-invest in the Dominican economy.

Last month, Prime Minister Skerrit said a review would be held to

determine what went wrong with security on the island following the passage of the category 5 hurricane



that killed at least 29 people and left millions of dollars in damage.

McKenzie said the private sector, which employs in excess of 15,000 people wants to know what went wrong, not only with the police, but what went wrong generally in the aftermath of the hurricane.

#### Guyana

Oil and gas giant ExxonMobil is expected to start oil production in Guyana by March 2020.

This was disclosed by Exxon's Country Manager Rod Henson during a recent press conference in Guyana where contents of the Stabroek Petroleum Agreement between the oil company and the government were shared.

Guyana and ExxonMobil entered into an agreement in July 2016, which will see the South American country

on law-abiding citizens to continue to support the Trinidad and Tobago Police Service (TTPS) in their fight against crime.


With 18 murders recorded in the first week of 2018, Rowley said he is appealing to citizens to keep hope alive in this war against the heartless family members and career violent criminals

## Trinidad to have its first female president

Trinidad and Tobago will soon have its first female presi-

Come March this year, retired Court of Appeal judge Paula Mae Weekes will make history when she is inaugurated as the first woman to be elected president of Trinidad and Tobago.

Following a 35-minute meeting with Opposition Leader Kamla Persad-Bissessar, Minister in the Office of the Prime Minister Stuart Young announced that Weekes will be the government's nominee at the Diplomatic Centre, Port of Spain last Friday.

Young said Persad-Bissessar indicated the Opposition had no nominees at this stage, but she indicated she needed to caucus with Opposition members and would contact the government

He said the Constitution stipulates that 12 or more elected members of parliament must sign the nomination form a week before the Electoral College convenes.

The college is set to meet on Jan. 19.

Young explained that once a nominee is unopposed, that individual is automatically the President-elect.

He said Weekes had a stellar career as a jurist in TT, serving as a Justice of Appeal for 11 years before retiring in

Young also said Weekes has "a very great professional career" at the Office of the Director of Public Prosecutions (DPP), spent a short time in private practice and served as a judge in the 1990s before being elevated to the Court of Appeal.

Weekes, who was called

to the bar in 1982, was the fifth woman to be appointed a judge of the High Court of Trinidad and Tobago.

In August 2012, she acted as chief justice in the absence of Chief Justice Ivor Archie.

Weekes also served as an appeal court judge in the Turks and Caicos Islands.

Current President Anthony Carmona five-year tenure in office will come to an end on March 16 this year.

The government has the majority of MPs in the Electoral College to approve Weekes as the next president.

Their bodies will be sent to St. Catherine Parish in Jamaica for burial on Jan. 21. the Times said.

It said several other funerals will be held over the next few weeks. Services were held on Sunday for the youngest victim, seven-month-old Amora Batiz, and her grandmother, Maria Batiz, 65.

Ms. Stewart-Francis, a hotel housekeeper, belonged to a close-knit family from southeast Jamaica, the Times said.

It said some relatives had lived in the building, on Prospect Avenue in the Belmont neighborhood in the Bronx, for nearly a decade.

Her family occupied five apartments there, and relatives doubled as babysitters, cooks and hairdressers, the Times said.

Her sister, Andrene Paul, said the family was still raising money to cover the cost of transporting their bodies to Jamaica for burial.

Paul said it had always been her sister's wish to be buried there alongside their father, according to the

Ms. Stewart-Francis was the youngest of their parents' 13 children, and "she and our father were joined at the hip," Paul said.

Francis joined her in the United States in 2016, and the two married that May. They had lived in the apartment building for about a year, Paul said.

"We always try to stick together because kids are involved," said Paul, whose pregnant daughter lived on the third floor with her husband and 10-year-old son. "It works that way, like a community for each other."

Many of the fire's victims were working-class immigrants, and relatives have been frustrated in their efforts to plan funerals because they are unfamiliar with the process and have little money to cover expenses, the Times said.

It said six victims of the fire were from the Ashanti region in Ghana. They included a soldier and two children.



amounts, pointing to a United Nations study which argues against such he said. Williams said that he recently noted a push in the United States to "retrieve the position on marijuana in the United States," noting that Guyana is unlikely to follow nations which have modified their own stances on weed possession.

Browne argues that "jailing offenders has not worked and when you are doing something consistently and it does not work you fix it." Criminal action against users only drives them underground and make it difficult for authorities to monitor.

He appealed to police officers not to go after personal users and appeared to signal that the local law could be amended if he wants another term.

"I want to signal to the members of the police force, in the interim, that they desist from incriminating individuals because the government has made its policy very clear. Even though the law has not been changed, they must at least respect the intent and to give those who use marijuana a break," he stated.

Browne spoke on a recent radio program and many of those who called in were quick to dismiss his calls as a general election gimmick to win hearts and minds. They said they are also on the lookout for a reduction in gasoline prices and import taxes on electronic items, all to win votes

The commission is mandated to enquire about the social, economic, health and legal issues linked to marijuana use in the region of 15 nations and as well, to recommend whether there should be a reclassification of marijuana as a narcotic. If so, it will be more accessible to people who need it for religious, personal, recreational, medical and research uses officials said.

When he was in his early 20s, Montrevil served five years for selling

Eight years ago, he was in Pennsylvania scheduled for imminent deportation when the earthquake hit Haiti and deportations were temporarily halted. Since then he regularly checks in with ICE — U.S. Immigration and Customs Enforcement, works and is a family man.

Jean Montrevil found fellowship, moral support and became active with the Judson Memorial Church community. He co-founded The New Sanctuary Coalition. But, the stress of multiple deportation orders has also wrought an emotional toll.

Shortly after Jean was picked up, ICE took him to the Essex County Jail in Newark, New Jersey, where he remained for two days. On Friday, he was flown down to Krome Detention Center in Miami.

His son Jahsiah 14 has written about years attending protests and of living with the uncertainty of his father's presence. His testimony is circulating with an on-line petition to try to stop his father's deportation.

He writes: He had to go to annual check-ins with ICE. Before every check-in I always try to spend as much time as possible with him and

try not to think about the fact that it may be the last time I see him.

His worst fears may have been realized.

At the vigil, Judson Minister Michah Bucey spoke, "We're here because there is something much colder inside.'

His Sunday sermon also addressed the issues of Jean's detention.

During the rally, State Senator Brad Hoylman, whose district includes Judson, said, "Jean deserves a pathway towards citizenship, not persecution by ICE."

He added, "I'll continue to join my Greenwich Village neighbors and my colleagues in government in speaking up against these unjust policies, as well as advocating for legislation in Albany."

U.S. Rep. Jerrold Nadler (D-Manhattan) and State Assemblymember Deborah Glick (D-West Village) also

This latest detention follows the Trump administration's suspension of Temporary Protected Status special immigration program for 60,000 Haitians that followed the 2010 earthquake.

On Tuesday, Judson Chief Pastor Donna Schapner flew down to Florida. "We're waiting to see what happens with the Board of Immigration Appeals," she said.

## Stand in solidarity with immigrants

I found out that I was a different from my fellow immigrant classmates in high school, as I applied for college and scholarships. At the time I didn't understand why I had to pay the same tuition as someone who lived in another state. And I didn't understand why I couldn't meet any of the scholarship requirements.

Throughout my childhood my family and I used to visit the United States frequently. But things changed when I was about 10 years old. My mother, brother and I came for what would be the last time, never returning to Haiti. My family received kidnapping threats, so we fled the island. And because we didn't really understand the immigration process, we overstayed our

That means when it came time to prove that I was a legal resident that could receive help to pay for college, I didn't have adequate paperwork. So I didn't know if I would be able to go to college. When I found out about CUNY, my anxiety settled a bit because the school was more welcoming to immigrants. I was relieved to know that I had at least one option for my education.

My first year was very difficult. At the time there wasn't any funding or scholarships for undocumented students. We didn't have a lot of money,

so we had to take it semester by semester — scraping together enough money for courses and books. When the earthquake happened we were devastated. But it took such a tragedy, people losing their homes, to get some support for my family.

As I entered my sophomore year, we were able to file for Temporary Protected Status (TPS), paying over \$1000 in fees for each member of my family. This meant that my mom was able to find work as a home health aide. It meant that I was able to apply for a part-time job to help my mom pay for my tuition, food and transportation. I was also able



ished since the end of 2016, but unpalatable excuses abound each time we enquire about the constantly deferred completion date, making it a virtual "pie in the sky!"

### Stop Stealing From Car Wash Workers!

o worker should earn less than the minimum wage, ever. But in many low-wage industries, including car wash, where hundreds of workers are represented by the RWDSU, that's what has been happening for years. For too long, the so-called "tip Credit" has allowed operators to pay workers well below the minimum wage. In a time when low-wage workers rely on every cent to provide for themselves and their families, tip credit provides employers with an outrageous license to steal.

The tip credit is a part of New York State minimum wage law that allows industry operators to pay car wash workers a different, lower minimum wage. In theory, workers' tips are supposed to make up the difference, and possibly more. And, if workers' tips don't raise the level of pay to at least the minimum wage, car wash employers are supposed to make up the difference in additional hourly wages.

But tip credit does not work in the car wash environment. It's a vehicle for wage theft and contributes to systemic underpayment of car wash workers – exactly what the car wash unionizing campaign and car wash workers have been fighting against. Investigations have shown that employers don't always make up the extra pay for workers when tips are short, and car wash workers don't always receive the tips customers presume are going into their pockets. We shouldn't be giving unscrupulous employers additional opportunities to underpay their workers, and that's exactly what tip credit does in the car wash industry and many others. Tip credit has provided bad car wash operators with an abhorrent loophole that has left immigrant workers susceptible to wage theft. Car wash operators have been fined and directed to make restitution for wage theft to the tune of millions of dollars.

In many industries, Immigrant workers are particularly susceptible to tip credit-aided wage theft. Nail salon workers, deliverymen, car wash workers, restaurant workers; all are affected by wage theft, and all are affected by the tip credit loophole that makes it easier for employers to underpay them and even steal from them.

It's past time that the state of New York puts an end to tip credit and makes sure that no worker in the Empire State earns less than the minimum wage. New York Governor Andrew M. Cuomo has directed the Commissioner of Labor to schedule public hearings to evaluate the possibility of ending minimum wage tip credits in New York State. Ending tip credit would raise base pay for workers in a number of industries, and stop a loophole that has been responsible for countless instances of wage theft and contributed to holding entire communities back.

The Governor's announcement is an important next step in ensuring that 5,000 car wash workers in New York now have a chance to earn fair wages for their work, and that no worker in the Empire State is underpaid and impoverished.

to apply for fellowships; one enabled me to work in youth justice, the other covered part of my tuition and allowed me to create my own interdisciplinary major. I majored in cultural anthropology and international human rights because I wanted to work in my community and understand the inequalities we face as immigrants and people of color

But the resources were never enough to completely cover for my tuition. Each year, tuition was getting higher. As a TPS recipient I still had to pay everything out-of-pocket since I didn't qualify for financial aid. Becoming a TPS recipient is more like becoming an international student, but with less security since we don't know what happens when it ends.

I'm sharing my story because it's important to understand the diversity of the immigrant experience. We're students, some of us are young and have lived here most of our lives, others are older and support their family in this country and in Haiti. We want to live; we don't want to just survive. We want a path to citizenship. And we want to remind our neighbors and co-workers that our struggle is intertwined. I could


get deported tomorrow. But as a Black woman, I could also get shot by law enforcement tomorrow.

We need action from the government that provides a humane, holistic solution for Haitians and other TPS holders. Not only do we want the Department of Homeland Security to update the Federal Register and re-start the 60-day re-registration period for Haitians, we need Congress to provide a legislative fix for all TPS holders. Congress has the power to affirm our long-term presence in and contributions to the United States by enacting legislation that provides a pathway to permanent residency.

TPS made it so that we could live, work, study, and support our families. In the time that we've lived in the United States, we have become a part of the fabric of this nation as workers, homeowners, and most importantly community members. This is all our fight. We have to work together to push forward.



## **How Net Neutrality can** affect the Caribbean

The Caribbean needs to rally behind net neutrality.

An online petition [https:// www.change.org/p/u-s-senatecaribbean-americans-for-netneutrality] is hoping to garner support from the Caribbean community for net neutrality. Maryland-based advocate Taylor Jenkins, who runs the platform Humans of the Caribbean Diaspora, says if the restoration of net neutrality fails, it will have grave consequences on the ways money and access to information is received from and by region, he said.

"The general issue on what it means for the Caribbean comaffect the ways we use online, and all the remittances that are sent back that can potentially be at risk," said Jenkins.

The Federal Communications Commission (FCC) introduced net neutrality rules in 2015 to protect free Internet and prevent broadband companies from slowing down and

charging users and providers for additional services. Last month commissioners voted to repeal it in a 3-2 vote.

Online services that allow their users to make money transfers, such as Western Union or Paypal, will greatly affect how remittances are sent from people living in the states to their families back in the Caribbean, said Jenkins. He adds that since the region is a central location for these type of payments, it is going to be greatly affected if broadband companies are given full control on what type of speed service their users are


"It is extremely impactful munity, by and large, is it will because looking at previous data as far as 2015 that receive remittances, most are coming from the United States, Canada, and the United Kingdom, going to many countries in Latin America and the Caribbean regions," said Jenkins.

He adds the significance of the region as a huge recipient of money transfers alone should grab the attention of Caribbean people stateside, and even bring light to how local business may be shaped.

"It's insane how much money we give back home to families, he said. "And even people who are starting business — the way they'll keep the connection is going to be huge. Because how do you get payments from Paypal or Western Union if you're an international designer?"

As of last week the petition had over 12,000 signatures and counting, and Jenkins hopes that number can reach 15,000 by the end date of Jan. 19. Massachusetts Senator Ed Markey filed a Congressional Review Act vote, backed by over 26 other senators, to reinstate the Open Internet order, which would make the FCC maintain the existing rules.

Jenkins says that the Caribbean community needs to mobilize and show their support for the reinstatement of a free Internet, because it will have a big impact on the Diaspora globally.

## Caribbean pastor battles for his life in Harlem nursing home

By Nelson A. King

The Rev. Reginald Euclid Moore, a very vibrant Methodist Church Minister who served in the Chateaubelair-Kingstown Circuit in St. Vincent and the Grenadines in the 1970s, is now battling for his life in a Harlem nursing home.

The Nevisian-born Moore, 77, who received this theological training at the University of the West Indies at Mona, Jamaica and also worked as a minister in Guyana and Trinidad and Tobago before migrating to New York in 1980 — is now lying helpless at the Henry J. Carter Specialty Hospital and Nursing Facility, 1752 Park Ave., Harlem, after suffering a series of strokes.

Some former parishioners, and their families, who Rev. Moore mentored as youths in the town of Chateaubelair in the 1970s, made a special visit at his bedside on Dec. 30, despite the snowy conditions.

Hewitt James, a former school teacher and police officer in St. Vincent and the Gren-

adines, trekked from Philadelphia. Pa to see Rev. Moore for the very first time since the

Ralphie Cunningham and Ann Franklin, otherwise known as Yvonne "Dan Dan" Nash, as well as a reporter, drove from Brooklyn. Cunningham and the reporter brought along their

Cunningham and Franklin were not totally surprised to witness Rev. Moore's condition, since they had seen him on preview occasions; but James and the reporter were shocked about his medical fate, as he depends on others for ADL (Activities of Daily Living) needs.

The former pastor of Beulah Wesleyan Methodist and Mt. Calvary United Methodist Churches, and assistant pastor at Salem United Methodist Church — all in Harlem — is breathing with the aid of a tracheostomy and is being tube-fed.

"Believe you me, he's in good shape now, compared to the shape he was in [when he suffered his first stroke in 2016 and was taken to the Intensive Care Unit at Harlem Hospital]," said Franklin, who — like James, Cunningham and the report- was a member of Clubland, the youth arm of the Chateaubelair Methodist Church, which Rev. Moore guided in the early-to-mid-1970s, in a Caribbean Life interview.

"He can scratch his head now," added Franklin, who works as a nursing assistant at a nursing facility in Brooklyn and worships at the Miracle Temple Ministries, a Pentecostal church, attended primarily by Vincentians and Jamaicans, in the Brownsville section of Brooklyn. "He did not know anybody around him. Thank God, he's still here. We can still see him."

"His situation, to me, is unfortunate," chimed in Cunningham, who lived at the Moore's, for six months, in Harlem when he migrated to New York in 1996. "But I think he made a lot of progress from the last time I saw him [in 2016]."

Robin Moore, 40, Rev. Moore's second of three sons, the only

one born in St. Vincent and the Grenadines — the eldest, Lathen, was born in Guyana; and the youngest, Nigel, was born in Trinidad and Tobago said, when his dad suffered a "massive stroke" in 2016, "he couldn't move, couldn't breathe by himself.

"He was basically in a comatose state, and he came out in March, 2016," said Robin, who has followed his dad's footsteps in pursuing the ministry. Robin serves as assistant pastor at Beulah Wesleyan Methodist Church, where Rev. Moore served as pas-

tor, when he first arrived in the

"Currently, he's on a ventilator and trachea," added Robin, expressing contrition about his dad's medical state "because I would want him to witness more of my ministries and the seeds that he planted to give me a living.

"I'm happy that he's still living and that he still recognizes me," continued Robin, who, despite his very busy schedule, still visits his dad on an almost daily basis. "He keeps fighting: he never gives up.

# St. Kitts & Nevis PM, Cuban ambassador discuss cooperation

St. Kitts and Nevis' Prime Minister, Dr. Timothy Harris, and Cuban Ambassador to the Federation, Abelardo Fabio Hernández Ferrer, have reaffirmed the commitment of their respective governments to further strengthen the shared bilateral relations between both countries.

These commitments were given on Jan. 9 when Ferrer paid his first courtesy call on Prime Minister Harris since assuming the post as Cuban ambassador to St. Kitts and Nevis. Permanent Secretary in the Office of the Prime Minister, Osbert DeSuza also atteneded meeting.

During the discussions, Ambassador Ferrer expressed gratitude towards the of St. Kitts and Nevis government for the support it has given to Cuba as it relates to calling for an end to the United States economic embargo.

The Federation of St. Kitts and Nevis and the Republic of Cuba share a mutually beneficial partnership, with assistance being provided to the Federation in human resource development, through the provision of scholarships.

Prime Minister Harris stated, "Cuba has long been a strong and reliable voice in support of developing states, and St. Kitts and Nevis, like other

countries within CARICOM, we have benefited from that strong advocacy. The international agenda is rife with many issues in which we hope again to collaborate and cooperate with Cuba. Some of these issues are issues relating to climate change, climate mitigation and resilience measures. Other issues relate to the challenge of the blacklisting of states by the OECD and also the emerging issue of de-risking of banks within Caribbean islands."

Dr. Harris also highlighted the strong support St. Kitts and Nevis has received from the Cuban government towards the social development of the Kittitian and Nevisian people, particularly in the areas of health and education.

"We would want of course to see both of these areas strengthened, broadening the cooperation and the supply of specialist services to our country, and of course the training of our citizens in Cuba," the prime minister added.

From the period 2014 – 2017, a total of 27 Cuban scholarships were offered to nationals of St. Kitts and Nevis, of which 23 students pursued studies in medicine and two pursued studies in mechanical and electrical engineering.



## Barbadian writers need money

Women swept away the top prizes given out for exemplary prose when the Barbados Frank Collymore Literary Endowment awards a few days ago celebrated its 20th anniversary of formally recognising the work of outstanding writers.

With there being no first prize because the panel of judges found none of the entries worthy of 1hat award, Heather Barker picked up the 2nd prize with her collection of stories, highlighted by a piece titled, "The Plundering."

Sonia Williams won the 3rd prize, which is also based on a collection, but in this instance it was poems under the shared title, 'Her Bald Head Luminous.'

Shakirah Bourne copped the Prime Minister's Award, a special prize for the top writer among those who put Barbados in a new, unexpected or unusual light. Her story is 'Getting Back at Jack Taylor.'

At the weekend ceremony celebrating Barbados' premier literary artistes, the issue of the ability of writers to earn a living off the artform raised its head as a number of speakers pointed

to a need for greater financial input into production of story-book pieces and a meaningful contribution to the bottom line of writers.

"At this point in our development it is important that we move beyond the politeness of lip service to fully appreciating and supporting our writers," said outgoing Chairman of the FCLE panel of judges, Antonio 'Boo' Rudder.

"When we speak of support we're talking about purchasing the books which many writers have published at tremendous sacrifice and cost."

"Money always helps," quipped member of the panel of judges and the ceremony's MC, Andy Taitt, who made clear, that the appeal for a fund-base for creative writers is made, "without reducing art to simply money."

Prizes in the annual FCLE awards scheme begin with Bds\$10,000 (Bds\$1 = 50 cents US) for the first prize winner, and lesser sums for the other winners.

Over the years this money has been coming from the Central Bank that pays the first, second and third place prizes; and the Ministry of Culture that puts out the prize money for the Prime Minister's Award.

But it was noted that the while the personal one-time reward for the winning submissions is significant, there remains a need for support funding to take many of these Bajan masterpieces to publication, and distribution.

Central Bank Governor, Cleviston Haynes, spoke of a need "to bring prominence to Barbados' best writers while rewarding them tangibly.

"We need to find avenues to

make literature commercially viable for its exponents."

## Guyana mourns the loss of disco legend Neil Chan

Neil Chan, a larger than life figure who launched Solo Sounds International, and dominated the landscape of Arts and Entertainment in Guvana, commanding large costume and float parade bands at Mashramani in the 70s and 80s in Georgetown, died on Jan. 5. He was 88 years old.

Born on Nov. 4 and named Neil Vibert Ignatius Michael Chan by parents Soloman Chan and Rudy Beckles who lived in Georgetown, Chan, from a very young age created history, as a multifaceted person.

Cultural Director of the Guyana Cultural Association New York Claire Goring, a close friend and former member of the "Solo" team, recalled Chan's commitment to creating a good life for himself, while promoting his country.

He was a sports enthusiast, who excelled at bodybuilding and weight lifting and represented Guyana at the 1966 8th

British Empire Commonwealth Games in Jamaica.

Chan's business savvy led to his appointment as general manager of the External Trade Bureau (ETB), in 1970, which was responsible for the importation of most of Guyana's food and other commodities. He played a major role in trade at a time when foreign currency was in short supply and material for the development of the country were greatly needed.

He later started Bel Park Guyana Agency, and as a distributor of the Solo brand of agricultural equipment used by small farmers throughout

Chan won King of the Band Competition on many occasions, leading Solo Sounds Int. to prominence at the Festival Arts of Guyana for many years, as the leading private sector costume band, well-known for splendor and pageantry with 1000 strong "Mashparaders."

He participated in Mash Nite

and Mash Day Competitions, and presented Solo contestants, displaying saris created locally by Solo staff at Deepavali Pageants.

Chan received the Golden Arrowhead of Achievement award, Guyana's highest honor, for his dedicated and outstanding contribution to culture. He was also honored with the GCA of New York Award for his endowment to Guyana's Arts

and Culture.

He went on to launch Xanadu, a popular upscale discothegue the Place Where Dreams Come True - formally located at Vlissengen Road and Duncan Street in Georgetown.

This icon also played a significant role in developing costumed bands for tramping, after joining the steel band culture. He was a member of the musical group the Four Lords with Billy Moore, Neville Rose, Willie Wright, and Eve Manifold, who laid a foundation for his excellence as an exponent in Guyanese expression.

Chan's Solo Sounds Int. was the first to bring international talent to Guyana. Such performers included, Trinidad and Tobago's Shadow, David Rudder, Tambu, and the Charlie's Roots band. His band became the most influential during the 1970s and the early 1980s.

Neil Chan would be most remembered for his supremacy in bringing all Guyanese together

in the myriad of productions and collaborations he was instrumental in forming during his life-

He was an astute businessman, well-liked, popular and versatile person. The Guyanese community and the thousands of lives he touched will dearly miss him.

Neil and his devoted wife, Sheila, shared 58 years of marriage. They also shared adopted children, Fabian Gaskin and Sattie Sasenarine, Carlotta, Vilma and George Chan.

Others who mourn Chan, include; nephews Musa Amin and Neil Allicock, nieces Patricia Mercurius, Sandra Britton, Marcy Allicock and six others; great nieces and nephew: Michelle Britton, Tony Britton and Abbi Braithwaight and 16 others; 18 great, great, nieces and nephews; cousins the Chan family; cherished friends: Fay and Grant Gaskin and family, the Spooner family, Claire Goring, Alicia Dougall and family, Inez Seepaul, and many others.



## Judge to Trump: DACA must continue for now

Amid an intense political battle over a United States federal program that shields from deportation young Caribbean and other immigrants who were brought illegally to the U.S. as children, a federal judge in California has issued an injunction ordering the Trump administration to restart the program.

Stating that the decision to kill it was improper, Judge William Alsup of Federal District Court in San Francisco wrote on Tuesday that the Trump administration must "maintain the DACA program on a nationwide basis," as the legal challenge to the U.S. President Trump's decision proceed.

Former U.S. President Obama created the Deferred Action for Childhood Arrivals program, known as DACA, in 2012 to also give young immigrants the ability to work legally in the United States. President Donald Trump moved to end the program in September, saying that Obama's actions were unconstitutional and an overreach of executive power, according to the New York Times.

decision set off a fierce debate in Washington as Democrats and Republicans spar about how to provide relief for about 800,000 immigrants who could face deportation when the program ends on Mar. 5.

Trump met with lawmakers Tuesday afternoon in a remarkable, hour-long televised meeting to begin negotiations, the Times said.

But it said critics of Trump's decision to end the policy, including several states and organizations, had already sued the administration, saying that shutting down the program was arbitrary and done without following the proper legal procedures.

One of the lead plaintiffs in the case, Janet Napolitano, is currently president of the sprawling University of California system, but served as Secretary of Homeland Security for Obama in 2012 and was an architect of the DACA program, the Times said.

In his ruling, Judge Alsup questioned the administration's contention that the DACA program had not been put into place legally. He asserted that

The Times report said that the secretary of the Department of Homeland Security has long had the authority to grant the kind of temporary protections that formed the basis of the program.

> Judge Alsup also cited several of Trump's Twitter posts that expressed support for the program, according to the Times.

> He noted that, in September, the president wrote: "Does anybody really want to throw out good, educated and accomplished young people who have jobs, some serving in the military? Really!"

> Such tweets, Alsup said, bolstered the idea that keeping the program going was in the public interest.

> The judge wrote that previous beneficiaries of DACA, known as Dreamers, must be allowed to renew their status in the program, though the government will not be required to accept new applications from immigrants who had not previously submitted one.

> In addition, Alsup said the Trump administration could continue to prevent DACA recipients from returning to the U.S. if they leave the coun-



## Frederick Douglass' story too important to miss

You're not backing down.

There's a line in the sand and nobody's crossing it on your watch. When something isn't right and you can fix it, you're going to defend it, too, even if it costs you. As you'll see in "Facing Frederick " by Tonya Bolden, if you lived in the mid-1800s, you'd be in good company.

Though he really didn't like to talk about it much, Frederick Douglass had been through things that were unimaginable. From the moment he was born into slavery, he was taken from his mother, who died when Frederick was small. At age six, his owner removed him from his grandparents' farm to a planta-

"Facing Frederick: The Life of tion house; there, he slept on the floor of a closet. He was hired out to a slavemaster who beat him for no reason at all, and he worked as a shipbuilder before escaping from bondage.

> Douglass didn't like to talk about his life — but he had to. As a young man, he gained recognition as an orator and newspaper publisher, but people thought he was a "fake." He grew awfully sick of that and so he wrote a book, to great acclaim, though doing so was dangerous: Douglass used several aliases in his anti-slavery activism, and his book finally laid bare the whole truth. Finding safety in Great Britain, he became a celebrity there, and met some men who further influenced his life and his work.

> Following his time in Great Britain, he returned to America and started an anti-slavery newspaper with donations he had received while overseas. The paper faltered later because Douglass "miscalculated," but that setback didn't cause him to lose sight of

his goal; in fact, it strengthened his anti-slavery ideals. He and his family became conductors on the Underground Railroad, moving people up through New England into Canada.


"With the outbreak of the Civil War," savs Bolden, "Frederick 's hopes soared."

But he still wasn't happy: Black soldiers weren't allowed to do their part in the War, and Douglass wanted that changed. Finally, on Aug. 10, 1863, he went to the White House. The man who was once a little boy who slept on the floor of a closet had an appointment with President Lincoln....

Filled with excerpts from diaries, newspaper articles, bits of speeches, and reproductions of photographs, "Facing Frederick" is a great book with a powerful story.

Getting the full extent from of it, I think, will depend on the age of its reader.

Because it wouldn't be the same biography without dates and accounts of Douglass' trav-

els and actions, there's a lot in here and this book can be hard-to-follow. Older kids on a 10-to-14-year-old spectrum shouldn't have any problem with too many facts.

# Concentrated juice consumption and kids' health

oday's youth continue to battle obesity. The Centers for Disease Control and Prevention says the percentage of obese children in the United States has more than tripled since the 1970s. Roughly one in five school-aged children is obese. Obese children and adults are at a higher risk for chronic health conditions such as asthma, bone and joint problems, type 2 diabetes, and heart disease.

Although many factors can contribute to obesity among children, researchers with the American Academy of Pediatrics are now warning parents that fruit juice can be a contributor. In suggestions that overwrite previous recommendations from 2006 in which the Academy said children between the ages of 6 months and 6 years could have up to six ounces of fruit juice a day, fruit juice is no longer recommended for children under the age of 1. Plus, health experts say that older children should choose whole fruit sources in lieu of fruit juices whenever possible.

According to an article "Reducing Childhood Obesity by Eliminating 100 percent Fruit Juice," authored by Dr. Janet Wojcicki and Dr. Melvin Heyman, and published in the American Journal of Public Health, excessive fruit juice consumption is associated with increased risk for obesity. There also is recent scientific evidence that sucrose consumption without the corresponding fiber is associated with metabolic syndrome, liver injury, and obesity.

Obesity is not the only risk associated with fruit juice. Although fruit juice in moderation can be a nutritious beverage, drinking juice from a bottle can lead to nursing bottle dental caries. Also, "toddler's diarrhea" has been associated with juice consumption, particularly in juice with a high fructose to glucose ratio, according to data published in the Journal of the American College of Nutrition.





# Can beer boost brain power?

here is newfound reason to indulge in a pint or two of your favorite beer — and it's not just to catch up and share a few laughs with friends. New research has shown that a chemical compound in beer may be able to improve cognitive function. The beverage once thought to obliterate brain cells when consumed in abundance may actually have the opposite effect and boost brain power.

No one should run out an start imbibing just yet, however. The study that ran in Behavioral Brain Research in October 2014 was preliminary and only conducted on lab mice. During the study, scientists discovered that xanthohumol, a type of flavonoid found in beer, seemed to improve brain function in the young mice given xanthohumol doses. The cognitive flexibility of the mice was tested with a specially designed maze, and younger mice showed signs of intellectual improvement. Older mice showed no improvements. Researchers believe xanthohumol and other flavonoids, such as those found in red wine, blueberries, and dark chocolate, may play a role in helping a person form memories.

The mice were given very high doses of the flavonoid. A person would have to drink roughly 2,000 liters of beer a day to equal what the mice con-

sumed to show improvement. However, should a supplement hit the market down the road, it may just be possible for men and women to consume a potentially beneficial amount of xanthohumol without bellying up at the har

One of the goals of the xanthohumol study was to examine its potential efficacy at treating age-related deficits in memory. Xanthohumol also may benefit those with metabolic syndrome, a condition associated with obesity and high blood pressure, as it can speed metabolism and reduce fatty acids in the liver.

Flavonoids are plant compounds that often provide plants with their color. Scientists have attributed many health benefits to flavonoids in foods and plants and have even suggested flavonoids can help in the fight against cancer and heart disease. Xanthohumol is rare and is most often found in the hops commonly used to make beer

While doctors and researchers do not suggest running out and consuming a few six packs right now in the goal of improving brain function and cramming for that next test, xanthohumol may one day be harvested from beer hops to slow down age-related memory deficits.







On Jan. 9, 2014, a coal industry cleansing agent called MCHM started leaking from an above-ground storage tank into West Virginia's Elk River. The major chemical spill was covered up by Freedom Industries, the company that owned and operated the tank.

The 300,000 residents of Charleston were lucky that the substance emitted a noxious odor, otherwise they might never have known that their tap water was toxic. Still, some 700 folks called the local poison control center to report rashes and a variety of other symptoms.





NEW YORK (AP) — After a twoyear hiatus, C. Vivian Stringer has Rutgers back in The Associated Press women's basketball poll.

The Scarlet Knights jumped into the AP Top 25 on Monday at No. 21, riding an 11-game winning streak.

Rutgers was last ranked on March 2, 2015.

MIGHTY DUCKS: After sweeping Southern California and UCLA, Oregon

is the Ducks' highest ranking ever. The Ducks had been as high as ninth in 1982 and again this season.

"That's neat," coach Kelly Graves said. "We don't talk about it as a team, but it means we had a hell of a week-

Oregon swept the Los Angeles schools for the first time in school history. It is 15-2 on the season, with the losses coming against Louisville and Mississippi State.

"I wouldn't have guessed we'd be 15-2 against the 13th-toughest schedule in the country at this point with the youngest team in the Top 25. ... We're better right now than I thought we'd be. I got some gritty kids and they're tough mentally."

# Vincentian body-building legend passes

Vincentian Winston "Winty" Roberts, a pioneer and significant player in the bodybuilding scene, passed away on Dec. 21, in Whitby, Ontario, Canada, according to Toronto's Muscle Insider.

Roberts, 78, was one of the most influential people in bodybuilding history, "but you'd never know it from how humble and modest he was," the Insider said.

It said Roberts began his bodybuilding journey as a competitor, with accolades such as winning the "Mr. Canada" title twice and participating in Mr. Universe "pose-downs" in the IFBB amateur ranks. The International Federation of Body Building and Fitness (IFBB), headquartered in Madrid, is an international professional sports governing body for bodybuilding and fitness that oversees many of the sport's major international events, notably the World and Continental Championships.

But what we'll all remember is how this jolly-giant always had a kind word, a hug, and a smile for anyone at an OPA or IFBB show, no matter how busy he was," the Insider said.

It said, on migration to Canada, Roberts first moved in Montreal but ultimately ended up in Whitby, Ontario.

Until his death, he was president of Winston Roberts Incorporated, which organizes competitions at the local, provincial and professional levels.

Roberts was an IFBB judge at the pro level since 1985.

"There's really nothing he hasn't done in the decades he's been involved in the industry/ sport," the Insider said. "Back when bodybuilding was in its infancy, Winston was heavily involved as a pioneer, working alongside many of the goldenera greats.

"As an example, Ben Weider, the father of modern bodybuilding, delegated Winston the task of writing the constitution of the IFBB," it added. "Winston took that assignment one step further and also wrote the initial IFBB rulebook for judging, which is still used today.'


Roberts was elected general secretary of the IFBB in 1972 and used his IFBB credentials

(Ontario Physique Association) to begin the Canadian Federation of Bodybuilding (now known as the CBBF).

> The Insider said Roberts was also responsible for two "extremely significant moments" in bodybuilding history: "one which revolutionized bodybuilding competition was the suggestion to open prejudging to the public; the other Winston used bodybuilding to help end an era of oppression and segregation in South Africa by allowing the president of the country to host 1975 Mr. Olympia and World Championships (Mr. Universe) competitions only if the audience was denied its common practice of limiting seating sections according to race.

> "This proposal was accepted and was documented in the 1975 bodybuilding hit 'Pumping Iron,' which catapulted bodybuilding's status into the mainstream," the Insider said.

According to Carl Cheung, a National Level competitor and OPA judge: "There's nothing more heart dropping than receiving the sad news this morning, that the great legendary Mr. Winston Robert has passed away.
