DEAL TURNS SOUR

CARICOM-Canada trade talks collapse

Negotiations for a free trade agreement between Canada and the 15-nation Caribbean trade group appear to have collapsed with the Canadian government telling its regional counterparts in official correspondence that it has done everything to reach a deal with the group to no avail after six years so it is simply walking awav.

The agreement would have replaced the decades-old CaribCan arrangement that has

become incompatible with current World Trade Organization (WTO) rules at least for the time being.

The agreement had allowed Caribbean countries to export more than \$700M a year in goods largely duty free. Carib-Can had been in place since the mid 80s and allowed the region to enjoy a healthy trade surplus in recent years thanks largely to gold exports from Suriname and Guyana as well as petro-

Jamaica diasporans hijack PM's message

Jamaicans who attended a Manhattan gathering billed as a community forum with Prime Minister Portia Simpson-Miller were witnesses to a disrupted address from the leader by disgruntled diasporan residents intent on reversing the buggery laws now in place on the Caribbean island.

The mostly partisan group that waited more than an hour to hear the leader; cheered her entry into the east-side located St. George's Episcopalian Church and welcomed her to New York City despite forecasted rainy conditions and a raging inferno that wreaked havoc just blocks from the venue.

Many seemed shocked by the disruption.

Some watched helplessly as protesting diasporans launched a verbal assault on their island leader — to the ire of JA PM.

She was visibly riled as protesters to the country's buggery laws shouted down her optimistic message praising Diasporans for contribution to the island.

Initially, emphasizing braggadocio about Jamaicans being great and "little but tallawah," she infused the names of Marcus Garvey, Bob Marley and Nanny saying how great Jamaicans have been.

She said when President Barrack Obama visits Jamaica on April 9 "she is likely to raise the issue of a pardon for the nation's first national hero, Marcus Garvey." That statement drew loud applause and approval.

The leader also won cheers when

Honoring slavery's victims with The Ark of Return

March winds blew through the UN Visitors Plaza. Enduring bone-chilling conditions, dignitaries, VIPs and the public alike braved the blustery weather, shivering during the remarks.

On March 25, the long-awaited unveiling of the Ark of Return monument took place. The marble permanent memorial commemorating victims of the slave trade sits at the far end of the plaza; the East River is its backgron

The date of the ceremony coincided with date that is the International Day of Remembrance of the Victims of Slavery and The Transatlantic Slave Trade. Several worldwide activities remembering slavery are organized on that day.

The memorial at the UN aims to remind visitors of the complete history of slavery, urging them to acknowledge the tragedy and its legacy, and to heighten awareness of the current dangers of racism, prejudice and slavery's lingering consequences that continue to impact the descendants of slavery's victims today.

Some 15 million people were forced to make the crossing in slave ships during more than four centuries of the trade...."a stain on human history," said U.N. Secretary-General Ban Ki-Moon in his remarks during the ceremony. The memorial is also for the "huge numbers" who didn't survive the journey.

General Assembly President Sam Kutesa and a host of international dignitaries including Prime Minister of Jamaica Portia Simpson-Miller as

well as NYC's Mayor David Dinkins and Councilman Jumaane Williams helped inaugurate the memorial.

Courtenay Rattray, UN permanent representative of Jamaica and chair of the Permanent Memorial Committee hosted the ceremony.

Asoke Kumar Mukerji, UN permanent representative of India, which contributed \$250,000 and was the main donor to the Permanent Memorial Trust Fund for monument, paid tribute to human rights defenders who fought to abolish slavery and indentured labor.

Haitian-American architect and designer Rodney Leon designed the memorial. He won an international competition of 310 participants from 83 countries.

Highlighting some of the features of the monument, Leon notes the triangular marble panels, which were inspired by the maps of the triangular trade in slaves. Maps are etched into the walls so visitors are confronted by the uncomfortable truth.

"These three triangular patterns describe the slave routes from specific locations in West Africa and throughout Africa to South America, to the Caribbean and Central America, and to North America," he says.

Vincentian priests mourn 'caring' bishop

Two Vincentian Anglican priests who were beneficiaries of an American bishop's goodwill are mourning his passing, saying he was a "great servant of God" and a "caring" shepherd.

The Right Rev. Orris George Walker, Jr., the seventh diocesan bishop of the Episcopal (Anglican) Diocese of Long Island, NY was called to eternal rest on Feb. 28. He was 72.

Vincentian-born priests, Frs. Ulric Jones and Leopold Baynes were among hundreds of mourners who paid their last respect at the funeral service and interment, on Saturday, March 21, at the Cathedral of the Incarnation, Garden City, Long Is.

Fr. Jones, who worked under Bishop Walker's leadership, flew from St. Vincent and the Grenadines for the funeral service.

He told Caribbean Life that Bishop Walker was "a man with a most caring heart and a shepherding spirit," whom he first met on arrival in New York, in July, 1991. Fr. Jones and his family had migrated, at the time, from the Bahamas "to begin a new life."

"He embraced me and afforded me the opportunity to serve as a priest in the Diocese of Long Island, at historic Grace Church, Jamaica, Queens, and my subsequent election as rector of the Church of St. James the Less, Jamaica, Queens, from where I retired in 2007, after 13 years, and returned home," Fr. Jones said. "For this, I express my deep appreciation."

He said Bishop Walker had visited St. Vincent and the Grenadines on several occasions, proving to be "a friend of the

Diocese of the Windward Islands by his willingness to assist two of our churches (St. Paul's Calliaqua and Holy Name, Sandy Bay), which were undergoing much urgent repair.

"His kindness and generosity will be forever be remembered," said Fr. Jones, adding that Bishop Walker's dedication to the people of the Diocese of Long Island will "forever stand as a testament to his love for Jesus Christ and his dedication to the ministry of the church.

"To his sorrowing widow, Mrs. Norma Walker, his children and grandchildren, relatives and friends, I convey my profound and sincere condolences with the assurance of our prayers," Fr. Jones continued. "May he rest in peace, and rise in glory, and may his family and friends know that he is held in the palm

Caribbean

Britain has warned travelers to the Caribbean about contracting the Chikungunya virus, based on the dramatic increase in the number of people affected by the disease in the last year.

Public Health England (PHE) said according to its latest annual data, there has been a 12-fold increase from 24 cases in 2013 to 295 cases in 2014 in England, Wales and Northern Ireland.

The majority of cases, 88 percent, were acquired on trips to the Caribbean and South America. The outbreak, which start-



ed in December 2013 in the French Caribbean territory of St. Martin, has now affected most of the countries and territories in the Caribbean and Americas.

"Chikungunya is an unpleasant viral illness that can cause fever and joint pains, which, in some patients may persist for a prolonged period," said Dr. Hilary Kirkbride, head of the PHE's Travel and Migrant Health.

Antigua

The government of Antigua and Barbuda recently announced the formalization of diplomatic relations with the tiny republic of Fiji, stressing the similar challenges the two countries faces as Small Island Developing States.

Prime Minister Gaston Browne's government said in a statement that Antigua and Barbuda's permanent representative to the United Nations Wal-

ton Aubrey Webson, and Fijian counterpart Peter Thompson signed recently the Joint Communique



establishing diplomatic relations.

The statement said the two countries will support each other in the quest to diversify their economies which rely mainly on tourism.

The small Caribbean nation of about 90,000 inhabitants will also collaborate with Fiji in areas such as climate change, debt reduction and ocean conservation.



The Jamaica government announced recently that it will be one of the beneficiaries of a \$15 million grant from the government of Japan to help Caribbean islands improve their capacity to cope with climate change.

St. Kitts and Nevis has become the

second Caribbean Community (CARI-COM) country to impose a ban on the importation of poultry products from several U.S. states following reports of an outbreak of Bird Flu.

Like Jamaica, Antigua and Barbuda said the ban applies to poultry products from the U.S. states of Kansas, Arkansas, Missouri, Minnesota, California, Idaho, Oregon and Washington and British Columbia in Canada.

The list includes all poultry prod-

ucts, by-products and eggs and the authorities said the ban is intended to safeguard the poultry industry.



The ban is expected to remain in effect for three months and officials in St. Kitts said the restrictions are necessary to minimize the introduction of the Bird Flu virus into the twin-island federation, where more than 22 poultry farms would be at risk.

leum products from oil and gas-rich Trinidad.

The region had also exported millions in apparel, leather, ornaments and a range of other products including liquor under the old trading scheme.

But the one the two sides have been negotiating for the past six years would have been converted to a two-way arrangement had the negotiations been concluded and signed.

The bloc said this week that the Canadians have formally written to leaders indicating that they had applied to the WTO for CaribCan to be extended into the future to allow for a legal framework for trade between Ottawa and the region, meaning that the Canadians have given up hope of a two-way arrangement in the coming months.

Caricom said that trade ministers who are scheduled to meet at bloc headquarters in Guyana after the Easter holidays are expected to discuss the issue and make a final pronouncement on it. A preliminary reply to the Canadians has already been sent but whether this will be ignored until the WTO rules on the application for an extension is left to be seen officials said.

The region had consistently said that all of the smaller Eastern Caribbean states had indicated lukewarm support for the talks because they have little to export in two-way free trade and would

have been required to open their economies to goods from Canada and would have lost millions from taxes no longer being imposed on exports.

cation for the extension of the life of the old agreement, the region is expected to enjoy an even greater trade surplus with Canada because Toronto-based Guyana Goldfields is expected to open Guyana's first mega mine later this year and sell most of its production to Canadian refineries.

The last big mine was operated by Montreal-based Omai Gold Mines Ltd. which closed off mining 10 years ago after exporting more than three million ounces of gold from its western Guyana mine.

Gold from Gross Rosebel in Suriname is part of the reason why the region still sells more to Canada than Canada does to the Caribbean as its mine has been churning out hundreds of thousands of ounces per year.



Venezuela slashes Caribbean oil

Reports say Venezuela has cut in half its subsidized shipments of crude oil to Cuba and Petrocaribe member nations to 200,000 barrels per day, down from 400,000 shipped in 2012.

Referring to a Barclays investment bank report, the Miami Herald said on Sunday that the report considered it "ironic" that Venezuela would ship any oil at all, underscoring that while the country is going through extreme difficulties, it continues to subsidize oil sales to countries that have healthier economies.

Because of the cuts in oil shipments to the Caribbean, the firm reduced its deficit forecast for Venezuela to US\$22.6 billion, down from more than US\$30 billion predicted for 2015, according to the Herald.

"The oil agreements have been a heavy burden for Venezuela. These deliveries reached 400,000 bpd at their peak in 2012, though Venezuela only received payment for 200,000

bpd," said the Barclays report, citing figures from Petrologistics, the firm that follows tanker movements. "In the last decade, the agreements have cost Venezuela up to US\$50 billion."

Surprisingly, the Herald said Cuba, "the most important ally of Nicolás Maduro's regime, has not been exonerated from the cuts, which deepened after August 2014, when crude-oil prices began to drop."

"Cuba has received about 55,000 barrels per day since September, nearly half of what it received in 2012," the report said.

The Herald said the cuts in deliveries to Cuba are more important than those of the other countries benefiting from Venezuela's largesse, because, unlike member countries of the Petrocaribe program, which at least pay a portion of the deliveries, "Havana's regime does not make cash payments for the exchange."

Why should the government deliver mail?

In a country where people extol the virtues of free enterprise, why is the U.S. government involved in the delivery of mail? After all, it would be difficult to find a better example of a violation of the principles of free enterprise than the U.S. Postal Service.

The Postal Service is a monopoly. That means that the law expressly prohibits anyone in the private sector from competing against the government in the delivery of first-class mail. If some private firm attempts to do so, the Justice Department immediately secures an injunction from a federal judge enjoining the firm from continuing to compete. If the firm persists, the judge jails the head of the firm until he agrees to cease and desist with his competition.

Why should a country that prides itself on the virtues of free enterprise have a massive monopoly on mail delivery? Why not free enterprise in mail delivery?

One option would be to simply repeal the postal monopoly. That would put the Postal Service in the same position as everyone else — as a competitor among many private firms that would be seeking people's

But we all know what would happen. It is a virtual certainty that the Postal Service would be quickly run out of business.

There is no way that a governmental enterprise can effectively compete against private firms for customers' business.

That's in fact why the government has given the Postal Service a monopoly on its activities. Everyone within the Postal Service and the rest of the federal government knows that a monopoly is necessary to keep the Postal Service in existence, owing to its inability to maintain any market share against private firms in a free and competitive market.

The real question is: Why not simply abolish the Postal Service and leave the delivery of mail entirely to the free

After all, isn't that what U.S. officials advise foreign socialist regimes to do — to "privatize" their state-owned enterprises by selling them off?

Why not the same for the Postal Service?

In an era of UPS, FedEx, LaserShip, and other overnight-delivery services, does anyone really doubt that the private sector could handle the delivery of mail? Every day the private sector handles the delivery of untold quantities of groceries to countless grocery stores across the land. Is there anyone who really believes that the private sector couldn't handle mail delivery?

The Postal Service has long maintained that people in

Education as a cornerstone for women's empowerment

WASHINGTON, March 25, 2015 (IPS) - Earlier this month, the Barack Obama administration announced a new initiative designed to improve girls' education around the world. Dubbed "Let Girls Learn," the programme builds on current progress made, such as ensuring girls are enrolled in primary school at the same rates as boys, and is looking to expand opportunities for girls to complete their education.

The Obama administration's leadership on this issue is commendable and incredibly important for moving global momentum on girls' education forward.

Without transforming gender norms that hold too many girls back and holding schools accountable for ensuring girls stay in school and can return to school, girls - and indeed entire communities - will be deprived of future leaders.

We know that keeping girls in school and providing them with a quality education that can prepare them for their future continues to pay dividends down the line, including better health outcomes and better financial stability for girls themselves, and also for their families and communities.

Research shows that girls with secondary school education are six times less likely to marry early compared to girls who have very little or no education. Additionally, each extra year of a mother's education reduces the probability of infant

mortality by as much as 10 per cent and each extra year of secondary schooling can increase a girl's future earnings by 10 to 20 per cent.

But around the world, far too many girls face insurmountable barriers that often cause girls to drop out of school, ultimately preventing them from getting the quality education they deserve.

Recently, the International Center for Research on Women (ICRW) conducted research to assess the main causes of school drop out for girls in two districts of the West Nile sub-region of Uganda where only six girls for every ten boys are enrolled in secondary school, a ratio far below the national average.

A predominantly rural and impoverished region, West Nile, Uganda's recent past has been characterized by war and conflict.

As such, poverty plays a huge role in girls' inability to continue school. Of the girls who dropped out of school nearly 50 per cent listed financial reasons as the main reason they dropped out of school. Pregnancy was the second most common reason girls gave for leaving school.

While these factors are indeed eye-opening, our research found, however, that gender norms and beliefs about the roles of women as compared to men, were among the most significant determinants of school dropout for girls in West Nile.

Traditionally in West Nile, girls were taught to be subservient to the men to whom they 'belonged', first to their fathers and then later in life to their husbands. Despite significant social change that has taken place over the past number of decades, deeply-rooted gender norms and expectations are carried from one generation to the next and have a profound impact on girls' and their families' expectations and hopes for girls futures, and girls' determination and ability to finish – or drop out of -school.

For example, while most parents surveyed said they value girls' and boys' schooling equally, they acknowledge burdens at home, like chores and housework, fall on the girls in the family, rather than the boys. Consequently, girls who reported their domestic chores had interfered with their schooling in the past were three times more likely to drop out.

The domestic sphere remains solely a woman's domain in the West Nile, and in the face of high adult mortality due to poverty, war, and HIV, girls who lost a parent were even more likely to have to take on a

the mountains would be unable to get mail but for the Postal Service. Really? Somehow people in the mountain get milk, food, supplies, clothing, and other important things. Would the private sector really be unable to figure out ways to get mail to them?

What would a free market in mail delivery end up looking like? That's impossible to say, which is one of the beauties of the free market. Through the imagination of entrepreneurs, their eagerness to make money by expanding market share, and their coordination with others doing the same, the free market brings into existence things that no one could ever have imagined. That's what would happen in a free-market mail system — that is, one in which the government played no role

whatsnever

The beneficiary of all this? The consumer. Instead of having to go to the Post Office and stand in a long line, he now would have an array of entrepreneurs and new firms coming to him with new and better, low-cost ways of service.

The 20th century was the century of socialism and economic interventionism throughout the entire world. So far things aren't too different in the 21st century. The American people have the opportunity to lead the world out of this statist morass. A great place to start is by abolishing the Postal Service and adopting free enterprise in mail delivery.

high household chore burden. This set of burdens often includes caring for younger siblings, which likely contributes to girls in the study reporting only starting school on average at the age of 8.25 years, more than two years past the intended starting age of six.

For girls who become pregnant while in school, dropout is almost inevitable. Only 4 per cent of girls who reported they had ever been pregnant were still enrolled in school. Pregnancy is often followed by a forced marriage and the accompanying expectation that a girl's responsibilities should now shift from her education to caring for her child.

These data highlight just how many barriers girls face in continuing their education, with so many of those barriers finding deep roots in cultural norms that simply don't value girls the way they value boys. And while this study was conducted in the West Nile region of Uganda, gender norms that continue to hold girls back are certainly not rare around the world.

In order to succeed in letting girls learn, governments, schools, communities and families must dismantle barriers for girls where they exist. Local governments and communities must ensure girls get off to a good start with their education, by disseminating information about existing policies for the age at start of school, because we know that when girls are enrolled in school on time and progress through each grade on schedule, they're more likely to continue their education.

The education and health sectors must also work with local governments to introduce comprehensive sexuality education in schools to improve knowledge of and access to reproductive health services to help prevent pregnancy, which currently marks the end of a girl's education in Uganda.

Additionally, we know that eight of 10 girls who dropped out of school in West Nile, Uganda are eager to return to school if given the opportunity, but for the girls who dropped out due to pregnancy this is a near impossibility.

Re-entry and retention policies for pregnant girls and mothers who gave birth as children must be strengthened so that these girls do not miss out on the opportunity to break an intergenerational cycle of poverty, which is all the more likely for an adolescent single mother without a secondary education.

Education is, simply put, a cornerstone for women's empowerment and subsequently for local and national development.

Without transforming gender norms that hold too many girls back and holding schools accountable for ensuring girls stay in school and can return to school, girls – and indeed entire communities – will be deprived of future leaders that could be instrumental in helping to combat poverty in the community, which could empower more girls for generations to come.

laws; I do not act on emotion or public opinion so I do not wish to join the discussion," the DPP said.

Recently, Prime Minister Dr. Kenny Anthony, in a nationwide radio and television broadcast, said Jamaican investigators probing alleged extrajudicial killings by members of the Royal St. Lucia Police Force (RSLPF) had found a "blacklist or death list" existed.

Anthony also said the investigators had found police had staged "fake encounters" to legitimize their actions and "all police officers involved in the unlawful killings of citizens in respect of the files reviewed must be prosecuted."

But Anthony said his administration would not be making any statement regarding the guilt or innocence of the police officers involved and "the question whether anyone is to be prosecuted is solely for the director of Public Prosecutions to determine after evaluating and assessing the probative value of the evidence placed before her."

In 2013, the St. Lucia government enlisted the help of the Jamaican police to investigate the TSLPF, following a decision by the United States to withdraw security-related assistance after claims of human rights violations.

As a result, Police Commissioner Vernon Francois was prevented from traveling to the U.S. to represent the Regional Security Service at a conference of Black Police Chiefs.

The DPP told television viewers she would not join in the public debate on the matter.

St. Vincent

The Eastern Caribbean Supreme Court has called on the St. Vincent and the Grenadines government to pay former police commissioner Randolph Toussaint more than EC\$360,000 after ruling that the acquisition of his land some years ago was "unconstitutional, unlawful and null and void."

The Court also said the acquisition was "a contravention of the fundamental rights" of Toussaint to the enjoyment of property guaranteed by the St. Vincent and the Grenadines Constitution.

In its ruling, the court ordered that the attorney general pay Toussaint RC\$361,779.30 plus interest at the rate of six percent per annum from Decem-

ber 2002, the date of first publication of the declaration of the acquisition in the gazette, until full payment of compensation.



The case stemmed from the acquisition by the government in 2002 of 12,957 square feet of land owned by Toussaint in the southern Grenadine island of Canouan.

In November 2002, Toussaint attempted to sell the lands for EC\$268,820 and Prime Minister Dr. Ralph Gonsalves accused him of seeking to profit from the assets of the state. Toussaint had acquired the land in 1990 through

the Development Corporation when the New Democratic Party (NDP) formed the government.

During the budget debate on Dec. 5, 2002, Gonsalves told Parliament that the sale of the land to Toussaint was an "injustice" or a "scandal," which required the government and the Cabinet to correct it.

On that same day in an extraordinary issue of the Government Gazette notice was given that the lands belonging to Toussaint had to be acquired "for a public purpose...for the people of Can-

On March 3, 2013, the Land and Survevs said it had deposited EC\$9,717.80 at the Treasury Department in Toussaint's name being payment for the lands that he acquired in 1990.

Suriname

CARIBBEAN ROUNDUP

At least 25 political parties have signed up to contest the May 25 general election in Suriname, electoral officials

They said 15 of the parties have formed various coalitions, while the other 10 are contesting the polls as individual parties.

Chairman of the Central Voting Bureau Eugene Merkus, said that sign-

ing up the documents does not necessarily mean that the political parties will be automatically allowed to contest the election.



The Bureau will announce the final lost and parties will then have two more days to file a final appeal at the Office of the President of Suriname.

The National Democratic Party (NDP) President Desi Bouterse, who is seeking a second consecutive term in office, has the largest registered number of members, totaling 50,000.

Trinidad

Trinidad and Tobago was successfully elected to the Peace Building Commission of the United Nations, New York, USA, recently.

Trinidad and Tobago was among six new members elected to the 31-member commission for the period 2015 to

The Peace Building Commission was established in 2006 with the clear man-

date to propose integrated strategies for postconflict peace building and recovery and to design reconstruction



efforts and institutions that facilitate the sustained resolution of conflict.

T&T Foreign Affairs Minister Winston Dookeran in a news release explained that the role of the commission is critical in ensuring countries which have experienced conflict do not suffer reversals that could not only undermine efforts at peace-building, but also have a deleterious effect on the longterm sustainable development of the affected states.


Barbados to become a republic

Prime Minister Freundel Stuart says Barbados will be moving towards a republican form of government "in the very near future" ending its centuries of old relationship with Britain's Queen Elizabeth as its head of state.

"We cannot pat ourselves on the shoulder at having gone into independence; having decolonized out politics; we cannot pat ourselves on the shoulders at having decolonized our jurisprudence by delinking from the Judicial Committee of the Privy Council and explain to anybody why we continue to have a monarchial system."

Therefore, the Right Excellency Errol Barrow decolonized the politics: Owen Arthur decolonized the jurisprudence and Freundel Stuart is going to complete the process," Stuart told supporters of the ruling Democratic Labor Party last

While he gave no indication as to how soon the political move would be made, Prime Minister Stuart nonetheless indicated it would be done soon.

JOHN, Antigua, March 26, 2015 (IPS) - Richard Huber is chief of the Sustainable Communities, Hazard Risk, and Climate Change Section of the Department of Sustainable Development of the Organisation of American States (OAS). Its objective? Foster resilient, more sustainable cities - reducing, for example, consumption of water and energy - while simultaneously improving the quality of life and the participation of the community.

On a recent visit to Antigua, IPS correspondent Desmond Brown sat down with Huber to discuss renewable energy and energy efficiency. Excerpts from the interview follow.

Q: What is a sustainable country?

A: A sustainable country is a country that is significantly trying to limit its CO2 emissions. For example, Costa Rica is trying to become the first zero emissions country, and they are doing that by having a majority of their power from renewable sources, most notably hydroelectric but also wind and solar and biofuels.


So a sustainable country in the element of energy efficiency and renewable energy would be a country that is planting lots of trees to sequester carbon, looking after its coral reefs and its mangrove ecosystems, its critical ecosystems through a national parks and protected areas progamme and being very, very energy efficient with a view towards, let's say by 2020, being a country that has zero carbon emissions.

Q: How can small island states in the Caribbean be sustainable environmentally?

A: The first thing you would want to do is to have a very strong national parks and protected areas programme, as we are working on right now through the Northeast



Budget hearing for youth services

Brooklyn Council Member Dr. Mathieu Eugene, chair of the Committee on Youth Services, said his committee on Friday jointly hosted a preliminary budget hearing with the Committee on Community Development in the Council Chambers at City Hall in lower Manhattan.

Eugene, who represents the 40th Council District in Brooklyn, said the Department of Youth and Community Development (DYCD) testified at the hearing.

Youth service providers, advocates, community leaders, and members of the public also presented testimony.

Last year, as the new chair of the Youth Services Committee, Eugene said he, combined with the strong support of Council Speaker Melissa Mark-Viverito, was instrumental in expanding the number of Summer Youth Employment Program (SYEP) jobs from some 35,000 slots to nearly 47,000 positions, an increase of nearly 10,700 jobs.

Eugene said he also worked hard to increase funding for many other critically-needed youth programs and services that included Comprehensive After School System (COMPASS) programs and services for Homeless and Runaway Youth.

The council member said he is looking forward to continue working with others to increase and improve programs for youth in every part of New York City.

Obama to visit Jamaica

For the second time in Jamaica's history a sitting president of the United States will visit the island.

In 1982, President Ronald Reagan registered first in their history books as a Republican to make a stop to the island while in office.

On April. 9, President Barack Obama will make an entry for the Democrats and also imprint a new chapter in Jamaica's history as the first Black president of the United States and the one to arrive while the first female prime minister leads the country.

A front page headline on the Jamaica Observer newspaper boasted "Yes We Can! Host Obama." The March 20 issue will undoubtedly tally record sales and ultimately enter their archives as a collector's item. Another inside story described the president's visit as a "once in a lifetime opportunity."

During the brief meeting in Jamaica, President Obama and Prime Minister Portia Simpson Miller will hold bilateral discussions on a range of issues of mutual interest.

"The government of Jamaica is delighted that President Obama will be visiting Jamaica at this time. It will mark the second time since our independence that a sitting U.S. president will be visiting Jamaica," PM Simpson Miller said

"We view the president's upcoming visit as an affirmation of the strong ties of friendship and cooperation that have united our two peoples for centuries. We are confident that through fruitful dialogue and exchanges during the visit we will succeed in further strengthening the close relations that exist at the bilateral level between Jamaica and the USA, and between the USA and CARICOM."

The leader's announcement received

an immediate endorsement from former prime minister and opposition leader Andrew Holness.

Holness said he was extremely happy that a sitting U.S. president would be visiting Jamaica but also added his Jamaica Labor Party's view on the relaxed relationship between Cuba and the U.S. which PM Simpson Miller also mentioned in her statement to the Parliament.

"It is expected that the president will be proceeding from Jamaica to Panama for this hemispheric encounter which will welcome for the first time the participation of our closest neighbor the Republic of Cuba," Prime Minister Simpson Miller added. Holness's response was that: "The Opposition will play its role when President Obama visits Jamaica and would like to place on record our appreciation for the chill in relations between the United States and Cuba. We the Opposition have always stated that the economic embargo against Cuba should be lifted. We welcome President Obama to Jamaica."

President Obama will meet with regional leaders afterwards on April 10, 11 in Panama for the Summit of the Americas. It will be his second meeting with CARICOM leaders following his meeting in Port of Spain, Trinidad during the Summit of the Americas six years ago.

Tax revenues in the Caribbean remain stable

A new report says tax revenues in Latin America and the Caribbean (LAC) have remained stable in 2013 and continue to be considerably lower, as a proportion of national incomes, than in most Organization for Economic Cooperation and Development (OECD) countries.

"Revenue Statistics in Latin America and the Caribbean 1990-2013 (fourth edition)" shows that the average ratio of tax revenue to gross domestic product (GDP) in the 20 Latin American and Caribbean countries, covered by the report, was 21.3 percent in 2013, 0.1 percentage point above the ratio in 2012.

The tax-to-GDP ratio rose from 19.5 percent to 21.2 percent over the 2009-12 period, the report says.

The report, produced jointly by the Inter-American Centre of Tax Adminis-

trations (CIAT), the Economic Commission for Latin America and the Caribbean (ECLAC), the Inter-American Development Bank (IDB), the Organisation for Economic Cooperation and Development (OECD) and the OECD's Development Centre, was launched during the 27th Regional Seminar on Fiscal Policy, at ECLAC headquarters in Santiago, Chile.

It shows that tax revenues rose significantly across the region over the 1990-2013 period, pushing the average tax to GDP ratio up by 7 percentage points, from 14.4 percent to today's 21.3 percent level.


While this revenue boost has provided governments in the region increased capacity to improve spending on social programs and physical infrastructure, the tax to GDP ratio is still 13 percentage points below the OECD average of 34.1

percent, according to the report.

The report includes two special chapters. The first measures the usefulness of taking into account non-tax revenues from natural renewable and non-renewable resources, on top of all mandatory contributions to private health and pensions, in addition to tax revenues traditionally covered.

The second describes trends since 2000 in revenues from non-renewable natural resources in the Latin American and Caribbean countries, whose economies are driven by natural endowments, with aggregate projections up to 2014.

According to the report, the largest increases in tax to GDP ratios in 2013 were in Bolivia (2.1 percentage points), Argentina (1.7), Costa Rica (1.2) and El Salvador (0.7).

Bichotte votes yes on abortion

Newly-elected State Assembly Member Rodneyse Bichotte has voted in favor of a woman's right to choose, as the New York State Assembly last week passed stand-alone abortion expansion legislation (A.6221 - Glick/S.4432 - Stewart-Cousins) that would require the state to "not deny a woman's right to obtain abortion."

The bill would align State law with existing federal law in Roe v. Wade, 410 U.S. 113 (1973).

"Today, with the leadership of Speaker Carl Heastie and Assemblymember Deborah Glick, my colleagues and I stood proudly on the right side of history today as we voted

to protect women's right to choose," said Bichotte, who represents the 42nd Assembly District in Brooklyn, in affirming her vote.

"Women deserve to make our own decisions about our own bodies and our own health and this bill affirms that right," added the first Haitian American to be represented in the State's Legislature. "It's time for the State Senate to take action for women's equality and pass this bill."

The Bill amends Section 1,

Article 41 of the public health law to maintain that the state shall not deny a woman's right to obtain an abortion as established by the Supreme Court in the Roe v. Wade decision of 1973.

The legislation ensures a woman's right to choose abortion within 24 weeks of conception or when necessary to protect a woman's life or health.

A previous law failed to specifically guarantee a woman's right to abortion when her life was not at risk, Bichotte said.

No-confidence motion flops

An unprecedented no-confidence motion brought by the Trinidad and Tobago People's Partnership (PP) government against Opposition Leader Dr. Keith Rowley flopped as members of the opposition staged a dramatic walk out from the House of Representatives on Wednesday, March 25.

The motion was presented by Leader of Government Business Housing Minister Dr. Roodal Moonilal in the House to show that Rowley was not capable of being the country's next prime minister.

General elections are due in T&T later this month.

Dr. Moonilal kicked off the debate raising questions about his tenure in office as an MP of Parliament and a past minister of the People's National Movement (PNM) administration between 2005-2009.

Responding to the motion, Opposition PNM MP Colm Imbert deemed it to be a monumental waste of time, turned

the tables on the government by staging a dramatic walkout, refusing to participate.

Imbert said: "Mr. Speaker, this motion is frivolous and vexatious, has no basis, no purpose! It is empty, vacuous, and tenuous! It is absurd."


The debate turned into a character assassination of Dr. Rowlev when Minister Vernella Allevne-Toppin during her contribution said he was the product of a rape victim.

Management Marine Area as well as Cades Bay in the south, two very large parks which would encompass almost 40 percent of the marine environment.

In fact, there is a Caribbean Challenge Initiative throughout many Caribbean countries that began through the prime minister of Grenada where many, many Caribbean countries are committing to having 20 percent of their marine areas well managed from a protection and conservation point of view by the year 2020.

So protect your biodiversity. It's a very good defence against hurricanes and other storm surges that occur. Those countries that in fact looked after their mangrove ecosystems, their freshwater herbaceous swamps, their marshes in general, were countries that had much less impact from the tsunami in the South Pacific. So protect your ecosystems.

Second of all, be highly energy efficient. Try to encourage driving hybrid cars, fuel efficient cars and have a very good sustainable transport programme. Public transportation actually is a great poverty alleviation equaliser, helping the poor get to work in comfort and quickly. So be energy efficient, protect your biodiversity would be the two key things towards being a sustainable

Q: What examples of environmental sustainability have you observed during your visit to Antigua?

A: I've been travelling around with Ruth Spencer, who is the consultant who's working on having up to 10 solar power photovoltaic electricity programmes in community centres, in churches and other outreach facilities. We went to the Precision Project the other day which not only has 19 kilowatts of photovoltaic, which I think is more electricity than they need, and they are further adding back to the grid. So that is less than zero carbon because they are actually producing more electricity than they use.

There is [also] tremendous opportunity for Antigua to grow all its crops [using hydroponics]. The problem with, for example, the tourism industry is that they depend on supply being there when they need it so that is the kind of thing that hydroponics and some of these new technologies in more efficient agriculture and sustainable agriculture could give. The idea would be to make Antigua and Barbuda food sufficient by the year 2020.

Q: Could you give me examples of

OAS projects in the Caribbean on this topic?

A: This is the second phase of the sustainable communities in Central America and the Caribbean Project. So the first one we had 14 projects and this one we have 10 projects. So let me give you a couple of examples in the Caribbean. In Dominican Republic we are supporting hydroelectric power, mini hydro plants and also training and outreach on showing the people who live along river basins that they could have a mini hydro powering the community.

Another project which is very interesting is the Grenada project whereby 90 percent of the poultry in Grenada was imported. The reason it's imported is because the cost of feed is so expensive. So there was a project where the local sanitary landfill gave the project land and the person is going by the fish market and picking up all the fish waste which was thrown into the bay earlier but he is now picking that up and taking it to the sanitary landfill where he has a plant where he cooks the fish waste and other waste and turns it into poultry feed.

So now instead of being 90 percent of the poultry being imported it's now down to 70 percent and not only that, his energy source is used engine oil.

Q: What advice would you give to Caribbean countries on the subject of renewable energy and energy efficien-

A: The first thing that needs to happen is there needs to be an enabling environment created on order to introduce renewables, in this case mostly solar and wind. Right around this site here in Jabberwock Beach there are four historic windmills which are now in ruins, but the fact of the matter is there is a lot of wind that blew here traditionally and still blows and so these ridges along here and along the beach would be excellent sites for having wind

Also lots of land for example around the airport, a tremendous amount of sun and land which has high security where you could begin to have solar panels. We're beginning to have solar panel projects in the United States which are 150 megawatts which I think is more than all of Antigua and Barbuda

So these larger plants particularly in areas which have security already established, like around the airport you can introduce larger scale photovoltaic projects that would feed into the grid and over time you begin to phase out the diesel generation system that supplies 100 percent or almost 99 percent of Antigua and Barbuda's power today.



and difficult to train. The Shih Tzu will be alert to its surroundings and, despite its small stature, can be a good watch-

Pomeranian: Pomeranians look like big balls of fur and can bring a smile to an owner's face. The breed tends to be perky, can display dominance and can be difficult to train. Because Pomeranians can be dog-aggressive, they may be best as the only pet in the house.

Yorkshire terrier: The Yorkie is a diminutive breed in size only, as they tend to have exuberant personalities that dwarf their stature. The ideal lap dog, Yorkies want to lie around and lounge, though some do like to bark. If the fur is kept short in a "puppy cut," the dog can be easy to maintain.

Pembroke Welsh corgi: This medium-sized dog hails from Wales and typically requires only moderate exercise and little grooming. They are easy to train and moderately dominant. They don't bark excessively, and they often get along with other dogs.

Schnauzer: Available in three sizes, schnauzers are good companions and protectors. This is an intelligent and loyal breed and will need to be kept amused to stave off boredom.



How to reduce your risk of Alzheimer's disease

lzheimer's disease affects millions of people across the globe. In the United States alone, the Alzheimer's Association estimates one in eight older men and women has the disease, which is the sixth-leading cause of death in the country.

Few families have not been affected by Alzheimer's disease, and many relatives of those with the disease fully understand the role family history can play. Research into the disease is ongoing, and it's already yielded valuable information that may help reduce the prevalence of this devastating disease in the years to come.

One byproduct of researchers' efforts is the discovery that it may be possible to prevent or delay the symptoms of Alzheimer's disease through the implementation of a combination of healthy lifestyle choices. The following are a few healthy habits that may help men and women reduce their risk for Alzheimer's.

Exercise regularly. A



Recognizing the early warning signs of Alzheimer's can encourage people to begin treatments that can stave off some of the more debilitating symptoms of this disease.

study conducted by Scottish researchers and published in the journal Neurology in 2012 touted exercise as the most effective way for adults to protect their brains from Alzheimer's disease. Researchers examined roughly 700

whom were born in 1936, who were asked to report their levels of physical activity. Each participant then received an MRI at age 73. Those tests revealed that the participants who were more physically active showed less brain shrink-70-year-old participants, all of age and fewer white matter

lesions, both of which are indicators of Alzheimer's disease. In addition, the Alzheimer's Research & Prevention Foundation reports that physical exercise reduces a person's risk of developing Alzheimer's by 50 percent and can even slow further deterioration in those who have already begun to develop the cognitive problems associated with Alzheimer's. Researchers continue to study the relationship between physical activity and the development of Alzheimer's diseases, but the evidence is mounting that regular exercise, regardless of a person's age, is a great way to reduce risk for Alzheimer's.

Eat healthy. What you put into your body may also reduce your risk for Alzheimer's disease. The brain operates at its best when it is fueled with a healthy diet that includes fresh fruit and vegetables, healthy fats and lean protein. A heart-healthy diet is also brain-healthy, and researchers have found a potential link between heart disease

and Alzheimer's disease. Researcher Larry Sparks of the Sun Health Research Institute in Arizona and formerly of the Kentucky medical examiner's office studied brain tissues with a goal of finding early signs of Alzheimer's disease. He discovered that those who had the telltale plaques of Alzheimer's disease also had heart disease, suggesting heart disease may be a forerunner of brain diseases like Alzheimer's. The Alzheimer's Association feels this link between the two will only grow stronger in the years to come, suggesting that a hearthealthy diet that reduces a person's risk of heart disease may also reduce the risk for Alzheimer's down the road. The memorial's intent is to acknowledge the impact-the tragedy, consider the legacy, and not forget.

Why the name 'Ark of Return'? Leon elaborates: "The 'Door of No Return' in Gorée Island, Senegal is where slaves held in captivity on the African coast went through before being shipped away...never to return, a very tragic image. We felt it would be a good counterpoint to establish a spiritual space of return, an 'Ark of Return,' a vessel where we can begin to create a counter-narrative and undo some of that experience."

Leon also designed the African Burial Ground Memorial on Duane Street in lower Manhattan — dedicated in 2007, the only U.S. national monument devoted to the contributions of people of African descent. A current project includes the proposed design

of God's hand!

"His death leaves a hole in the hearts of many and certainly in the Diocese of Long Island," he said. "We are so very, very sad but give great thanks for having him as a Father-in-God, a friend and colleague."

Fr. Jones further said Bishop Walker was "a pioneer," who warmly welcomed Vincentian priests in his diocese.

"He really showed appreciation and gave us opportunity," Fr. Jones said. "I couldn't stay in St. Vincent [and the Grenadines]. I had to come to New York. He really opened his heart to me and members of our families.'

Fr. Jones disclosed that Bishop Walker had recommended his only daughter. Sharon, for the position of executive assistant to the then presiding Bishop of the Episcopal Church in the U.S., the Most Rev. Frank Griswold. Sharon is still serving in that capacity - now under the Most Rev. Kathrine Jefferts-Schori.

Fr. Baynes said he first met Bishop Walker in September 1995 when he migrated to New York to study counseling, among other things, at Blanton Peale Theological School.

There was no hesitation on his part to allow me to become the assistant at the Church of St. Mark (in the Crown Heights section of Brooklyn) to work with the Rev. Harold Lewis," he said. "He was very approachable, kind, and had that compassionate spirit to make one feel at ease in his presence.

"Bishop Walker always said that, because of the West Indians in the diocese of Long Island, the church was doing well and that he loved visiting those churches because of their strong faith in God and tasty curry goat and rice and peas," Fr. Baynes added.

He said Bishop Walker was also "kind to many churches in the Windward Islands offering financial support for much-needed repairs.

"Like anyone of us, he had his strengths and weakness, but as Dr. Lloyd Lewis said at the memorial service for him at Garden City 'Ordination is not a vaccination against our demons," said Fr. Baynes, adding that it was because of Bishop that he was appointed Rector of Grace Episcopal Church, Corona, Queens, on May 1, 1999, "for which my family and me will always be forever grateful."

Another Vincentian-born pastor, the Rev. Carver Israel, archdeacon of Brooklyn, was also high in praise for Bishop Walker.

"He was a good, genuine pastor, who loved people and cared for people," Fr. Israel, Caribbean Life, "He really cared for his clergy. He held no animosity. He had his short comings, like anybody else, but he was a very decent man."

Bishop Walker was born on Nov. 5, 1942 in Baltimore, MD. In 1984, he earned his Doctor of Ministry degree from Drew University in Madison, NJ.

In 1969, he was ordained to the priesthood. As Bishop of Long Island, he served as chairman of the board of managers of Episcopal Health Services and board chairman of the Interfaith Medical Center in the Bedford-Stuyvesant section of Brooklyn.

In addition, Bishop Walker served as president of Episcopal Charities of Long Island and the George Mercer Memorial School of Theology.

He taught Canon Law, and Theology and Contemporary Society at The Mercer School and at the General Theological Seminary.

Bishop Walker also served as president of the Cathedral Chapter of the Cathedral of the Incarnation in Garden

Anti-corruption onsite visits

The Organization of American States (OAS) says the governments of Jamaica and Suriname, as well as Canada, Costa Rica and the Dominican Republic, have consented to receive on-site visits as part of the Fifth Round of the Mechanism for Follow-up on the Implementation of the Inter-American Convention against Corruption (MESICIC).

The five countries notified the MESICIC Technical Secretariat of their decisions in accordance with the Methodology for Conducting On-site Visits, the OAS said.

It said the five countries also consented to and received on-site visits during the Fourth Round of Review.

For the Fifth Round, the MESICIC Committee of Experts will review the implementation of the provisions in Article III, paragraphs 3 and 12 of the Inter-American Convention against corruption, "which refer to the need-

ed instruction to government personnel and the study of preventive measures that take into account the relationship between equitable compensation and probity in public service," the OAS said.

Moreover, it said the committee will analyze the follow-up on the recommendations formulated to the States Parties in the Second Round, on topics such as public procurement, the hiring of public servants, whistleblower protection and the criminalization of acts of corruption under the convention.

The OAS said the "affirmative answers" from these five countries join those previously expressed by Antigua and Barbuda, Argentina, Belize, Bolivia, Brazil, Colombia, Chile, Ecuador, El Salvador, the United States, Guatemala, Guyana, Haiti, Honduras, México, Panamá, Paraguay, Peru, Trinidad and Tobago, and Uruguay.

Through workshops and panel discussions, a wide range of topical issues will present the 2015 forum NAN members



asked to be addressed.

Among them a discussion on "How Race is Covered in the Media," a panel focussing on law and social justice — "Approach the Bar: A Discussion with Some of the Nation's Top Legal Practitioners," "Criminal Justice - The State Of Our Prisons and Jails In New York State," "The Impact of Police Brutality: The Victims Speak," "Disability Rights – At the Intersections of Justice: Fighting for the Rights of All," "Environmental Justice - Killing Us Softly," "Environmental Threats To Our Future," and even an IT workshop titled "Technology Reaching Our Potential Through Technol-

Sports will get its own spotlight when insiders talk about "Racism & Sexism in Sports.

And the Black church will be the object of scrutiny on a panel "Can God Trust the Black Church to be Agents of Social Justice?'

"Truth to Power" a gospel revival with Rev. Marvin Sapp will probably mobilize many of the talking heads who participated in the previous-ly mentioned discussion.




'Dancehall Rising'



Shailene Woodley radiates chemistry aplenty

"Insurgent" Very Good (3 stars) Rated PG-13 for sensuality, pervasive violence, intense action, mature themes and brief profanity Running time: 119 minutes Distributor: Lions **Gate Films**

'Insurgent" is the second in the action-oriented series of screen adaptations based on Veronica Roth's blockbuster Divergent trilogy. This installment represents a rarity for a cinematic sequel in that it's actually better than the first episode.

In case you're unfamiliar with the franchise's basic premise, the post-apocalyptic sci-fi is set amidst the crumbling ruins of a walled-in Chicago where what's left of humanity has been strictly divided into five factions based

on personality types, namely, Abnegation (the selfless); Amity (the peaceful); Candor (the honest); Dauntless (the brave); and Erudite (the intelligent).

Our intrepid heroine, Tris (Shailene Woodley) was deemed a threat to society after testing positive for several of the aforementioned qualities since that makes her a Divergent, one of the handful of nonconformists whose minds the government cannot control. Consequently, the headstrong rebel ended up orphaned and roaming the streets with fellow faction-less rogues by the end of the original.

Insurgent picks up right where Divergent left off, though upping the ante in terms of intensity and visually-captivating special f/x. At the point of departure, we find Tris on the run with her boyfriend Four (Theo James), her brother Caleb (Ansel Elgort) and the duplicitous Peter Hayes (Miles Teller). The fugitives are being sought by Jeanine (Kate Winslet), the monomaniacal Erudite leader who has seized control of the city by commandeering the Dauntless warrior class.

The Machiavellian despot has declared martial law until all threats to her power have been neutralized. Meanwhile, Tris and company proceed to elude apprehension as they search for a sacred talisman supposedly hidden somewhere by her late mom (Ashley Judd).

The ancient artifact is rumored to contain an important message from Chicago's founding fathers. However, the box can only be accessed by a Divergent who succeeds at surviving an ordeal testing for all five of the commonwealth's designated virtues. Sure, it's obvious that Tris is bright, fearless and altruistic. But she could perish in the process of attempting to prove herself a pacifist and truthful, too.

Fans of the source material will undoubtedly be surprised by this complicated box challenge which wasn't in the book. Nevertheless, the seamlessly-interwoven plot device works in terms of ratcheting up the tension.

The film features an A-list supporting cast that includes Oscar-winners Kate Winslet and Octavia Spencer and nominee Naomi Watts, along with effective performances on the part of Theo James, Ansel Elgort, Zoe Kravitz and Miles Teller. Still, make no mistake. "Insurgent" is a Shailene Woodley vehicle from beginning to end.

And the rising young star exhibits an impressive acting range in a physically as well as emotionally-demanding role promising to do for her what "The Hunger Games" did for Jennifer Lawrence.



she humorously mentioned the might of immigrants, saying their tradition of sending "something back in suitcases, barrels and remittances" was a source of pride.

"We are proud of you," she said.

It was then that a voice shouted "Liar! Liar!"

Echoing the jeering accusation, more boisterous voices added to the disruption that interrupted her appraisal of diasporan residents.

The diplomat seemed to morph into a force of tyranny assailing her assailants who were determined to disrupt her keynote presentation.

She responded to their cat-calls with anger challenging repudiation of her record on gay rights.

The prime minister said she recognized the demonstrators because they had previously attempted to derail her visit to the United Nations one day earlier when she attended the unveiling of the "Ark of Return" monument honoring victims of slavery and the transatlantic slave trade.

Seemingly committed to a sense of purpose, the dissenters publicly rebuked the prime minister for neglecting to enforce her majority in Parliament to reform the 1864 colonial law which prohibits same-sex marriage and other public display of homosexual conduct.

In response, she said along with her government she had always respected the rights of all citizens including those who identify themselves to be lesbians and homosexuals.

A name-calling episode followed and seemed to send the leader into a tailspin which ultimately forced a halt to the community forum promised by an invitation to all Jamaicans extended from the island's consulate.

Some individuals fired back seemingly supportive comments of the PM although derogatory to the group — many of which seemed inappropriate to the religious house of worship.

Eventually, the dissenting group carrying a Jamaican flag was escorted from the church.

The abrupt end to the meeting sacrificed any hope for a question and answer segment or even a more detailed presentation from the leader.

The principal reason PM Simpson-Miller attended the forum was to endorse a launch of the sixth biennial Jamaica Diaspora Conference slated for Montego Bay.

Slated for June 13 to 18, the aim of the unifying event is to provide a forum for exchange of dialogue between Jamaicans residing throughout the world.

With a greater number of Jamaicans residing outside the island, the theme, "linking for growth and prosperity' seemed elusive to gay rights advocates who faced off with the leader.

Prior to the heckling rant, the PM discarded a prepared speech that explained the aim of the conference.

During an earlier launch on Feb. 20 Ann Ogilv in Kingston, she stated that the conference would address issues related to the event.

healthcare, education and implementation of a charter for long-term returning residents.

At that time she said: "we are refining the mechanisms to strengthen the relationship between the Jamaican Community overseas and the government communities and people (here) in Jamaica."

She also said then: "we are conducting a mapping survey of our nationals overseas in an effort to locate and tap this reservoir of skills for Jamaica's long term development."

"As we launch the Jamaica Diaspora 2015, I am pleased to learn that a feature of the conference this year will again be the Day of Service."

"On the designated day, members of the diaspora will carry out their projects all across the country, and not just in western Jamaica."

But what must have been an easy explanation in the capital city of Jamaica was a difficult task here.

As if taken from a latter-day soap opera aired on the national radio station titled "Portia faces life" a media observer dubbed the foreign visit "Portia faces strife."

Luckily for the visiting head of state — except for her own personal media entourage — there were no major press crews to capture the unfortunate interchange between nationals.

"I am very disappointed with the behavior of the prime minister," Duane Coombs said.

"Although I don't endorse the bad behavior displayed by the demonstrators inside a church, I would have hoped the PM would have used her elevated status to show better judgment and decorum."

"I hope her performance will not go viral and further harm the country's reputation."

Since then Jamaica Anti-Homophobia Stand (JAHS) issued a statement saying: "The silence of Prime Minister Simpson-Miller in the face of such horrific persecution of LGBT Jamaicans is inexcusable. I hope that the St. George's community speaks out against her complicity in these massive human rights violations."

Jason Latty-Travis, president of the Caribbean Alliance for Equality added: "The prime minister has too often escaped scrutiny for her record of failure around protecting all Jamaicans, including LGBT folks. Jamaicans need her to speak out against the atrocities and then implement a plan to address the crisis."

"We will continue to raise our voices in support of our LGBT brothers and sisters still in Jamaica," Dwayne Brown, founder of JAHS said. "It is the Christian thing to do and the right thing to do."

Prior to the showdown, presentations from Diasporan conference participants – Vivion Scully, Jampro; Harry Bhoorasingh, Jamaica National; Consular General Herman G. Lamont, Ambassador Sheryl Saunders, Director Diaspora Affairs Joan Pinnock; Minister of Foreign Affairs A.J. Nicholson and Lisa Ann Ogilvie, conference project manager presented an overview of plans for the event.



Bolt returns to NY

It would not be long now before professional track and field returns to the met area, and it will be just about when the high school and college season ends for the track buffs and athletes. Now we just need to have good weather, and not a rainy day.

All track and field competitors and spectators expect to iam once again for this year's edition of the New York Diamond League meet on June 13. This event will mark the initial appearance for a world class competitor since the end of May 2008 when Usain Bolt ran a 9.72 second time for the 100-meter dash. Incidentally, Bolt, a native of Jamaica, has not competed in the met area since that time.

After his performance of some seven years ago, he won six Olympic Gold Medals, eight world championship titles and just kept on winning and setting records in the process. He is an outstanding sprinter, and he, alone, should bring out the

Bolt holds the current 100meter world record with a 9.58 clocking and 200-meter world

He is certainly looking forward to compete here once again at Ichan Stadium.

'No one could forget their first world record, and I will never forget the crowd in New York that night," Bolt said. "They (the crowd) had to wait for an hour during a thunderstorm delay for our race and I don't think a single person left the stadium. They deserve a great performance and I'm glad I was able to give iit to them.'

However, officials and connections of the upcoming meet did not announce if Bolt will compete in the 100 or 200-meter runs at Ichan Stadium.

The 28-year old Bolt will start off the current outdoor season by competing in the 100-meter dash in Rio in mid April.

His highlight of the outdoor season is the World Championships in Athletics at the Beijing National Stadium, Beijing, China in August.


Meanwhile, the highlight invitational races in the tri-state area will be the Penn Relays. This is a meet that draws large crowds with something for eve-
